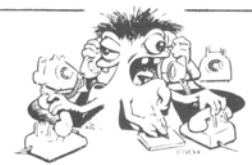

# SD&C Industry News



A new report by Business Communications Co. says manufacturers' sales of cosmetics and fragrances will reach \$3.1 billion by 1980 and \$4.7 billion by 1985. The study, "Cosmetics, Toiletries, Fragrances: Markets, Dynamics" says fragrances will continue as the sales leader, reaching \$1.7 billion by 1985, followed by men's toiletries at \$808 million. The report costs \$635 and is available from BCC in Stamford, CT.

Lever Bros. expects to have a \$30 million modernization and expansion program at its Hammond, IN, plant completed by 1981. The project includes a new soap plant that will double soap processing and packing capacity. Ground-breaking is scheduled for this month.

R.I.T.A. Chemical Corp. has opened a new plant in Chicago that more than triples previous productive capacity, the firm says. R.I.T.A. produces lanolin, lanolin derivatives, and biochemical ingredients for cosmetic, pharmaceutical, and industrial applications.

Olin Corp. has named Robert J. Martin as marketing manager, chemical specialties, for Olin's Chemicals Group. He previously had been sales specialist in that group.

Norda Inc. has announced three new staff assignments. Thomas H.F. Smith is corporate director of product integrity, responsible for product safety and related regulatory affairs. Saul Klabin is a new member of Norda's perfumery staff. William Note has been named manager of the

Odor Control Group of Norda.

Stepan Chemical Co. is marketing a terpolymer resin, Stepanhold R-1 for hair spray and wave set formulators, the company has announced. The product is completely alcohol soluble and provides a complete range of water solubility, the firm says. Stepan is located in Northfield, IL.

The FDA extended provisional listing of lead acetate as a color additive from Jan. 31, 1978, until Feb. 28 to permit time to evaluate comments for and against continued use of the substance. Originally, the FDA had proposed extending the provisional listing until April 30, 1979, to evaluate the likelihood of lead acetate being absorbed through the skin. A decision whether to adopt the April 30, 1979, date was expected by the end of February. ●

Fryma-Maschinen AG in Rheinfelden, Switzerland, has announced development of a new deaeration unit that permits immediate packing of shampoos, bubble baths, and bath oils, instead of delaying packaging time from 1½ to 5 days after production. Fryma says its Vacuum Deaeration unit VE-III produced good results with the products and even proved practical with shaving creams and cream body lotions.
