
Corporate Members

1979 Honored Student Awards

Nominations are now being solicited for the 1979 AOCS Honored Student Awards. Graduate students at any North American institution of higher learning, in any area of science dealing with fats and lipids, who are doing research toward an advanced degree, and who are interested in the areas of science and technology fostered by this Society, are eligible. To receive the award, he/she must remain a registered graduate student and must not have received his/her degree or begun career employment prior to the AOCS meeting he/she is to attend. Selection of awardees is based upon educational qualifications and performance.

The awards provide funds equal to travel costs, plus \$75.00, to permit attendance at the national meeting of the AOCS to be held in San Francisco on April 29 – May 3, 1979.
