SCC symposium to be Sept. 27

Monsanto Co. has published a 16-page technical bulletin describing its ethylene maleic anhydride resins for use in liquid detergents, household products, shampoos, and toiletries. The EMA resins are made by co-polymerization of ethylene and maleic anhydride. Copies of the bulletin are available from Monsanto Industrial Chemicals Co., Dept. 133, 800 N. Lindbergh Blvd; St. Louis, MO 63166. Shiseido Labs of Japan has won the Society of Cosmetic Chemists award for the best paper published in the society's journal during 1977. The \$2,000 award, sponsored by International Flavors and Fragrances Inc., was presented during a spring SCC meeting in Chicago. The paper, "Studies of Water-in-Oil Emulsions Stabilized with Amino Acids or Their Salts," was written by Y. Kumano, S. Nakamura, S. Tahara, and S. Ohta. Judges selecting the paper were Dr. Jerome, Dr. Jungermann, Mr. Silverman, and Mr. S. Sichak.

The Richardson Company's Organic Chemicals Division describes its new Richamide Liq as a "90% active, high lauric alkanolamide" that has been synthesized to remain liquid at room temperature, eliminating the need for glycols or other diluents. Richardson also says its new hair conditioning agent, Richquat 150, can be used in smaller amounts than competing substances. It is compatible with glycerol stearate, fatty alcohols, and sorbitan esters, the firm says.

PQ Corporation has three new bulletins describing properties and application of sodium silicate liquids, solids, and powders (Bulletin 17-102, 17-103, and 17-104). PQ's anhydrous and pentahydrate metasilicates for detergent formulations and cleaning compounds are described in Bulletin 17-102.
