

# 70th Annual Meeting

13 symposia topics for S.F. announced

Thirteen symposia subjects for the AOCS 1979 Annual Meeting in San Francisco have been announced by Dave McClung, program chairman, including seven that will be joint sessions with the Japan Oil Chemists' Society.

The seven joint symposia will be:

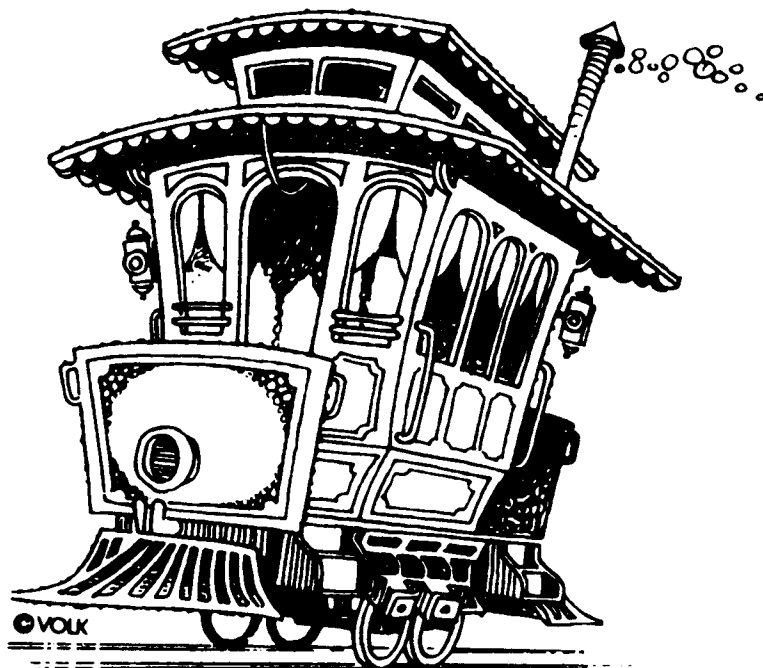
- Marine Lipids
- Detergents—Looking to the 1980s (Soaps, Detergents, and Cosmetics)
- High Performance Liquid Chromatography
- Processing of Fats and Oils
- Fatty Acids and Other Derivatives
- Analytical
- Diet, Nutrition, and Diseases in the 1980s.

Other confirmed symposia topics are:

- Environmental Regulations
- Energy Conservation
- Antioxidants and Peroxidation
- Lipid Protein Complexes
- Essential Fatty Acid Deficiency in Man
- Very Low Density Lipoprotein (VLDL) and Low Density Lipoproteins (LDL)

Other subjects being considered include: minor constituents in vegetable oils; oilseed protein; commodity markets; new sources of oil, toxicology problems in oils; new edible uses for oils, industrial uses for fats and oils; essentiality of linolenic acid; composition and processing of germ oils; catalysis; utilization of fats; and human milk lipids.
