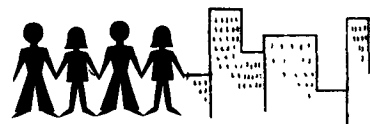

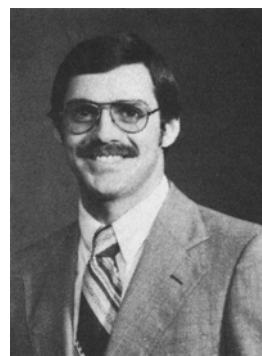

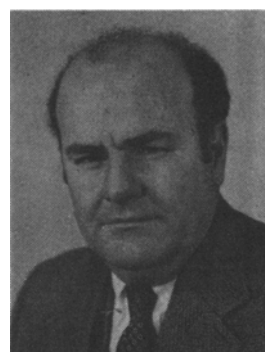

Numar de Hondurs has recently purchased its third Wurster & Sanger continuous deodorizing/deacidification system, including heat economization and fatty matter recovery . . . **Gardners of Gloucester Ltd.**, England, and **Tourell Gardners Ltd.** of Cornwall, have changed names to **Babcock Gardner Ltd.** to indicate the firm's tie to the **Babcock & Wilcox Limited** Group of Companies . . . September 1979 is expected start-up date for a new oilseed processing complex under construction by **Maple Leaf Monarch Company** at Windsor, Canada. The plant will have an annual capacity of 450,000 metric tons, capable of providing more than a third of eastern Canada's vegetable and meal production . . . **Cargill Inc.** has signed an agreement with the Indiana Port Commission to lease an \$18 million grain export elevator to be built by the commission near Portage, Indiana, if governmental approval is obtained. The elevator could handle more than 40 million bushels of grain annually when completed in 1980. ●
