# Fox wins Smalley, Doughtie cups

Ronnie M. Fox of Fox Testing Labs in Lubbock, Texas, won both the Smalley Cup and the R.T. Doughtie Cup in the AOCS Smalley Check Sample program this year. Ed Hahn, owner and manager of Hahn Laboratories in Columbia, South Carolina, is the only other person to finish first in both competitions in one year.

Persons who win either cup three times receive the cup for permanent possession. Fox retired one Doughtie Cup in 1975 while with Texas Testing Laboratories in Dallas and now has two victories toward receiving a second cup. He also now has two wins toward permanent possession of a Smalley Cup. Fox purchased the Texas Testing firm a few years ago, changed the name and moved his headquarters to Lubbock.

The Smalley Check Sample program provides standard samples of various fats and oils industry materials to analytical chemists. Each chemist analyzes the samples, then submits his results to the program committee. Winners and honorable mentions in each category receive certificates. A total of 329 analytical chemists participated in the program this year, with slightly more than 100 receiving certificates.

All independent analytical chemists seeking AOCS Official Referee Chemist status must participate and do well in the program to be approved. Others participate to maintain their proficiency at analytical methods used in the fats and oils industry.
