Neiditch receives ASTM award



AOCS member Oscar W. Neiditch, principal scientist for Lever Brothers Co., Edgewater, New Jersey, received a 1985 ASTM Award of Merit. Neiditch was cited for nearly 20 years of work with the ASTM Committee D-12 on Soaps and Other Detergents. The award includes an accompanying honorary title of Fellow of ASTM.

Neiditch has been either a principal author or major contributor for eight published ASTM standards. He joined Lever Brothers as a principal research chemist in 1949 and became principal scientist in 1969. Neiditch has been a member of AOCS since 1963.

Shell Chemical expands

Shell Chemical Co. in September announced plans to expand its higher olefins process unit at Geismar, Louisiana, from 590 to 650 million pounds per year. The work is set to be completed by April 1986. In August, Shell

restarted an idled 150 million pound per year linear higher olefins unit at Geismar.

News briefs

Raymond F. Attebery has been appointed director of quality performance for U.S.I. Chemicals and Emery Chemicals, both divisions of National Distillers and Chemical Corporation. Meanwhile, Paul Van Nortwick has been named project manager at Emery Chemicals, responsible for determining the markets for aroma chemicals and new branch chain acids. AOCS member Dave Bigner, formerly director of process technology, now is product manager of oleochemicals, the position previously held by Van Nortwick.

Akzo's Brazilian subsidiary is building a \$15 million fatty nitrile and amines plant at Itupeva, Brazil, with an expected yearly capacity of 7,500 metric tons of amines and 6,500 metric tons of nitrile. Startup of the facility is set for the end of 1985.

DETERGENTS EIGHT-0

Held September 14-17, 1980, Hotel Hershey & Country Club, Hershey, Pennsylvania (86 p., \$10).

Proceedings of four sessions: "What Constraints Do We Operate under?" "What Do We Have to Work with?" "How Do We Make a Technical Product?" and "How Do We Make a Successful Consumer Product?" These topics were addressed by 23 contributors to the course.

INDUSTRIAL FATTY ACIDS

Held June 10-13, 1979, Tamiment Resort and Country Club, Tamiment, Pennsylvania (150 p., \$12 for AOCS members and \$15 for nonmembers).

Thirty-eight papers constitute these proceedings. Topics include raw materials; hydrogenation; distillation; toxicological, bacteriocidal, and fungicidal properties; federal regulations; packaging; pollution control; analytical chemistry of fatty acids and their derivatives; and new applications.

DETERGENTS IN THE CHANGING SCENE

Held June 15-18, 1975, Hotel Hershey, Hershey, Pennsylvania (76 p., \$6 for AOCS members and \$8 for non-members).

The volume includes 15 of the papers presented at the course. Topics include surfactant manufacture, raw materials, alcohol ethoxylates in laundry detergents, environmental acceptability and human safety.
