



Obituaries

KAROL RUCKENSTEIN



Karol Ruckenstein, an AOCS member since 1975, died in Israel in late June. He was 67 years old. Mr. Ruckenstein was born in Vienna,

Austria, and received his technical training in Strasbourg, France, and Bucharest, Romania. He received the title of engineer in 1948. Ruckenstein served as chairman of the AOCS Committee for International Relations, and was a member of the organizing committee for the World Conference on Emerging Technologies held in Cannes, France, in 1985, as well as for a short course on oilseed processing held in Zurich, Switzerland, following that world conference.

Mr. Ruckenstein gained his fatsand-oils experience in nearly 30 countries in the past 40 years. Between 1948 and 1973, he worked in Romania where he was responsible for the modernization of a number of facilities and the building of new plants. In 1973, he joined the Etz-Hazayith Oil Factory as technical director, then moved on to be technical marketing manager of H.L.S. Ltd., an industrial engineering firm based in Israel. He also served as managing director for the firm. For seven months in 1985-86, he headed the food department of the USOP-Eisenberg Group in China.

Mr. Ruckenstein retired in 1986 to set up a consulting firm. He is survived by his wife.

Earle Fritz died July 25, 1988, after a lengthy illness. He was manager of process engineering for Union Camp Corp.'s Chemical Division in
