## Chung honored

AOCS member Okkyung (Okky) Kim Chung received the William F. Geddes Memorial Award at the American Association of Cereal Chemists' (AACC) 1988 annual meeting in San Diego, California. The award was given to recognize outstanding service, loyalty and devotion to the principles and objectives of AACC and its membership.

Chung is a supervisory research chemist and research leader of the Grain Quality and Structure Research Unit (Hard Winter Wheat Quality Lab) at the U.S. Department of Agriculture/Agricultural Research Service's Grain Marketing Research Laboratory in Manhattan, Kansas.

# **EEC** food research

The European Economic Community (EEC) plans to develop a food research program called Food Linked Agro Industry Research (FLAIR).

According to the *Leatherhead Food R.A. Bulletin*, the program's objective is for academic and industrial researchers to work together in three areas: assessment and enhancement of food quality; food hygiene, safety and toxicological aspects; and nutrition and wholesomeness aspects. "The work is expected to contribute to Europe's competitiveness in the food industry as well as helping the 'harmonious' development of the internal market," the *Bulletin* reported.

Meanwhile, the European Economic Community (EEC) Commission has suggested to the Council of Ministers that compulsory nutrient labeling be introduced, ac-

cording to an International Federation of Margarine Association newsletter. In a proposal to the council, the commission suggested that nutrition labeling be compulsory when nutrition claims are made on labels or in advertisements.

The proposed regulations cover not only foods delivered to the consumer, but also foods intended for restaurants, hospitals and canteens. When nutrition labeling is provided, energy values and the amounts of protein, carbohydrates, fat, dietary fiber and sodium would have to be included. Total fat declarations would have to include saturated, monounsaturated and polyunsaturated fat levels.

The council is expected to act on the proposal by September 1989.

## **Durkee purchased**

Unilever United States Inc. has signed an agreement to purchase the industrial foods and food service assets of Durkee Industrial Foods Corp., an affiliate of Hanson Industries Inc. The transaction was to be completed by the end of December. The total value of the sale was \$185 million.

Durkee Industrial Foods, headquartered in Cleveland, Ohio, manufactures specialty oils, frozen bakery products and confectionary coatings for the food service and processing industries. For the year ending Sept. 30, 1987, Durkee registered \$11.1 million in operating profits.

#### **Cottonseed course**

The Food Protein Research and Development Center at Texas A&M University will present a one-week practical short course in cottonseed oil milling Feb. 19-24, 1989.

The course is designed for oil mill supervisors and other persons interested in the details of cotton-seed processing. It will cover all aspects of processing, from cotton-seed storage through dehulling, flaking, extrusion, solvent extraction, meal desolventizing/toasting and oil degumming.

## Italian soaps

Henkel KGaA is negotiating the purchase of Panigal S.p.A., the Bologna-based detergent producer. The purchase price is expected to be \$152 million.

Henkel already has two subsidiaries in Italy. The addition of Panigal would give Henkel the second largest detergent market share in Italy, second only to Procter & Gamble (P&G).

Meanwhile, Procter & Gamble Italia S.p.A., P&G's Italian subsidiary, has purchased controlling interest in Nelson S.p.A., a liquid-

detergent company based in Gattatico, Italy.
