# **Bailey Award**

David R. Erickson, director of technical services for international marketing for the American Soybean Association (ASA), St. Louis, Missouri, has been selected to receive the 1989 Alton E. Bailey Award given by the North Central Section of AOCS.

The award will be presented at a dinner meeting to be held Thursday, Feb. 9, 1989, at the Chicago Marriott O'Hare, Chicago, Illinois.

Erickson, who is one of two candidates seeking the position of AOCS vice president for 1989-1990, was selected in recognition of his research and service in the field of fats and oils. The award is named for Alton E. Bailey, a prolific author and researcher who served as the first editor for the reference known as *Bailey's Industrial Oil and Fat Products*.

Erickson, a member of AOCS since 1964, was AOCS secretary during 1986-1988 and a member-atlarge on the AOCS Governing Board during 1984-1986. He is technical program chairman for the 1989 World Conference on Edible Oils and Fats Processing— Basic Principles and Modern Practices, to be held Oct. 1-6, 1989, in Maastricht, The Netherlands. He has been with ASA since 1977. He previously worked at Swift and Co. and Unitech Chemical Inc.

## **Certification deadlines**


Applications for either certification or recertification in the AOCS Approved Chemist and the AOCS Certified Laboratory programs must be received at AOCS headquarters, PO Box 3489, Champaign, IL 61821-0489, USA, by March 31, 1989, for applicants to be eligible for the 1989-90 official listings. Official listings and criteria for approval and certification are published in the AOCS methods book, Official Methods and Recommended Practices of the American Oil Chemists' Society.

applicants should write to AOCS Certification Programs at AOCS headquarters to request application forms and check lists.

The Approved Chemists Program was known as the Referee Chemist program until 1985. New applicants must complete a background questionnaire and laboratory checklist. New certification fees for Approved Chemists go in effect beginning in 1989. The new fees are the following:

• \$100 for first-time applicants.

• yearly renewal fees, based on categories - \$50 for one category, \$40 each for two to five categories, \$30 each for six to 10 categories, \$20 each for 11-15 categories, and \$10 each for 16 or more categories.

Categories for which a chemist may seek approval are the same as those outlined in the accompanying article on the Smalley Check Sample Program.

The Certified Laboratory Program, which covers persons wishing to do referee analysis of soybean meal, was begun in 1985. To qualify for certified status, laboratories must have an Approved Chemist on staff for oilseed, cake and meal. The chemist also must successfully complete a blind check-sample series for soybean meal. New applicants are required to complete a questionnaire and check list accompanying the application forms. The yearly fee for this program is \$1,000.

Application forms, with the completed questionnaire, must be returned to AOCS headquarters by March 31, 1989.



## **Graham retires**



A subscriber to a series receives a sample of uniform quality. Identical samples are distributed to other subscribers in the same series. Each participant analyzes the sample using the designated method. Depending on the series, standard methods currently used are either AOCS, AOAC, PORIM or CRA. After results are received by AOCS, a statistical analysis is made (mean and standard deviation) and each participant receives a report. The chemist can then check the precision of the laboratory's methods. Laboratories are identified by only a code number to maintain confidentiality.

Deadline for enrollment in the Smalley Check Sample Program is June 30, 1989.

Check sample series scheduled to be offered during 1989-1990 are oilseed meals, cottonseed, soybeans, peanuts, safflowerseed, rapeseed, sunflowerseed, cellulose yield (cotton linters), soybean oil, cottonseed oil, vegetable oil (color), edible fats, tallow and grease, NIOP fats and oils, gas chromatography (fatty acid profile), aflatoxin in cottonseed meal, aflatoxin in peanut meal, aflatoxin in corn meal, aflatoxin in milk, fish meal, fish solubles, fish oil, palm oil and corn gluten feed.
