### **Publication Rights:**

The American Oil Chemists' Society reserves first publication rights on all papers delivered at official AOCS meetings. A release from AOCS must be obtained by authors wishing to publish elsewhere. Submission of a paper to another publication before scheduled oral presentation can cause cancellation. Please promptly inform AOCS of other than routine publication plans.

### **Abstracts:**

Abstracts must be limited to the space provided on the reverse side. Abstracts should be typed and double-spaced.

### **Delivery Time:**

The delivery time for the standard paper is 20 minutes including discussion and question/answers.

### **Deadline:**

The deadline for abstracts for the Baltimore Annual Meeting is January 1, 1990. The program will be arranged immediately thereafter. Your abstract—the original and two copies—must arrive before the deadline.

### **Acceptance:**

The author will be contacted at the earliest possible date with regard to acceptance and scheduling of the paper.

### **Equipment and Facilities:**

Please advise the Program Chairman if you will require any equipment other than a 35mm slide projector. It will be available without request.

### **Poster Session:**

Space will be available for the exhibit of papers by poster and exhibits for authors who would like this opportunity for more personal interaction with interested parties. The display area is accessible and comfortable, but only flat posters and non-electrical displays will be permitted. You will have to provide all materials and equipment and be responsible for everything, including set up and take down. Thumbtacks and tape will be provided. If you are interested in this means of presentation, please check the box on the front of this form. Further information and instructions will be sent.

**A PAPER PROPOSAL OR FULL ABSTRACT must be submitted by all potential presenters by October 15. If your research has progressed sufficiently to submit a full Abstract, that is preferred. If your research has not progressed sufficiently to submit an abstract, a PAPER PROPOSAL alone may be submitted by October 15 to give the technical chairperson sufficient information for the tentative program. A FULL ABSTRACT is then due January 1, 1990.**
