# AOCS opens membership, raises dues

From now on, anyone with a professional interest in the science and technology of fats and oils and related substances can become a full member of the American Oil Chemists' Society.

During the 1989 AOCS annual meeting in Cincinnati, members approved changes in the AOCS Articles of Incorporation, eliminating differences between "active" and "associate" individual members, while retaining special membership categories for corporations, students, retired members, emeritus members and honorary members.

During AOCS Governing Board sessions, meanwhile, a "dues philosophy" was adopted that calls for yearly member dues to cover the direct costs of printing and mailing publications provided as a membership benefit and the general operational costs, excluding personnel costs and mortgage interest. Implementing that philosophy led to governing board approval of an annual dues increase to \$85 a year from the present \$50 a year, effective Jan. 1, 1990. Non-U.S. members pay an additional \$10 annually to cover non-U.S. postage costs.

B.F. Szuhaj of Central Soya Co. Inc. was named to complete the unexpired member-at-large term of Joe Endres who was elected AOCS treasurer this past spring. Szuhaj was one of the nine candidates for three at-large positions voted upon earlier this year.

The AOCS Governing Board also voted to separate the present JAOCS into two publications: JAOCS, which will contain peer-reviewed research articles, and I.N.F.O.R.M. (International News on Fats, Oils and Related Materials), which will be an expanded version of the present non-technical section of JAOCS. Members will receive I.N.F.O.R.M. as part of their dues package, but will pay an additional fee to subscribe to JAOCS or Lipids, or both. Member subscription fee will be \$30 for JAOCS and \$40 for Lipids. Those subscription rates are forecast to be about equal to the cost of printing and mailing each journal subscription during 1990. AOCS student members will be able to subscribe to AOCS technical journals at half the member subscription rate. Neither technical journal will be available for individual nonmember subscriptions.

The dues increase and new publications alignment were part of a response to operating deficits during the past two years. Whereas members' dues the past few years provided \$28 toward JAOCS, actual cost of printing and mailing the journal to each member has averaged about \$40. The print/mail cost does not include any pre-press expenses, including typesetting, proof distribution and corrections, preparation of final boards for printers, or reimbursement of volunteer editor expenses. The 1990 dues package

allocation will include \$35 for *I.N.F.O.R.M.*, \$5 for a membership directory, and \$45 toward administrative expenses.

In other action, the AOCS Governing Board:

- Voted to hold the 1994 annual meeting in St. Louis; the 1990 meeting will be in Baltimore, 1991 in Chicago, 1992 in Toronto (joint with International Society for Fat Research), and 1993 in Anaheim (joint with the Japan Oil Chemists' Society).
- Voted to increase participation fees in the Smalley Check sample program by 20% for the 1990-91 program year.
- Agreed to permit sale of surplus Smalley reference check samples at an initial price of \$25 per sample.
- Agreed to spend \$21,000 in 1989 to expedite publication of technical research papers in *JAOCS*, with a proviso that the money be repaid to the AOCS reserves by *JAOCS* during 1990.
- Agreed to add two full-time and one part-time positions to the AOCS staff: an editor/writer position

as of September to prepare for the start of *I.N.F.O.R.M.* in January 1990; a clerical person in the publications department; and a part-time clerical position in the technical department as statistical processing of the Smalley program is to be done by the headquarters staff.

- Agreed to meet the first week of September in Champaign and the second week of February at a Chicago-area location to be specified.
- Modified future Honored Student Awards to specify what costs are to be covered by the award.
- Adopted a set of scopes for AOCS committees based on original drafts by Robert Burton.
- Heard a report from David Domsch of the Lawrence-Leiter Company on a membership survey done earlier this year.
- Approved staff work toward organization of a world conference on oilseed and oil processing to be held in Hungary and an international conference on jojoba, both events to be held during 1992.
  - Accepted 186 new member applications.
- Set specific terms for members of the board of trustees for the AOCS Foundation, with E. Campbell and B. Szuhaj to serve until 1992, and E.G. Perkins and J. Heilman to serve until 1991. E. Lusas and T. Matson are incumbent trustees whose terms expire in 1990.
- Approved a budget committee recommendation to allocate \$50,000 for purchase of a new data services computer system for the headquarters office, noting required reprogramming of the older system would require approximately the same expenditure.
- Approved a list of committee appointments by new AOCS President Roy Carr.

And so the section was born.

"Al Ehrman thought that we should form a section and so he helped draw up bylaws and set up our Friday morning breakfast meeting," Bryan Madison said. Madison, who served as technical program chairperson for the annual meeting, added that as a result of that May 5 breakfast, the section may already have signed up 60 to 70 members.

Ehrman noted that the original local committee led by Ahmad Moustafa (annual meeting general chairperson) and Madison was mostly made up of members based at Procter & Gamble Co. "We jelled together but we were concerned that it was too much

P&G. So we encouraged others to join us, and we jelled even better. The general feeling was that it would be a shame to disband after the meeting, and so we talked about forming a section."

P&G and Henkel Corp./Emery Group helped sponsor the section's May 5 breakfast. "This indicates that the local companies are behind us. Now, we want to get other companies involved as well," Ehrman said. Those attending the breakfast were given pep talks by AOCS past president Karl Zilch of Henkel Corp./Emery Group, Cincinnati, and Edwin Lutton, retired, of Cincinnati, a member of AOCS since 1944. 

### **Book review**

Surfactants in Chemical/Process Engineering, Surfactant Science Series 28, edited by Darsh T. Wasan, Martin Ginn and Dinesh O. Shah (Marcel Dekker Inc., 270 Madison Ave., New York, NY 10016, 1988, 516 pp., \$99.75 US and Canada, \$119.50 elsewhere).

Surfactants play an important role—positive and negative—in industrial chemical processes and unit operations. As a subject in its own right, the topic has not received much concentrated and unified attention in the past. With this volume, editors have attempted to fill the gap in the literature. They have largely succeeded and have provided an excellent compilation of the role of surfactants in a number of important technical areas.

The book begins with a fundamental discussion by Edwards and Wasan of the dilatational properties of surfactants. The dilatational modulus has an important bearing on foam stability, emulsion stability and oil displacement in EOR operations.

When surfactants are present during distillation, they can either enhance or interfere with clean separations. This topic is reviewed by John Berg in the second chapter. In spite of much useful information now available, the author emphasizes the "unfinished business" nature of this subject in the hope, as the author says, of stimulating further research.

The chapter on surfactant-based treatments of aqueous process streams, authored by Scamehorn and Harwell, is a model of clarity. It deals instructively with some of the newer techniques, particularly micelleenhanced ultrafiltration, for the removal of trace quantities of undesirable components.

Along similar lines, the utility of liquid surfac-
