The sixth volume in this now well established series covers the literature from mid-January 1972 to mid-January 1973. It follows the pattern of Volume 5 about which W. G. Overend in *Chemistry in Britain* said, "the usual high standard of the series is maintained and Volume 5 is strongly recommended to all chemists interested in developments in the chemistry of carbohydrates. It is indispensable to those actively engaged in research on this class of natural products".

The volume is divided into two parts as follows:

Part I: Mono-, Di-, and Tri-saccharides and their Derivatives: Introduction; Free Sugars; Glycosides; Ethers and Anhydro-sugars; Acetals; Esters; Halogenated Sugars; Amino-sugars; Hydrazones, Osazones, and Related Compounds; Miscellaneous Nitrogen-containing Compounds; Thio-sugars;

Derivatives with Nitrogen or Sulphur in the Sugar Ring; Deoxy-sugars; Unsaturated Derivatives; Branched-chain Sugars; Aldehyde-sugars, Alduloses, Dialduloses, and Diuloses; Sugar Acids and Lactones; Inorganic Derivatives; Cyclitols; Antibiotics; Nucleosides; Oxidation and Reduction; N.M.R. Spectroscopy and Conformational Features of Carbohydrates; Other Physical Methods; Polarimetry; Separatory and Analytical Methods; Alditols.

Part II: Macromolecules: Introduction; General Methods; Plant and Algal Polysaccharides; Microbial Polysaccharides; Glycoproteins, Glycopeptides, and Animal Polysaccharides; Enzymes; Glycolipids and Gangliosides; Chemical Synthesis and Modification of Oligosaccharides, Polysaccharides, Glycoproteins, Enzymes, and Glycolipids.
