Information for Authors

Full details of how to submit material for publication in *Perkin Transactions 1* and *2* are given in Instructions for Authors (*J. Chem. Soc., Perkin Trans. 1* or *2*, 1985, Issue 1).

The subject matter of *Perkin Transactions 1* embraces all aspects of synthetic and natural product organic, organometallic and bio-organic chemistry, including aliphatic, alicyclic, and aromatic systems (carbocyclic and heterocyclic).

Perkin Transactions 2 deals with kinetic and mechanistic studies of organic, organometallic, and bio-organic reactions; the description and application of physicochemical, spectroscopic, and theoretical procedures to organic chemistry, including structure-activity relationships; and physical aspects of bio-organic chemistry and of organic compounds, including polymers and biopolymers.

All contributions are judged on the criteria of (i) originality and quality of scientific content and (ii) appropriateness of the length to the content of new science. Short papers are acceptable provided that they constitute full reports of completed pieces of work and are not fragments of more extensive studies.

Manuscripts (three copies typed in double spacing) should be addressed to:

Particular attention should be paid to the use of standard methods of literature citation, including the journal abbreviations defined in Chemical Abstracts Service Source Index. Wherever possible, the nomenclature employed should follow IUPAC recommendations, and units and symbols should be those associated with SI.

All queries relating to the presentation and submission of papers, and any correspondence regarding accepted papers and proofs, should be directed to the Editor, *Perkin Transactions 1* or *2* (address as above). Members of the Perkin Editorial Board (who may be contacted directly or via the Editorial Office) would welcome comments, suggestions, and advice on general policy matters concerning *Perkin Transactions*.
