# Cadmium(II), bismuth(III), lead(II) and thallium(I) crown thioether chemistry: synthesis and crystal structures of $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24]^{2} \mathrm{an}_{8}\right)\right]$, $\left.\left[\left(\mathrm{BiCl}_{3}\right)_{2}[24] \mathrm{aneS}_{8}\right)\right],\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ and $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right]-$ $\mathrm{PF}_{6}$ ([24]aneS $\mathrm{S}_{8}=1,4,7,10,13,16,19,22$-octathiacyclotetracosane; [28] aneS $_{8}=1,4,8,11,15,18,22,25$-octathiacyclooctacosane)

#### Abstract

The complexes $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left(\left[24 \mathrm{aneS}_{8}\right)\right],\left[\left(\mathrm{BiCl}_{3}\right)_{2}[24] \mathrm{aneS}_{8}\right)\right],\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ and $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}\left([24] \mathrm{aneS}_{8}=\right.$ 1,4,7,10,13,16,19,22-octathiacyclotetracosane, [28]aneS $\mathrm{S}_{8}=1,4,8,11,15,18,22,25$-octathiacyclooctacosane) have been prepared, characterized and their crystal structures determined. $\mathrm{In}\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$ two $\mathrm{CdI}_{2}$ units are bound to the macrocycle forming a discrete centrosymmetric binuclear complex, $\mathrm{Cd}(1)-\mathrm{I}(1) 2.7551(11), \mathrm{Cd}(1)-\mathrm{I}(2) 2.6944(8)$, $\mathrm{Cd}(1)-\mathrm{S}(1) 2.817(2), \mathrm{Cd}(1)-\mathrm{S}(4) 2.615(2), \mathrm{Cd}(1)-\mathrm{S}(7) 2.927(2) \mathrm{A}$. In $\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$ two $\mathrm{BiCl}_{3}$ units are weakly bonded to the thioether crown, $\mathrm{Bi}-\mathrm{S} 3.134(2)-3.313(2) \AA$, to give a discrete centrosymmetric binuclear complex with the two metal centres disposed on opposite sides of the mean plane of the macrocycle. In $\left[\mathrm{Pb}_{2}\left([28]\right.\right.$ aneS $\left.\left._{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ an $\mathrm{S}_{4} \mathrm{O}_{4}$ co-ordination is realized at each $\mathrm{Pb}^{\mathrm{II}}$ sitting in the macrocyclic cavity. The two $\mathrm{Pb}^{\mathrm{II}}$ are bridged by two $\mathrm{ClO}_{4}^{-}$ ions, $\mathrm{Pb}-\mathrm{S} 2.861(2)-2.998(2), \mathrm{Pb}-\mathrm{O} 2.701(7)-2.936(6) \AA$. In contrast, $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}$ adopts a polymeric structure in which each $\mathrm{Tl}^{\mathrm{I}}$ bridges two thioether crowns to give an infinite sinusoidal chain. The $\left[\mathrm{S}_{4}+\mathrm{S}_{4}\right]$ co-ordination sphere at the metal centre is satisfied by two half ligands in a sandwich arrangement, T1-S 3.2413(11)-3.4734(14) $\AA$.


## Introduction

The co-ordination chemistry of crown thioethers has been the subject of great interest over the past decade. ${ }^{1}$ These macrocycles can form stable, inert complexes with a wide range of transition metal ions, ${ }^{2-12}$ sometimes forcing the metal centre to adopt unusual co-ordination geometries and/or oxidation states. ${ }^{1,13-15}$ The majority of these studies have focused on the co-ordination chemistry of 1,4,7-trithiacyclononane ( $[9]$ aneS $_{3}$ ), 1,4,7,10-tetrathiacyclododecane ([12] $\left.\mathrm{aneS}_{4}\right), \quad 1,5,9,13$-tetrathiacyclohexadecane ([16]aneS 4 ) and $1,4,7,10,13,16$-hexathiacyclooctadecane ( $[18] \mathrm{aneS}_{6}$ ) in order to understand the relationships between the stereochemical and redox characteristics of the corresponding transition metal complexes. In contrast, the co-ordination chemistry of larger rings such as 1,4,7,10,13,16,19,22-octathiacyclotetracosane ([24]aneS $8_{8}$ ) and $1,4,8,11,15,18,22,25$-octathiacyclooctacosane ([28]aneS $\mathrm{S}_{8}$ ) is less well studied ${ }^{3,16,17}$ and the examination of p-block metals ions and $\mathrm{d}^{10}$ transition metal ions still remains an open area of investigation. Few examples of thioether macrocyclic complexes of $\mathrm{Cd}^{\mathrm{II}}, \mathrm{Hg}^{\mathrm{II}}$ and $\mathrm{Au}^{\mathrm{I}}$ have been reported ${ }^{15,18-21}$ and it is only recently that the corresponding co-ordination chemistry of $\mathrm{Ag}^{\mathrm{I}}$ has received any attention. ${ }^{1,22-29}$ Furthermore, the only examples of structurally characterized complexes of p-block elements with thioether crowns are limited to $\left[\mathrm{Pb}\left([9] \mathrm{aneS}_{3}\right)_{2}-\right.$ $\left.\left(\mathrm{OClO}_{3}\right)_{2}\right],{ }^{30}\left[\mathrm{AlMe}_{3}\left([12] \mathrm{aneS}_{4}\right)\right],{ }^{31}\left[\mathrm{AlMe}_{3}\left([14] \mathrm{aneS}_{4}\right)\right]$, , ${ }^{32}[\mathrm{Tl}([9]-$ $\left.\left.\mathrm{aneS}_{3}\right)\right] \mathrm{PF}_{6}{ }^{33}\left[\mathrm{Tl}\left([18] \mathrm{aneS}_{6}\right)\right] \mathrm{PF}_{6}{ }^{34}\left[\mathrm{BiCl}_{3}\left([12] \mathrm{aneS}_{4}\right)\right],{ }^{35}\left[\mathrm{BiCl}_{3}-\right.$ $\left.\left([15] \mathrm{aneS}_{5}\right)\right] \cdot 0.5 \mathrm{MeCN}^{35} \quad\left[\mathrm{SbCl}_{3}\left([9] \mathrm{aneS}_{3}\right)\right],{ }^{36} \quad\left[\left(\mathrm{SbCl}_{3}\right)_{2}([18]-\right.$ aneS $\left.\left._{6}\right)\right],{ }^{36} \quad\left[\left(\mathrm{SnCl}_{3}\right)_{3}\left([9] \mathrm{aneS}_{3}\right)_{2}\right]^{37}$ and $\left[\left(\mathrm{SnCl}_{4}\right)_{2}\left([18] \mathrm{aneS}_{6}\right)\right]$. $\mathrm{MeCN} .{ }^{37}$

Considering that macrocyclic polythioethers also represent a useful starting point for designing selective metal complexation agents for the uptake and transportation of toxic heavy-metal ions, we have recently reported the synthesis, crystal structures and electrochemical properties of complexes of $\mathrm{Ag}^{\mathrm{I}}, \mathrm{Hg}^{\mathrm{II}}$ and
$\mathrm{Au}^{\mathrm{I}}$ with [24]aneS ${ }_{8}$ and [28]aneS ${ }_{8} .{ }^{16}$ As an extension of this investigation, we report herein the synthesis and crystal structures of $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right],\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$, $\left[\mathrm{Pb}_{2}([28]-\right.$ aneS $\left.\left._{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ and $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}$. With the exception of our work on $\left[\mathrm{Cu}_{2}\left([24] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{BF}_{4}\right]_{2},\left[\mathrm{Cu}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{2}{ }^{3}$ and on related complexes of $\mathrm{Ag}^{\mathrm{I}}, \mathrm{Hg}^{\mathrm{II}}$ and $\mathrm{Au}^{\mathrm{I}},{ }^{16}$ these represent the only examples of complexes of these large-ring crown thioethers to have been structurally characterized.



## Results and discussion

[( $\left.\left.\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$
Reaction of [24]aneS ${ }_{8}$ with 2 equivalents of $\mathrm{CdI}_{2}$ in MeCN $\mathrm{CH}_{2} \mathrm{Cl}_{2}(1: 1 \mathrm{v} / \mathrm{v})$ affords a white precipitate after stirring at room temperature for 1 h . Analytical and mass spectrometric data supported the stoichiometry $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24]\right.\right.$ aneS $\left.\left._{8}\right)\right]$ and colourless block-shaped crystals suitable for X-ray diffraction studies were obtained by diffusion of $\mathrm{Et}_{2} \mathrm{O}$ vapour into a solution of the complex in $\mathrm{MeNO}_{2}$-thf ( $1: 1 \mathrm{v} / \mathrm{v}$ ).

A single crystal structure analysis confirms the complex to be the binuclear species $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24]\right.\right.$ aneS $\left.\left._{8}\right)\right]$ (Fig. 1, Table 1). As in $\left[\left(\mathrm{HgBr}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$, ${ }^{16 b}$ the complex lies across a crystallographic inversion centre with the asymmetric unit consisting of one $\mathrm{CdI}_{2}$ moiety and half of a [24]aneS ${ }_{8}$ macrocycle. Each $\mathrm{Cd}^{\mathrm{II}}$ has an overall distorted trigonal bipyramidal geometry, being co-ordinated by three consecutive S atoms of the macrocycle

and two $\mathrm{I}^{-}$ligands, $\mathrm{Cd}(1)-\mathrm{I}(1) 2.7551(11), \mathrm{Cd}(1)-\mathrm{I}(2) 2.6944(8)$, $\mathrm{Cd}(1)-\mathrm{S}(1) 2.817(2), \mathrm{Cd}(1)-\mathrm{S}(4) 2.615(2), \mathrm{Cd}(1)-\mathrm{S}(7) 2.927(2)$ $\AA$. The two apical $\mathrm{Cd}-\mathrm{S}$ bond distances to $\mathrm{S}(1)$ and $\mathrm{S}(7)[\mathrm{S}(1)-$ $\left.\mathrm{Cd}(1)-\mathrm{S}(7) 147.39(5)^{\circ}\right]$ are much longer than the bond to $\mathrm{S}(4)$ and, as for $\left[\left(\mathrm{HgBr}_{2}\right)_{2}\left([24]\right.\right.$ aneS $\left.\left._{8}\right)\right]$, ${ }^{16 b}$ this could be a consequence of the different dispositions of the three co-ordinated S donors relative to the cavity of the macrocycle, $S(4)$ being endo- and $S(1)$ and $S(7)$ being exo-oriented. However, even though the two $\mathrm{Hg}-\mathrm{S}_{\text {ap }}$ interactions in $\left[\left(\mathrm{HgBr}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]^{16 b}$ differ considerably, $\mathrm{Hg}-\mathrm{S}_{\mathrm{ap}} 2.836(4), 3.110(4) \AA$, the average $\mathrm{Hg}-\mathrm{S}$ bond distances, $2.8(1) \AA$, is practically identical to the average of the $\mathrm{Cd}-\mathrm{S}$ bonds in $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right], 2.79(8) \AA$. This underlines the similarity of the co-ordination geometry imposed by [24]aneS ${ }_{8}$ at $\mathrm{CdI}_{2}$ and $\mathrm{HgI}_{2}$ moieties. [In this paper, the estimated standard deviations $(\sigma)$ on each mean $\mathrm{M}-\mathrm{S}$ distance were calculated using the expression $\sigma^{2}(x)=\Sigma_{i=1}^{n}\left(x_{i}-\bar{x}\right)^{2} /$ $n(n-1)$ where $n$ is the number of data averaged and $\bar{x}$ is their mean.] The $\mathrm{Cd} \cdots \mathrm{Cd}$ distance across the inversion centre is $5.797(2) \AA$ with the two $\mathrm{CdI}_{2}$ moieties disposed on opposite sides of the macrocyclic ring, to give an overall anti configuration. Selected bond lengths and angles are summarized in Table 1. The crystal lattice comprises stacks of the binuclear complex propagating along the $b$ axis via $\mathrm{S} \cdots \mathrm{S}$ contacts of $3.636(2) \AA$ between successive units (Fig. 2). Interestingly, as for $\left[\left(\mathrm{HgBr}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right],{ }^{16 b}$ the S atoms involved in these long range $S \cdots S$ contacts are the one not involved in any co-ordination $[S(10)]$ and the one which shows the shortest $\mathrm{Cd}-\mathrm{S}$ bond distance $[\mathrm{S}(4)]$.

To our knowledge only four cadmium(II) complexes of thioether crowns have been reported, namely $\left[\mathrm{Cd}\left([15] \mathrm{aneS}_{5}\right)\right]-$ $\left[\mathrm{ClO}_{4}\right]_{2} \cdot \mathrm{H}_{2} \mathrm{O}^{21},{ }^{21}\left[\mathrm{Cd}\left([16] \mathrm{aneS}_{4}\right)\right]\left[\mathrm{ClO}_{4}\right]_{2},{ }^{20 a}\left[\mathrm{Cd}\left([9] \mathrm{aneS}_{3}\right)_{2}\right]\left[\mathrm{BF}_{4}\right]_{2} \cdot$ $2 \mathrm{MeNO}_{2}{ }^{20 b}$ and $\left[\mathrm{CdI}_{2}\left([9] \mathrm{aneS}_{3}\right)\right]_{2} \cdot{ }^{20 c}$ These complexes have five, four, six and three $S$-donors bound to the metal centre, respectively, with mean $\mathrm{Cd}-\mathrm{S}$ bond distances of 2.76(2), 2.618(1), $2.654(2)$ and $2.767(7) \AA$. Comparing these data with a value of $2.79(8) \AA$ for the mean $\mathrm{Cd}-\mathrm{S}$ distance in $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$ where three S -donors bind to $\mathrm{Cd}^{\mathrm{II}}$, it is now apparent that the proposed direct correlation ${ }^{21}$ between the metal-sulfur bond lengths and the number of co-ordinated S atoms has not been conclusively established. When the estimated standard deviations on the mean distances are taken into account, the mean metal-sulfur bonds do not change significantly as the number of co-ordinated S-donors increases. Also, in mercury(II) complexes of thioether crowns for which this relationship was first proposed, ${ }^{20 a}$ the average $\mathrm{Hg}-\mathrm{S}$ bond distances do not differ significantly between $\left[\mathrm{Hg}\left([16] \mathrm{aneS}_{4}\right)\right]\left[\mathrm{ClO}_{4}\right]_{2},{ }^{20 a} \quad\left[\mathrm{Hg}\left([14]\right.\right.$ aneS $\left._{4}\right)$ $\left.\left(\mathrm{OH}_{2}\right)\right]\left[\mathrm{ClO}_{4}\right]_{2},{ }^{18}\left[\left(\mathrm{HgCl}_{2}\right)\left([14] \mathrm{aneS}_{4}\right)\right]^{18}$ (four co-ordinated S donors) and $\left[\mathrm{Hg}\left([15] \mathrm{aneS}_{5}\right)\right]\left[\mathrm{PF}_{6}\right]_{2}{ }^{19}$ (five co-ordinated S donors) $\left[\mathrm{Hg}-\mathrm{S}_{\mathrm{av}} 2.597(5), 2.61(4), 2.64(3)\right.$ and 2.59(5) $\AA$, respectively] and $\left[\mathrm{Hg}\left([9] \text { aneS }_{3}\right)_{2}\right]\left[\mathrm{PF}_{6}\right]_{2}{ }^{15 a}$ [six co-ordinated S-donors, $\left.\mathrm{Hg}-\mathrm{S}_{\mathrm{av}} 2.69(2) \AA\right]$. For $\left[\left(\mathrm{HgBr}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$, ${ }^{16 b}$

$\mathrm{Hg}-\mathrm{S}_{\mathrm{av}} 2.8(1) \AA$ for three $\mathrm{Hg}-\mathrm{S}$ distances, and 2.71(8) $\AA$ if the $\mathrm{Hg}-\mathrm{S}_{\text {ap }}$ long interaction of 3.110 (4) $\AA$ is excluded from the calculation of the mean on the grounds that it is quite beyond the value of $2.8 \AA$ which is the sum of the formal ionic radii for $\mathrm{Hg}^{\mathrm{II}}(0.96 \AA)$ and $\mathrm{S}(1.84 \AA) .{ }^{38}$

Presumably, steric factors associated with the preferred coordination geometry of the thioether macrocyclic ligands together with the nature of co-ligands will have a marked influence on the observed $\mathrm{M}-\mathrm{S}$ bond lengths especially when soft and polarizable metal ions such as $\mathrm{Cd}^{\mathrm{II}}$ and $\mathrm{Hg}^{\mathrm{II}}$ and thioether donors are considered. It may therefore be very difficult to make generalizations about potential trends in observed M-S bond distances in these systems.

## [ $\left.\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$

Reaction of [24]aneS $S_{8}$ with 2 molar equivalents of $\mathrm{BiCl}_{3}$ in MeCN affords a white precipitate after stirring for 2 h at room temperature under $\mathrm{N}_{2}$. On the basis of microanalytical

and IR spectroscopic data, the product was assigned as $\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left[[24] \mathrm{aneS}_{8}\right)\right]$. A single crystal structure determination confirms the compound to be a binuclear bismuth(III) complex (Fig. 3, Table 2). Like $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$, this molecule lies across a crystallographic inversion centre, the macrocycle adopting a sigmoidal conformation generating two symmetryrelated cradles over which the two $\mathrm{BiCl}_{3}$ moieties sit. Each $\mathrm{Bi}^{\mathrm{II}}$ is co-ordinated to five S -donors of the crown and to three $\mathrm{Cl}^{-}$ligands in a half-sandwich arrangement. Atom $\mathrm{S}(1)$ and its symmetry equivalent $\mathrm{S}\left(1^{1}\right)(\mathrm{i}-x,-y,-z)$ both bridge the two metal centres and this represents the first example of a thioether macrocyclic complex in which S-donors link two metal centres within the same complex cation. The co-ordinated S atoms in the asymmetric unit are not coplanar and the $\mathrm{BiCl}_{3}$ moiety sits centrally over the macrocyclic ring with the Bi atom displaced 1.6003(8) A from the mean plane defined by $\mathrm{S}(1), \mathrm{S}(4), \mathrm{S}(7)$, $\mathrm{S}(10)$ and $\mathrm{S}\left(1^{\mathrm{i}}\right)$. Three of the $\mathrm{Bi}-\mathrm{S}$ bond distances, $\mathrm{Bi}(1)-\mathrm{S}(1)$ 3.227(2), $\mathrm{Bi}(1)-\mathrm{S}(4) 3.209(2), \mathrm{Bi}(1)-\mathrm{S}\left(1^{\mathrm{i}}\right) 3.313(2) \AA$, are longer than the other two, $\operatorname{Bi}(1)-\mathrm{S}(7) 3.134(2), \operatorname{Bi}(1)-\mathrm{S}(10) 3.144(2) \AA$,
with an overall mean value of $3.21(3) \AA$ [the sum of the formal ionic radii of $\mathrm{S}(1.84)$ and $\mathrm{Bi}^{\mathrm{III}}(1.17)$ is $\left.3.01 \AA\right] .{ }^{38}$ Interestingly, this mean $\mathrm{Bi}-\mathrm{S}$ distance is similar to that observed for $\left[\mathrm{BiCl}_{3}\left([15] \mathrm{aneS}_{5}\right)\right] \cdot 0.5 \mathrm{MeCN}, 3.17(3) \AA{ }^{3 .}{ }^{35}$ which shows a similar co-ordination sphere at the Bi . In $\left[\mathrm{BiCl}_{3}\left([12] \mathrm{aneS}_{4}\right)\right],{ }^{35}$ which shows four S -donors bound to the $\mathrm{BiCl}_{3}$ unit, the average $\mathrm{Bi}-\mathrm{S}$ bond distance is $3.07(5) \AA$. As with other complexes of $\mathrm{BiCl}_{3}$ with thioether crowns, the structural parameters of the $\mathrm{BiCl}_{3}$ unit change very little upon complexation, indicating a relatively weak interaction between the macrocycle and the metal halide; for $\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$ the mean $\mathrm{Bi}-\mathrm{Cl}$ bond distance is 2.56(2) $\AA$ and the mean $\mathrm{Cl}-\mathrm{Bi}-\mathrm{Cl}$ angle is $90(2)^{\circ}$ compared to $2.49 \AA(1)$ and $91(3)^{\circ}$ in the parent halide. ${ }^{39}$ The crystal lattice features stacks of binuclear units linked along the $b$ axis by $\mathrm{Cl} \cdots \mathrm{Cl}$ and $\mathrm{S} \cdots \mathrm{S}$ contacts of $3.447(4)$ and $3.321(3) \AA$, respectively (Fig. 4). Of interest is the close similarity of the co-ordination geometry around the metal centre in $\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$ and $\mathrm{BiCl}_{3}$. In the latter the Bi centres is strongly bonded to three chlorine atoms, $\mathrm{Bi}-\mathrm{Cl}$ 2.468(4)$2.518(7) \AA$, in a distorted trigonal pyramid with five $\mathrm{Cl}^{-}$centres located opposite the first three and interacting weakly with the metal ion, $\mathrm{Bi} \cdots \mathrm{Cl} 3.216(9)-3.450(9) \AA$. The overall eight-fold co-ordination is best described as a trigonal prism with two additional $\mathrm{Cl}^{-}$donors occupying two of its faces. ${ }^{39} \mathrm{~A}$ similar co-ordination geometry can be envisaged in $\left[\left(\mathrm{BiCl}_{3}\right)_{2}-\right.$ ([24]aneS $\mathrm{S}_{8}$ )] if we consider that the three $\mathrm{Cl}^{-}$atoms and $\mathrm{S}(4)$, $\mathrm{S}(10)$ and $\mathbf{S}\left(1^{1}\right)$ form a trigonal prism (the two planes defined by the three $\mathrm{Cl}^{-}$atoms and the three S atoms are tilted by only $9.4^{\circ}$ ); $\mathrm{S}(1)$ and $\mathrm{S}(7)$ then cap the $\mathrm{Cl}(1)-\mathrm{Cl}(3)-\mathrm{S}(4)-\mathrm{S}\left(1^{\mathrm{i}}\right)$ and $\mathrm{Cl}(2)-\mathrm{Cl}(3)-\mathrm{S}(4)-\mathrm{S}(10)$ faces, respectively (Fig. 3).
The crystal structures so far reported suggest that the co-ordination mode of thioether macrocycles to $\mathrm{BiCl}_{3}$ as well as crown ethers ${ }^{40}$ depends strongly upon the inflexible character of this metal halide moiety. The macrocyclic ligands therefore have to adopt a conformation which allows between four and six donors to bind to the $\mathrm{BiCl}_{3}$ fragment within the constraints of a half-sandwich structure.

## $\left[\mathrm{Pb}_{2}\left([24] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ and $\left[\mathrm{Pb}_{2}\left([28]\right.\right.$ aneS $\left.\left._{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$

Treatment of [24]aneS ${ }_{8}$ with 2 equivalents of $\mathrm{Pb}\left(\mathrm{ClO}_{4}\right)_{2} \cdot 3 \mathrm{H}_{2} \mathrm{O}$ in $\mathrm{MeCN}-\mathrm{CH}_{2} \mathrm{Cl}_{2}(1: 1 \mathrm{v} / \mathrm{v})$ affords a white solid after stirring at room temperature for 2 h . Spectroscopic and microanalytical data suggest the formulation $\left[\mathrm{Pb}_{2}\left([24] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$. Crystals were grown by diffusion of $\mathrm{Et}_{2} \mathrm{O}$ vapour into a solution of the complex in MeCN. Unfortunately, severe crystal twinning prevented a complete elucidation of the crystal structure. In order to obtain information on the binding of very large thioether crowns to $\mathrm{Pb}^{\text {II }}$, we repeated the reaction under the same conditions but using [28]aneS S $_{8}$. The IR spectrum of the resulting white solid confirmed the presence of [28]aneS ${ }_{8}$ and coordinated $\mathrm{ClO}_{4}^{-}$, while the fast atom bombardment (FAB) mass spectrum in 3-nitrobenzyl alcohol (noba) showed peaks with the correct isotopic distribution for $\left[{ }^{207} \mathrm{~Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right.$ $\left.\left(\mathrm{ClO}_{4}\right)_{3}\right]^{+}\left(M^{+}, m / z 1250\right)$ together with peaks corresponding to successive loss of $\mathrm{ClO}_{4}{ }^{-}$counter anions. Elemental analysis confirmed the stoichiometry $\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$. In order to establish the solid state connectivity and stereochemistry of the product, single crystals were grown by diffusion of $\mathrm{Et}_{2} \mathrm{O}$ vapour into a solution of the complex in MeCN . The single crystal structure determination confirms the binuclear nature of the compound (Fig. 5, Table 3). Again, the complex lies across a crystallographic inversion centre with the [28]ane$\mathrm{S}_{8}$ crown adopting a flat conformation with all eight S atoms endo-oriented, allowing the two $\mathrm{Pb}^{\mathrm{II}}$ to sit within the ring cavity. An analogous situation has been observed for the complexes $\left[\mathrm{Ag}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{NO}_{3}\right]_{2}{ }^{16 b} \quad\left[\mathrm{Au}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{PF}_{6}\right]_{2}{ }^{16 b}$ and $\left[\mathrm{Cu}_{2}-\right.$ ( $\left.\left.[28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{PF}_{6}\right]_{2}{ }^{3}$ in which the two metal centres are also encapsulated within the cavity of the thioether crown. The larger ring size of [28]aneS ${ }_{8}$ compared to [24]aneS ${ }_{8}$ is clearly

advantageous for the complexation of large metal ions within the macrocyclic cavity to give discrete binuclear products. Complexes of [24]aneS $\mathrm{S}_{8}$ reported so far are either polymeric or binuclear, but with the two metal centres considerably displaced from the mean plane of the ligand. An exception is $\left[\mathrm{Cu}_{2}\left([24] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{BF}_{4}\right]_{2}{ }^{3}$ but the copper( I$)$ ion is considerably smaller than those discussed herein. In $\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ each $\mathrm{Pb}^{\mathrm{II}}$ is co-ordinated to four S - and four O -donors, two of the latter deriving from a terminal bidentate $\mathrm{ClO}_{4}{ }^{-}$ion and two from two $\mathrm{ClO}_{4}^{-}$ions bridging the two metal ions within the macrocyclic cavity (Fig. 5). Three of the $\mathrm{Pb}-\mathrm{S}$ bond distances, $\mathrm{Pb}(1)-\mathrm{S}(4) 2.861(2), \mathrm{Pb}(1)-\mathrm{S}(8) 2.955(2), \mathrm{Pb}(1)-\mathrm{S}(11) 2.998(2)$ $\AA$, are significantly shorter than the fourth, $\mathrm{Pb}(1)-\mathrm{S}(1)$ $3.137(2) \AA$. The same trend is observed for the $\mathrm{Pb}-\mathrm{O}$ bond lengths, $\mathrm{Pb}(1)-\mathrm{O}(1) 2.722(6), \mathrm{Pb}(1)-\mathrm{O}(5) 2.701(7), \mathrm{Pb}(1)-\mathrm{O}\left(8^{i}\right)$ $2.795(12), \mathrm{Pb}(1)-\mathrm{O}(2) 2.936(6) \AA, \mathrm{i}-x,-y,-z$. The only thioether complexes of $\mathrm{Pb}^{\text {II }}$ previously reported are those with 1,4,7-trithiacyclononane ${ }^{30}$ and 1,5-dithiacyclooctan-3-ol; ${ }^{41}$ the $\mathrm{Pb}-\mathrm{S}$ bond distances range from 3.015(5) to 3.208(3) $\AA$ and the $\mathrm{Pb}-\mathrm{O}$ bond lengths to the co-ordinated counter ions $\left(\mathrm{ClO}_{4}^{-}\right.$ and $\mathrm{NO}_{3}{ }^{-}$respectively) span the range $2.701(10)-2.795(11) \AA$. Complexes of $\mathrm{Pb}^{\mathrm{II}}$ with mixed N/S donor macrocyclic ligands ${ }^{42}$ also give $\mathrm{Pb}-\mathrm{S}$ bond distances comparable with that of $3.137(2) \AA$ observed in $\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$. The only exception is represented by the complex with 1-thia-4,7-diazacyclononane ${ }^{42 d}$ for which the $\mathrm{Pb}-\mathrm{S}$ distance is $2.860(5) \AA$. Interestingly, for complexes with these mixed N/S donor

macrocyclic ligands, the $\mathrm{Pb}-\mathrm{O}$ distances of the co-ordinated counter anions are much shorter, ranging from 2.440(14)2.548(17) $\AA$ for the bidentate acetate ion in $\left[\mathrm{Pb}\left(\mathrm{L}^{1}\right)\left(\mathrm{O}_{2} \mathrm{CMe}\right)\right]-$ $\mathrm{PF}_{6}\left(\mathrm{~L}^{1}=3,13\right.$-dithia-6,10-diaza-1,8(2,6)-dipyridinacyclotetra-decaphane-6,9-diene) ${ }^{42 a}$ to $2.599(12)-2.761(12) \AA$ for the bidentate $\mathrm{ClO}_{4}^{-}$ion in $\left[\mathrm{Pb}\left(\mathrm{L}^{2}\right)\right]\left[\mathrm{ClO}_{4}\right]_{2}\left(\mathrm{~L}^{2}=6,7,8,9,10,11,12\right.$, 13,19,20-decahydro- 5 H -dibenzo $[e, p][1,4,8,11,14]$ dithiatriazacycloheptadecane). ${ }^{4 c c}$ In $\left[\mathrm{Pb}_{2}\left([28]\right.\right.$ aneS $\left.\left._{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ the overall
$\mathrm{S}_{4} \mathrm{O}_{4}$ donation at each $\mathrm{Pb}^{\text {II }}$ gives a holodirected ${ }^{43}$ co-ordination geometry around the metal ions with the bonds to the donor atoms evenly distributed about the co-ordination sphere and the $6 \mathrm{~s}^{2}$ lone pair of $\mathrm{Pb}^{\text {II }}$ seeming to be stereochemically inactive. Presumably, the separation of the two metal ions within the macrocyclic cavity, $\mathrm{Pb} \cdots \mathrm{Pb} 5.9127(12) \AA$, allows the $\mathrm{ClO}_{4}^{-}$ anions to act as bidentate ligands bridging the metal centres by permitting favourable $\mathrm{Cl}-\mathrm{O}-\mathrm{Pb}$ angles. In this way, the inert lone pair of electrons is prevented from expanding the coordination sphere of the lead(II) ions.

## [TI([24]aneS $\left.\left.{ }_{8}\right)\right] \mathrm{PF}_{6}$

Treatment of $\mathrm{TlPF}_{6}$ with either 1 or 2 molar equivalents of [24]aneS ${ }_{8}$ in $\mathrm{MeCN}-\mathrm{CH}_{2} \mathrm{Cl}_{2}(1: 1 \mathrm{v} / \mathrm{v})$ at room temperature for 3 h affords a colourless solution from which free ligand can be recovered as a white solid after partial removal of the solvent. Colourless block crystals were grown by diffusion of $\mathrm{Et}_{2} \mathrm{O}$ vapour into the remaining solution. Infrared spectroscopy and microanalytical data of the product were consistent with the formulation of these crystals as $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}$. Fast

atom bombardment mass spectrometry showed a peak at $\mathrm{m} / \mathrm{z}$ 685 assigned to $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right]^{+}$. A single crystal structure determination was undertaken to define the nature of the interaction between the macrocyclic ligand and the metal ion and this confirmed the complex to be a one-dimensional polymer. Each molecule of [24]ane $\mathrm{S}_{8}$ lies across a crystallographic inversion centre and is co-ordinated to two thallium( I ) ions disposed on opposite sides of the mean plane of the macrocycle in an anti configuration. Each $\mathrm{Tl}^{\mathrm{I}}$ occupies a two-fold axis and is sandwiched between two symmetry-related halves of two $[24] \mathrm{aneS}_{8}$ molecules (Fig. 6). Successive $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right]^{+}$units are related by the $a$ glide plane, generating an infinite one-dimensional sinusoidal polymer running along the $a$ axis (Fig. 7). An overall $[4+4]$ thioether co-ordination at each metal centre results with two $\mathrm{Tl}-\mathrm{S}$ bond distances, $\mathrm{Tl}(1)-\mathrm{S}(1)$

3.2851(13), $\mathrm{Tl}(1)-\mathrm{S}(4) 3.2413(11) \AA$, lying within the sum of the formal ionic radii of S and $\mathrm{Tl}^{1}(1.84+1.59=3.43 \AA)^{38}$ suggesting a substantial covalency. The two other Tl-S distances are rather longer, $\mathrm{Tl}(1)-\mathrm{S}(7) 3.4305(14), \mathrm{Tl}(1)-\mathrm{S}(10) 3.4734(14) \AA$, so they can be considered as short interactions. Apart from $\mathrm{S}(1)-\mathrm{Tl}(1)-\mathrm{S}(7), 116.29(3)^{\circ}$, all the $\mathrm{S}-\mathrm{Tl}-\mathrm{S}$ angles are quite acute (Table 4) ranging from 61.34(3) to 87.90(3) ${ }^{\circ}$ consistent with the long Tl-S distances observed. We have observed similar Tl-S distances and acute $\mathrm{S}-\mathrm{Tl}-\mathrm{S}$ angles for the complexes $\left[\mathrm{Tl}\left([9] \mathrm{aneS}_{3}\right)\right] \mathrm{PF}_{6}{ }^{33}$ and $\left[\mathrm{Tl}\left([18] \mathrm{aneS}_{6}\right)\right] \mathrm{PF}_{6}{ }^{34}$ which represent the only previous examples of thioether macrocycle complexes of $\mathrm{Tl}^{1}$ reported. In $\left[\mathrm{Tl}\left([9] \mathrm{aneS}_{3}\right)\right] \mathrm{PF}_{6}$ the trithia macrocycle is bound facially to the metal ion, $\mathrm{Tl}-\mathrm{S}$ 3.114(3), 3.092(3), $3.110(3) \AA$, while a thioether donor from an adjacent cation makes a longer contact, Tl-S 3.431(3) Á, linking $\left[\mathrm{Tl}\left([9] \mathrm{aneS}_{3}\right)\right]^{+}$ cations into infinite helices. A similar situation is observed in $\left[\mathrm{Tl}\left([18] \mathrm{aneS}_{6}\right)\right] \mathrm{PF}_{6}$ where all six macrocyclic S-donors interact with the metal centre at distances ranging from 3.164(5) to $3.356(6) \AA$ and are disposed on one side of the $\mathrm{Tl}^{\mathrm{I}}$, with two much longer intermolecular interactions on the opposite side, Tl-S $3.689(6)$, $3.688(6) \AA$. The complex $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}$ represents the first example of a thioether macrocyclic complex of $\mathrm{Tl}^{\mathrm{I}}$ having a genuine sandwich structure with half a ligand molecule bonded symmetrically on each side of the metal ion co-ordination sphere. Although in this structural situation $\mathrm{Tl}^{\mathrm{I}}$ fulfils its stereochemical preference for relatively high co-ordination numbers, it is quite surprising to see this sandwich structure achieved with [24]aneS ${ }_{8}$ for which the size mismatch between the $\mathrm{TI}^{1}$ and the macrocyclic cavity should be reduced. A situation in which the metal ion is encapsulated within the ligand cavity might prevent a favourable geometric distribution of donor atoms about the $\mathrm{Tl}^{\mathrm{I}}$ because of conformational constraints within the ligand.

## Conclusions

The 24- and 28 -membered octathia macrocyclic ligands have been used to synthesize complexes of p -block metal ions ( $\mathrm{Bi}^{\mathrm{III}}$, $\left.\mathrm{Pb}^{\mathrm{II}}, \mathrm{Tl}^{\mathrm{I}}\right)$ and $\mathrm{d}^{10}$ transition metal ions $\left(\mathrm{Ag}^{\mathrm{I}}, \mathrm{Hg}^{\mathrm{II}}, \mathrm{Cd}^{\mathrm{II}}\right.$ and $\mathrm{Au}^{\mathrm{I}}$ ). ${ }^{16}$ In all cases binuclear complexes have been isolated and structurally characterized and this demonstrates the ability of these ligands to bind two metal centres. In some cases polymeric complexes have also been obtained, expecially with the 24 membered ring, indicating that stereochemical and size mismatch with the complexed metal ion can also occur for these very large thioether macrocycles. The intramolecular metalmetal distances observed do not indicate any interaction, at least when the metal ions are in their stable electronic configurations. The possibility of these ligands stabilizing redox processes of metal centres through the formation of a metal-metal bond is now open to examination. The metals in which the $\mathrm{d}^{8}$ and $\mathrm{d}^{10}$ configurations are stable (e.g. Pt, Pd and Au ) would be of obvious interest. With Au we have already demonstrated that [28]aneS $\mathrm{S}_{8}$ is capable of supporting within its own co-ordination sphere a reversible four electron oxidation between the $\mathrm{Au}^{\mathrm{I}} \mathrm{Au}^{\mathrm{I}}$ and $\mathrm{Au}^{\text {III }} \mathrm{Au}^{\text {II }}$ species with the formation of transient $\mathrm{Au}^{\text {II }}$ containing intermediates. ${ }^{16 b}$ The synthesis and electrochemical study of binuclear complexes of $\mathrm{Pd}^{\mathrm{II}}$ and $\mathrm{Pt}^{\mathrm{II}}$ with [24]aneS ${ }_{8}$ and [28]aneS ${ }_{8}$ is currently under investigation.

## Experimental

Melting points are uncorrected. The IR spectra were recorded as KBr discs using a Perkin-Elmer 598 spectrometer over the range $200-4000 \mathrm{~cm}^{-1}$. Microanalyses were performed by the University of Nottingham School of Chemistry Microanalytical Service. Mass spectra were recorded at the EPSRC National Mass Spectrometry Service at Swansea. CAUTION: the lead(II) complexes of [24]aneS 8 and [28]aneS ${ }_{8}$ were isolated as $\mathrm{ClO}_{4}^{-}$salts. We worked with these complexes on small scales
both in solution and in the solid state without any incident. In spite of these observations, the unpredictable behaviour of $\mathrm{ClO}_{4}^{-}$salts necessitates extreme care in their handling.

## Preparations

[ $\left.\left(\mathbf{C d I}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$. To a well stirred solution of $[24] \mathrm{aneS}_{8}$ ( $20 \mathrm{mg}, 0.0416 \mathrm{mmol}$ ) in $\mathrm{MeCN}-\mathrm{CH}_{2} \mathrm{Cl}_{2}\left(15 \mathrm{~cm}^{3} 1: 1 \mathrm{v} / \mathrm{v}\right.$ ) was added a solution of $\mathrm{CdI}_{2}(30.76 \mathrm{mg}, 0.084 \mathrm{mmol})$ in MeCN $\left(5 \mathrm{~cm}^{3}\right)$. The mixture was stirred at room temperature for 2 h and the white solid formed filtered off, washed with $\mathrm{CH}_{2} \mathrm{Cl}_{2}$ and dried in vacuo ( $23.54 \mathrm{mg}, 46.4 \%$ yield). Colourless block crystals suitable for X-ray diffraction studies were grown by allowing $\mathrm{Et}_{2} \mathrm{O}$ to diffuse into a $\mathrm{MeNO}_{2}$-thf solution (1:1 $\mathrm{v} / \mathrm{v}$ ) of the complex, $\mathrm{mp} 179-181^{\circ} \mathrm{C}$ [Found (Calc. for $\mathrm{C}_{8} \mathrm{H}_{16} \mathrm{CdI}_{2} \mathrm{~S}_{4}$ ): C, 16.15 (15.83); H, $\left.2.70(2.66) \%\right]$. FAB mass spectrum: $m / z 720\left(\mathrm{M}^{+}\right)$; calc. for $\left[{ }^{112} \mathrm{Cd}\left([24] \mathrm{aneS}_{8}\right) \mathrm{I}\right]^{+}$ 720. $\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$. A mixture of $[24] \mathrm{aneS}_{8}(25.64 \mathrm{mg}$, $0.0533 \mathrm{mmol})$ and $\mathrm{BiCl}_{3}(33.61 \mathrm{mg}, 0.1066 \mathrm{mmol})$ in $\mathrm{MeCN}(15$ $\mathrm{cm}^{3}$ ) was stirred at room temperature and under nitrogen atmosphere. A white microcrystalline powder was formed over 2 h . It was filtered off, washed with $\mathrm{CH}_{2} \mathrm{Cl}_{2}$ and dried in vacuo ( $43 \mathrm{mg}, 72.6 \%$ yield). Crystals suitable for X-ray diffraction studies were grown by diffusion of $\mathrm{Et}_{2} \mathrm{O}$ vapour into a solution of the complex in MeCN-thf ( $1: 1 \mathrm{v} / \mathrm{v}$ ), mp $152-$ $153^{\circ} \mathrm{C}$; the white microcrystalline powder turns into an amorphous yellow wax, decomp. 183-185 ${ }^{\circ} \mathrm{C}$ [Found (Calc. for $\mathrm{C}_{8} \mathrm{H}_{16} \mathrm{BiCl}_{3} \mathrm{~S}_{4}$ ): C, 17.59 (17.28); H, $2.94(2.54) \%$ ]. $\left[\mathrm{Pb}_{\mathbf{2}}\left([24] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$. A mixture of $[24] \mathrm{aneS}_{8}(30 \mathrm{mg}, 0.062$ $\mathrm{mmol})$ and $\mathrm{Pb}\left(\mathrm{ClO}_{4}\right)_{2} \cdot 3 \mathrm{H}_{2} \mathrm{O}(57.06 \mathrm{mg}, 0.124 \mathrm{mmol})$ in $\mathrm{CH}_{2} \mathrm{Cl}_{2}-\mathrm{MeCN}\left(12 \mathrm{~cm}^{3}, 1: 1 \mathrm{v} / \mathrm{v}\right)$ was stirred at room temperature for 4 h . The solvent was removed under reduced pressure and the white residue washed with $\mathrm{CH}_{2} \mathrm{Cl}_{2}$ and subsequently with $\mathrm{Et}_{2} \mathrm{O}(15.1 \mathrm{mg}, 21 \%$ yield). Colourless block crystals were grown by diffusion of $\mathrm{Et}_{2} \mathrm{O}$ into a MeCN solution [Found (Calc. for $\mathrm{C}_{8} \mathrm{H}_{16} \mathrm{Cl}_{2} \mathrm{O}_{8} \mathrm{PbS}_{4}$ ): C, 14.55 (14.86); H, $\left.2.22(2.48) \%\right]$. A mixture of $[28] \mathrm{aneS}_{8}(20 \mathrm{mg}$, $0.0372 \mathrm{mmol})$ and $\mathrm{Pb}\left(\mathrm{ClO}_{4}\right)_{2} \cdot 3 \mathrm{H}_{2} \mathrm{O}(34.24 \mathrm{mg}, 0.0744 \mathrm{mmol})$ in $\mathrm{MeCN}-\mathrm{CH}_{2} \mathrm{Cl}_{2}\left(15 \mathrm{~cm}^{3}, 1: 1 \mathrm{v} / \mathrm{v}\right)$ was stirred at room temperature overnight. The white solid formed was filtered off and washed with $\mathrm{CH}_{2} \mathrm{Cl}_{2}(40.5 \mathrm{mg}, 80.7 \%$ yield). Crystals suitable for X-ray diffraction studies were obtained by recrystallization from $\mathrm{MeCN}-\mathrm{Et}_{2} \mathrm{O}$ [Found (Calc. for $\mathrm{C}_{10} \mathrm{H}_{20} \mathrm{Cl}_{2} \mathrm{O}_{8} \mathrm{PbS}_{4}$ ): C, 17.60 (17.79); H, $\left.2.88(2.96)^{\%} \%\right]$. [Tl([24]aneS $\left.\mathbf{S}_{8}\right)$ PFF $_{6}$. To a solution of [24]aneS $\mathbf{S}_{8}(20 \mathrm{mg}, 0.042$ $\mathrm{mmol})$ in $\mathrm{CH}_{2} \mathrm{Cl}_{2}\left(3 \mathrm{~cm}^{3}\right)$ was added a solution of $\mathrm{TIPF}_{6}(14.52$ $\mathrm{mg}, 0.042 \mathrm{mmol})$ in $\mathrm{MeCN}\left(3 \mathrm{~cm}^{3}\right)$. The resulting mixture was stirred at room temperature for 3 h . The solvent was partially removed under reduced pressure and a white solid precipitated

(unchanged [24]aneS 8 ). From the solution obtained after filtration, block crystals of the target compound were grown by $\mathrm{Et}_{2} \mathrm{O}$ diffusion ( $14.3 \mathrm{mg}, 41.42 \%$ yield). The same compound was obtained in $32 \%$ yield by performing the reaction with a [24]aneS $\mathrm{S}_{8}: \mathrm{TlPF}_{6}$ molar ratio of $1: 2, \mathrm{mp} 130-132{ }^{\circ} \mathrm{C}$ [Found (Calc. for $\mathrm{C}_{16} \mathrm{H}_{32} \mathrm{~F}_{6} \mathrm{PS}_{8} \mathrm{Tl}$ ): C, 22.95 (23.14); H, 3.70 (3.86) $\%$ ]. FAB mass spectrum: m/z 685 ; calc. for $\left[{ }^{205} \mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right]^{+} 685$. IR spectrum ( KBr pellet): 2922w, 1421m, 1262m, 1194w, 839s and $558 \mathrm{~m} \mathrm{~cm}^{-1}$.

## Crystallography

A summary of the crystal data and refinement parameters for $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right], \quad\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right], \quad\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]-$ $\left[\mathrm{ClO}_{4}\right]_{4}$ and $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}$ is given in Table 5. The crystals were cooled using an Oxford Cryosystems open-flow nitrogen cryostat. ${ }^{44}$ For $\left[\left(\mathrm{CdI}_{2}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$, $\left[\left(\mathrm{BiCl}_{3}\right)_{2}\left([24] \mathrm{aneS}_{8}\right)\right]$ and $\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ data were collected on a Stoë STADI-4 four-circle diffractometer using $\omega-\theta$ scans, whereas for $\left[\mathrm{Tl}\left([24] \mathrm{aneS}_{8}\right)\right] \mathrm{PF}_{6}$ a Stoë IPDS image plate diffractometer was used. Data were corrected for Lorentz-polarization effects and absorption corrections (numerical or $\psi$ scans) were also applied. The structures were solved by direct methods ${ }^{45}$ and subsequent Fourier-difference syntheses. ${ }^{46}$ All non-H atoms were refined anisotropically and all H atoms placed at calculated positions and thereafter refined using a riding model with $U_{\text {iso }}(\mathrm{H})=1.2 U_{\text {eq }}(\mathrm{C})$. For all the four structures the largest residual electron density features lay near the metal atoms. The structure of $\left[\mathrm{Pb}_{2}\left([28] \mathrm{aneS}_{8}\right)\right]\left[\mathrm{ClO}_{4}\right]_{4}$ shows disorder of the $\mathrm{O}(8)$ atom of the bridging perchlorate ions; the disorder was modelled by a partial occupancy model over two sites with occupancies of 0.57 and 0.43 .
