The witness, Miss Mary Smith (not her real name), a 25-year old high school teacher in Florida, and her mother were visiting in Georgia when the sighting took place, the night of December 27, 1969. It was about 0200 EST, and this case unpublished until this issue of SKYLOOK, is from a tape recorded interview, as follows:

"We had driven to near Atlanta to visit my aunt and couldn't find her house as she had moved since the last time we were up there. We stopped at a roadside coffee shop and after leaving the coffee shop, we sat out front. Across the street from the coffee shop there is a plaza with several small stores setting back on the lot away from the street. Up toward the front of the lot is a Dairy Castle (ice cream shop). It sets several yards back from the road although it's nowhere close to as far as the shopping centers stores from the street. The street was the main one through town, a highway and it is well illuminated by street lights. The lights did not extend far back into the lot (parking lot), the shopping center had individual lights in the stores

but none in between the street lights and the stores.
"I was sitting there talking to my mother, discussing what we were going to do next and she looked up and I was looking at her because she had such a strange reaction -- her face was pale and her eyes got big and her mouth just dropped. She was staring up in the sky and I kept asking her what it was and finally she pointed up and said, 'Look! I I did not see what she had seen originally. She had described it later to me -- a black saucer-shaped object, and she did describe it as very, very dark, she would say black. It had a flat bottom to it and the bottom of the saucer opened up slowly, it was hovering. This part I didn't see-what I saw was when this thing, it looked like a plastical bubble, dropped from the object. It rolled out through this door, and at this point I saw it as it began falling. At the time when I saw it; I would say it was no more than four stories in the air. I watched it? as it drifted; it drifted in a fairly regular pattern, but the bubble itself was illuminated from the inside by a white core of heat. Now i say heat because there were no visible flames coming from it. I knew it was hot; it had this white hot core; on the edges you could see the color that comes into a fire, it appeared cooler. The bubble was shimmering it seemed to become irregular in shape, the shape of the actual bubble was constantly shifting. As it got closer to the ground, I was concentrating on the light within the bubble. I'm not sure, I cannot describe exactly what happened to the casing to this heat core but it was like it had just malted off he it foll the core tracked. it had just melted off. As it fell, the core itself, in this bubble, divided into three parts, and they were arrows, they were prongs. And at first they were gathered like they were almost touching at the base away from the point end. As they traveled down, they separated and, like I say, this was just across the street. The lot couldn't have been more than 15 or 20 yards from where we were sitting and the arrows went into the ground just beyond the paved part of the parking lot. They were in the flame as they reached the ground; the glow had gone from them and they were just in a flame. You could discern the shape of the arrows; they had that white heat to them. As they went into the ground and it was normal to assume that they did go into the ground, you could see the fire and the heat disappear from the bottom up as they went out of sight. We had a clear view into this area where they fell. Now all this time that this happened, my mother and I talked back and forth to (Continued on Next Bage)

each other, verifying that we were seeing the same things; because it was very late at night and this was such a strange thing to see that we kept checking with each other to make sure that we were both okay.

We sat there for a few moments; some boys came out-I believe they were local, they were watching us. They had entered their car and they had seen us watching something; they came up and asked us if we had car trouble or something. We told them no and they drove away, but in a few

moments they came back and just sat there.

"In a very little while, I was looking over in the parking lot and I saw a dark figure up close to the Dairy Queen building. I asked my mother, if she saw it also and she said that she did. This thing was about 5 feet, 7 inches to 5 feet, 10 inches; it was large, had large shoulders, husky in build. It tapered down into a very narrow waist with extremely thin hips, long straight legs. The head was extremely small for the body and came up into a point. The arms were shorter than normal and it appeared to be all black, we couldn't see any feature. tures. As we watched, it seemed from out of nowhere there were two other figures, the same -- same build and shape. One of them was extremely larger than the other two, but they all had the same build. We did not see a craft land; we did not see them get out of a craft. They had rake-like objects in their hands although they were not rakes--they were long handled, like a broom handle, and the bottom was a triangle, a solid triangle. They were sweeping furiously an area of about 9 feet in diameter. It was as if they were beating something back--they had a basket of some sort with them that was setting in the center. And as they swept these things up onto a satisfactory pile, they would reach down and put them into the basket. At one point, the guys who had been sitting in the other car near us followed our gaze and evidently saw. the figures. They started their car and tore out to the spot in the parking lot. As they went through, this was the most terrifying part about it, I think, because of the fact that I was watching one of the figures and I didn't see him run and he didn't go up'in a cloud of smoke, but he just CEASED TO BE VISIBLE TO ME!

"My mother didn't see him either. When the boys got up to the spot where the figures had been, they weren't there any more. They went through the back side of the parking lot and they did not come back."

I feel sure that whatever we were seeing they saw also.

"At one point while the figures were sweeping the area, whatever it was they were chasing seemed to run out to the edge of the street and the large thing followed it out with this triangular-shaped rake. It was trying to beat it back into the group, and couldn't get it. It reached down, and when it reached down it had in its hand something that glowed. As it raised this thing up, the light in it just disappeared, and it ran back and put this thing in the basket. The figures movements were in some sort of syncopated rhythm; when I say rhythm, it was like they were actually marking time with each movement of their body, it was very jerky. But it was syncopated. \( \overline{D}\) Does this suggest a robot? \( \overline{T}\)

We didn't report any of this because we were afraid of being ostracized for reporting it. Now I can guarantee that I was in a sober state at the time, my mother being a complete, absolute Baptist non-drinker, with a sober reputation. I can guarantee that we were not inebriated when we saw this. The weather was very crisp and cold,

and the sky was clear."

"Like a Boomerang"

Some interesting photos have recently been brought to my attention and I wish to share the details with SKYLOOK readers. They were taken by Ronald Hemingway, a brother of my neighbor, Robert Hemingway. Robert knew of my interest in 1805 and other knew of my interest in UFOs and other sky phenomena, so he brought. Ronald by to see if I would know what he had photographed. Initially I thought it to be a barium cloud, but it has some different twists.

Ronald was on vacation in California in November of 1970. On Nov: 5 he and his wife were camped at Carlabad State Beach which is about 20 miles north of San Diego. About 6:30 PM local time. Ronald noticed through the partial overcast a blue sh light about the size of the moon which was in the west about 75 degrees over the ocean. At first glance he believed the blue area to be the moon, but quickly realized it was in the east.

Following a discussion with his wife and some neighboring campers concerning the light, he decided to take photographs. Using Extachrome (64) in his 35mm Minolta (55 mm, f-1.7 lens) he made three exposures. The first and second are similar in that they show a round blueish haze just above a low bank of clouds. The first exposure was approximately 15 seconds at f 1.7. The second exposure was about 30 seconds. It more clearly shows a cloud bank and redish area low in the picture supposedly where, the sun had set.

After several minutes the blue changed to a brighter white and he took a third and, to me, most interesting photo. This slide shows a very bright, white, round but irregular, diffuse area noticeably larger than the blue. At the lower right edge of this larger bright spot and about one twelfth the size is an irregular light area with sharp edges. his smaller area appears that it could be a solid object. Neither Ronald nor his wife remember seeing this small bright spot.

Hemingway listened to the radio the next day but heard nothing to explain the phenomenon. I have no doubt of his honesty. He has no idea what he photographed and is very anxious, as I am, to know more about what he saw. Hopefully, one of our California SKYLOCK readers may have an explanation. We would appreciate hearing from them.

Raymond Watts, of E. Peoria, Ill., writes of an unusual sighting about 7:45 the night of April 12, 1971. It was a clear night, with little wind, and Mr. Watts and a neighbor saw a strange object about a mile distant and an altitude of approximately 5,000 feet. Mr. Watts said if you threw a boomerang into the air and it came spiraling down, and "lit up", this would best describe the object they saw. It didn't appear to be a free fall, but under directional power. It was observed about three or four seconds and was about 20 degrees above the western

horizon when it "went out." We'd like to hear from anyone else in the area who may have seen this unusual object.

#### Illinois Man Follows Sky Object

Herb Williams age 36, an Illinois Revenue Officer, followed a round white light for about ten minutes April 30, 1971, then lost sight of it

while trying to contact a witness.

Williams was filling a truck with diesel fuel at the Ready-Mix Plant at 2090 Washington, on the west side of Carlyle, when he saw the object approximately 100 feet above the ground. The night was clear, and the bright object was easily seen. The sighting occurred at 11:50 PM and there was no sound. It moved in a westerly direction at about 10 miles per hour and Williams said he could have kept up with it by running, but

decided to get into his car and follow it.

First seen over the Carlyle fairgrounds, it moved at a mild left angle toward Beckemeyer. On reaching the town, Williams decided to call a friend in the law enforcement agency as he wanted a witness to his observation; but after making the call, the object had disappeared

from view.

Its course would have carried it over a railroad crew operating a Speno Bassast machine working between Carlyle and Beckemeyer, and the railroad crew reported, on being questioned, that no one had observed the object. This is understandable as they would have been watching the operation of the machinery, and a large cloud of dust surrounded the machine.

Williams said he felt the object was operated by remote control as it seemed to be too small to carry a pilot. Its slow motion resembled that of a balloon, he said, but he thought the intense white light would eliminate that possibility. Rather than drifting aimlessly, it appeared to be following the railroad track. Credit: Rosetta Holmes.

Retired Farmer Reports 1968 Sighting

"What it looked like was a full moon, only about 3 times larger and orange color," said Mr. Ira Prahl, age 66, a retired farmer of Route 1, Odin, Ill.

Mr. Odin doesn't recall the exact month or day, but it was four years ago and about five o'clock in the morning, as Mr. Odin was preparing to go to work at the Warren G. Murray Children Center. He was to be there two hours earlier that morning, so he remembers the hour.

It was still dark when he went out to the garage to get into his car and then he saw the object approaching from the southwest. He watched it for about three minutes; he said, then went back into the house to get his wife. When they came outside, the object had disappeared. It was about 1,500 feet high when he first saw it, three times the size of a full moon, and orange in color. There was no sound.

He mentioned the sighting to several people where he was employed, and they told him he was just "seeing things," he said. So he said no more about it to anyone at that time, as he didn't want to be laughed

Patricia Petersen, both housewives, were walking along Kettner Blvd. in downtown San Diego, California. They were on their way to pick up Mrs. Stine's car at a garage. They stopped in front of Dryer's, a large furniture store, to watch a large jet land at San Diego International Air-

port, two blocks distant.

A minute or two later, they heard a strange noise directly overhead. Looking up, they saw "a strange looking cloud." It was described as being white, shaped like a cigar, about the size of a commercial jet liner in length and appeared to be three and one half feet high. Mrs. Stine said the noise sounded like a ribbon flapping in the breeze, while Mrs. Petersen compared the sound to one made by shaking a stick through the air rapidly.

The object came out of the west and headed east. The women viewed it for a very brief time--two to four seconds. Both agreed that it was traveling "much faster than a jet." Both were puzzled by the sighting and asked each other, "What was it?" They talked about it as they con-

tinued walking.

Later, after she arrived home, Mrs. Petersen called the police and

Both witnesses agreed on the following points: the object was not sharply defined, but rather "fuzzy," It did not give off smoke or leave any visible trail. Neither did it drop anything nor change shape, bright ness or color. And it disappeared by climbing out of sight. They stated that the object was probably 250-300 feet above them.

Comment: The object reported by the witnesses seems to fit Vallee's definition of a Type IIA sighting i. e. a cloud cigar; but one that does not generate other objects. In Type II sightings the object is moving at a slow speed, is usually quite high, and the sighting lasts for several minutes. However, the present object, as reported, was moving quite rapidly at a low altitude and was seen for a very short length of time.

The object did not fly smoothly across the sky. Rather, it skipped across the sky. This is similar to Arnold's sighting and the Rev. Browning (Tasmania) sighting of October 1960.

Checks with the local news media and police (city, county and state) yielded no additional information. The FAA Radar Air Traffic Control Center did not pick up anything on radar and the FAA controllers on

duty at the airport did not see anything.

I checked at the airport to determine what airline landed between 12:20 and 12:30 PM on the day in question. The only airline landing during this time period was National Airlines. The counter agent for National at the airport said that neither the crew nor the passengers had said anything. He further stated that anytime an unidentified ob= ject is spotted near an airliner, it is always reported. Continuing, he said that the crew of that particular flight would not be available for questioning since they had already returned to Miami.

In my judgment it is quite probable that neither the crew nor the

passengers saw the object. The reasons for this are as follows:

- The crew of the airliner would be concentrating on the task of land ing the jet and would probably not see the object unless it came quite close to the plane.

- The passengers are generally "restless," excited, and preparing for the landing. They are not looking out the windows as much as at

other times.

- The witnesses stated that the object's speed was "much faster than." a jet." If we take the speed of a jet as 600MPH and "much faster" as being 50% faster or 300 MPH, we have a speed of 900 MPH. A speed of 900 MPH equals 15 miles per minute. The witnesses stated that the object appeared one or two minutes after the jet passed overhead. This would place the object 15 to 30 miles out to sea. According to the Weather Bureau, the visibility was 92 miles.

The possibility of a hoax has been ruled out for two reasons. First, they did not attempt to exploit the incident. In fact, they did not tell anyone except their immediate families and the writer. And, second, I knew both witnesses personally, since they were neighbors of mine in San Diego. Neither witness is the type to concoct a hoax or indulge in

practial, jokes:

Pactial, jokes.

Natural phenomena has also been ruled out because of 1) the speed of the object, 2) the sound-coming from the object, and 3) the motion

of the object i.e. the "skipping" effect.

What was the unusual flying object seen by Linda Stine and Patricia Petersen? I do not know. As Mrs. Petersen said, "whatever it was, it sure was strange."

Editor's Note: We consider this an excellent example of thorough investigation and good reporting.

A "Box" in the Sky

Ted Phillips received this report through a friend in California, Mo., who urged the witness to write Mr. Phillips. A follow-up on this will be presented later when Mr. Phillips can interview the observer.

The report, as sent to him, is as follows:

"It was January 31, 1967. We lived on highway 87, eleven miles south of California. The time was about 7 o'clock in the evening. We had 100 acres across the road from us and there was a clear view for miles. There were a number of lights above the horizon, but this one thing. stood out very definitely against the sky. It appeared to be a big box with changing lights. Some Army men interviewed my husband a few days later. We both felt that it was something that didn't belong in the sky. It was hanging there. This was such a clear night, and there could be no way to know the distance. We both felt that it was at least a mile. My husband passed away in 1968, but he definitely felt that it would be an unidentified foreign object.

Was It a UFO?

Larry Yoder and family, of Moberly, Mo., observed bright vellow and white lights, with three red lights, one blinking, pass directly overhead at 9:04 PM. April 21, 1971. The lights came out of the east, moving slowly at a very high altitude, passing overhead in a westerly course. Because of the spacing and arrangement of the lights, the object must have been very large, but did not resemble any conventional aircraft. There was a sound, as of a motor, he reported.

Dr. J. Allen Hynek, Director of Astronomy at Northwestern University and Scientific advisor to the USAF for 20 years, was the guest speaker of the St. Louis Aero Club, April 27, 1971. Eighty-two were present at a dinner meeting held at the Officers' Club at the old Navy Base at Lambert Field, St. Louis, Mo.

The subject of Dr. Hynek's lecture was "Do UFOs Exist?" with evidence and conclusions being emphatically in the affirmative. Dr. Hynek has written a book on UFOs / See May SKYLOOK/ with the publication date now set at early next year, and he is currently teaching a credit course

on UFOs at Northwestern with 70 aprlicants at its opening.

Dr. Hynek used about 50 slides to illustrate his lecture during which he was critical of the Condon Report, saying it would seem the Committee assumed from the beginning that there is nothing to UFOs, and then ... wrote from that premise. He specifically criticized the concentration on trivial misidentifications rather than truly puzzling cases.

Ted Phillips, SKYLOOK staff reporter, was introduced by Dr. Hynek and spoke briefly on "Landing Traces" which will be Mr. Phillips subject when he addresses the MUFON Conference in St. Louis, June 12.

A question and answer session followed and proved to be of great, interest as questions were asked which showed the audience (many of them pilots) had long been interested in the fascinating phenomena of uni-

dentified flying objects.

When asked about the current location of all the old Blue Book data, he replied that all of it is in Mongomery, Alabama, unclassified, and therefore, theoretically open to anyone who wants to see it, but, "If you try to see it, you will get a letter from the Pentagon saying that while all the data are unclassified, they happen to be housed in a classified area, and consequently it would be necessary for you to obtain clearance."

A member of the audience queried him about the Hills and he replied as follows: ". ... Dr. Simon invited me and Fuller to have dinner with the Hills at his home, and he hypnotized Betty and Barney for me and allowed me to interrogate them while they were under hypnosis. And it was a strange experience. . for an hour and a half I talked to them while they were under hypnosis. . and when Barney got to the. . where he was being physically drawn--pulled aboard, there was a terror in his voice, and he just got off the chair and got down on his knees and yelled and screamed, and it was a horrible thing to go through. I was shaken by it, and he would have had to have been a consummate actor. it seems to me, to have done that, and yet I can't say that it really

In 1967 Mrs. R. B. witnessed the landing of a glowing, domed disc in a field behind her home, just south of Eldom, Missouri.

- She noted a bright glow-through her living room window while watching television and went to investigate. As she stood at her back door, she saw the object approaching the field; it slowed, paused for a brief time just above ground level, then proceeded to land.

The UFO was illuminated by a bright blue-white light which seemed to cover the entire object. After touching ground, the upper section became dark and moonlight reflected from what appeared to be a metallic surface. The object remained on the ground only a short time, then ascended at a low angle and disappeared into the distance. The next morning the observer's husband and a relative went to the field where the object had landed and found eight oval areas where the vegetation was dry and dead. The marks were in pairs, 3 feet apart, each oval about 8 inches in diameter. The plants were also damaged for some distance along the flight path of the object.

Also in 1967, a farmer living near Barnett, Missouri, observed a large disc as it landed near his home. The object was on the ground for several minutes. After it left, the witness and his grandson went. to the landing site and found a circular area where the plants had been scorched.

It is interesting to note that the two ceses just given took place at towns only six miles apart. Unfortunately the witnesses could not give the exact dates of their sightings, only that they occurred in the summer of 1967.

These reports are of special interest to me as I have been special. izing in landing trace cases for the past 18 months. Of the 291 landing trace reports, 5 were in Missouri.

# "Silver Needles" Fall from UFO The Advance of the A

Mention of UFOs is apt to pop anywhere these days. In the February issue of "Industry Week, "this appeared in an article on hobbies:

Chester Cain has a story: "There was this circular patch, a burned out area in a Michigan-farmer's field which had been discovered two days after the owner had sighted a strange object in the sky over his house. The patch was filled with silvery colored needles looking some thing like a silver mat. Nobody could identify them. Eventually, I got hold of some of the stuff and had Argonne National Laboratories, Chicago analyze it. It turned out to be aluminum with a high lead content. None of the aluminum companies had ever heard of anything like it. A cross section under a microscope showed that the 5/8 in. long needles were made like microscopic sized angles. The farmer also reported later that he harvested a bumper crop of soybeans that grew on the 'burned area. "

"I simply cannot agree with those self-styled psychologists who explain away unusual observations as illusions born of personal insecurity when they haven't even bothered to check the basis for the reports," Dr. Utke states.

He has talked to many (whole families in some cases) who have claim ed to see UFOs and some accounts involved objects seen up close, on or near the ground. Dr. Utke says he is convinced that the vast majority of these apparently intelligent, stable people were not lying, over-exaggerating, insecure, or seeing "spots" in front of their eyes. They gave an honest account of an unusual experience and in some cases, he was able to explain what they had seem. He feeds that if more scientists would interview UFO observers themselves, their perspective would change

Dr. Utke says he also does not agree with schentists who admit UFOs "may exist" but do not warrant looking into. "Can science afford to overlook a global phenomenon, that has been seen by thousands of people and seems to be increasing in scope?" he asks. "If UFOs exist, they are important no matter what they turn out to be. Suppose they were some sort of new natural phenomena. They d almost have to be electrical in nature. Finding out how an electrified object with no visible source of energy can move through the atmosphere for sustained perods of time could be extremely valuable. Suppose UFOs were extra-terrestrial, this would be the greatst discovery of; all time. Or suppose UFOs really are only psychological in origin and do only exist in the mind. The phenomenon is still well worth studying, especially those cases involving simultaneous and yet independent witnesses. Proving that thought transfer or ESP exists might almost be as spectacular as proving that UFOs exist."

A few scientists have claimed that the UFO phenomenon would simply be too hard to study. You can't find thesevobjects, they say, because they are so unpredictable, if they do exist; and there are no patterns in the sightings. Some scientists claim that studying UFOs would require too much money and too much valuable time that would be better spent on more to worthy projects. Dr. Utke answers this by saying, "This argument is relative and depends upon the definitions of too much money, too much time, and more worthy projects. Admittedly, it might be quite costly and time consuming to actually determine what UFOs are But that's one step ahead in the argument. We should first of all actually prove that they exist. Localized teams of scientists, equipped with inexpensive, portable cameras, magnetometers, spectroscopes, and radiation detection devices, and only working part time; could probably conclusively determine whether UFOs actually exist or not in two or three years. And even if a computerized central study headquarters was added, staffed by full-time scientists, to study the data obtained; the cost of the whole project shouldn't exceed two or three million dollars a year. There are probably enough scientists interested in UEOs right now to staff such a project. Can we afford the money involved?

Dr. Utke thinks we can. He points but that billions of dollars. are wasted by the government on duplication and useless research; millions\_are\_spent\_on military weapons\_which\_are obsolete = Before they are built and gives tother examples. If the answer is still mo, then he suggests that a few thousand collars a year appropriated by the National Science Fountation to establish prizes to be awarded each year to the best essay or research paper on UFOs (pro or con) could stimulate

further research.
"How do we get off the UFO merry-go-round?" Dr. Utke asks. Only two ways seem possible. Number one-the sightings would have to cease. But UFOs seem to be rather stubborn, he reminds us, and they haven't disappeared just because some scientists don't believe in them. So that leaves the second possibility—a scientific "change of heart." The scientific community will have to change a few of its attitudes, roll

up its sleeves, and go to work on the problem.
"In order to solve the UFO problem," Dr. Utke says, "scientists are going to have to help try to find the 'scientific proof' of the existence of UFOs. Proving conclusively, one way or the other, whether UFOs

exist should be worth the effort.

"Isn't it our duty as scientists to find this out?"

Dr. Utke believes it is.

"It occurred in September, 1939, the eve of World War II. I was living on a farm, two miles outside the small town of Skerries  $\sqrt{N}$ .  $Z_{\bullet}7$ , on the East Coast. It was a calm evening, visibility was unlimited. I remember my father calling me outside and exclaiming: What on earth is that? Looking out to sea, and some half-mile to one side of the islands I could see this circular, orange-coloured globe hovering and then moving slowly, southwards. It travelled in a sort of slow, bounding fashion, just like a ball in slow motion, then it would come back to its original position. I would say; and this is only an approx. measurement, that its size was about 150 feet in diameter. There were many adult witnesses to this sighting, all of whom were baffled by the startling appearance of the object; at the least, one would say it was weird both in appearance and behaviour. We watched for over half an hour, then grew tired, as it kept patrolling up and down a five-mile stretch most of the time. Before we went to sleep that night, we went outside to see if it were there, but it had gone. Next day war was declared between Britain and Germany. It was not until Flying Saucers made news again in 1947 that I began to compare sightings with mine of 1939 and found many 'orange-coloured globes' or saucers that seemed very similar."

Because of Jonssons psychic talents, the villagers were spared further maniacal savagery, but to Jonsson, a sick man had been needlessly destroyed, and he vowed never again to become involved in solving crimes of violence.

The NATIONAL TATTLER is still running its UFO series and will continue to do so through at least the May 23rd issues perhaps longer. Even if most of the material is familiar to SKYLOCK readers, it is good to see a nationally-distributed weekly publication devoting this amount of space to the UFO subject. And their presentation of UFO material has been fairly "straight" thus far.

Want a few good laughs? If you do, see the May 31st issue of another weekly tabloid, NATIONAL CLOSE-UP. UFOs are living creatures who breed in our pollution-choked atmosphere, according to this bit of drivel. Not that are totally averse to the "UFOs as living creatures" idea--at least not in a small minority of cases. But the CLOSE-UP report is a good example of the type of sensationalistic nonsense which crops up far too often.

In last month's issue of SKYLOOK, we reported that Dr. J. Allen Hynek's UFO book would be published in August of this year. We have now learned that the publication date has been set forward into early 1972. Any later details will be presented in future columns.

RIAN REVELATIONS, edited by Brad Steiger (Dell Books, 75¢). Although dealing primarily with the experiences of a Canadian contactee (contact ess?), the book also presents other material in a similar vein from other sources. Steiger declines to accept the claimed "outer space" origin for the contactee messages, but he does not doubt that messages are being received from some "outside" source. While the contactee field definitely has its con-men and glory -seekers, it also consists of honest, sincere people who believe wholeheartedly in the reality of all-wise and benevolent "space people." Whether or not that belief is justified is the \$64,000 question. "If you wish to go "inside" the contact stories, THE AQUARIAN REVELATIONS is definitely recommended.

Clippings from the 1897 "Houston Daily Post" Childress, Texas, April 17 -- The much talked - of airship was seen here last night about 1:16 o'clock. The Rev. J. W. Smith was the first to discover the curious aerial monster.

He thought at first that it was a star shooting, but after watching it a moment or two, saw that it was not. It seen disappeared; travel-ing in a westerly direction. The Rev. Smith thinks that it must have been 2,000 feet high and traveling very fast,

Longview, Tex., April 20-Last night about 9:30, the Post correspondent and family, on returning from church, saw the so-called airship. A bright light, seemingly about the size of Venus, moved swiftly to the northwest, disappearing beneath the horizon.

In a few minutes, it reappeared. . The light emitted a series of intermittent flashes of a steel color. No car (cabin) was seen.

Atlanta, Tex., April 19--There was considerable excitement here today; caused by a visitation last night by the mysterious airship.

It was first seen by Jim Nelson, a farmer. . His attention was attracted by a peculiar noise and, looking up, he discovered the mysterious aerial traveler.

It seemed to be descending straight to the earth with great rapidity and Mr. Nelson's hair stood out with fright.

April 19, 1897 "Dallas Morning News": Aurora, Wise County, April 17-About 6 o'clock this morning the early risers of Aurora were estonished at the sudden appearance of the airship which has been sailing throughout the country. It sailed directly over the public square, and when it reached the north part of town, collided with the tower of Judge Proctor's windmill and went to pieces with a terrific explosion, scattering debris over several acres of ground, wrecking the windmill and water tank and destroying the judge's flower garden.

The pilot of the ship is supposed to have been the only one aboard and while his remains are badly disfigured, enough of the original has been picked up to show that he was not an inhabitant of this world.

Mr. T. J. Weems, the U.S. Signal Service officer at this place and an authority on astronomy, gives it as his opinion that he (the pilot) was a native of the Planet Mars.

Papers found. . are written in some unknown hieroglyphics. . This ship was too badly wrecked to form any conclusion as to its construction or motive power.

The town is full of people today who are viewing the wreck and gathering specimens of a strange metal from the debris. The pilot's funeral

will take place at noon tomorrow.

"Houston Daily Post", April 28. Merkel, Tex., April 26 -- Some parties returning from church last night noticed a heavy object dragging along with a rope attached.

They followed it until in crossing the railroad it caught on a rail. On looking up they saw what they supposed was the airship. It was not

near enough to get an idea of the dimensions.

The Constellations. No. 7 Bootes - The Constellations - No. 7 Bootes

The word Bootes in Greek means a "Herdsman." Bootes is one of the oldest constellations and is mentioned in the Odyssey. Bootes is generally represented by the figure of a man holding a spear in one hand. In his other hand is a leash to which are fastened two dogs, that figure in a neighboring constallation, Canes Venatice, "The Hunting Dogs." In Bootes, as in many constellations, the shape outlined by the brighter stars is that of a kite. Arcturus is the brightest star in this constallation and is ranked fourth brightest of all the stars. Arcturus is a normal giant with a diameter of 30 times the diameter of the Sun. It is 37 light years distant. With modern infra red recording devices, the heat received from the star Arcturus can be measured and is found to be equal the heat of a single candle at a distance of 5 miles. Arcturus is often called the "Star of Job" because it is mentioned in the boo, of Job. The four stars Mu, Delta, Gamma and Beta form a slightly cockeyed rectangle that the Arabs used to call. Mars Has Big Core--More Like Earth

New evidence indicates that the planet Mars has a large core--perhaps 1,000 miles in diameter -- and is therefore more like the earth than previously believed, a California Institute of Technology scientist reported at a recent meeting of the American Geophysical Union.

The matter is of great interest because it could help determine how the Solar System was formed. If it is conceded the planet, like the earth has a core, the next question is whether it contains sulfur or silicon. If it is sulfur, it would indicate the planet -- and by inference the Solar System -- formed slowly and that Mars was initially a cold body. But if it is silicon, it would mean the temperatures attending Mars! birth were extremely high and that the planet solidified quite to

rapidly.
Until now it has been widely believed that Mars was too small for a molten core to have formed as the planet solidified from a cloud of the swirling gas at the dawn of the Solar System.

almost identical to this story.

It was on the evening of June 5, 1969, at 5:55 pm. A green light was observed flashing across the sky from east to west about 30 degrees up from the southern horizon. It was in view for about eight to ten seconds until it disappeared into the west like a bright star." It was a perfectly clear day, the temperature was near 80 degrees, and it traveled a perfect horizontal line. As it passed this area (Peoria, Ill.), four smaller objects shot out from it. One was a little larger than the other three and they were white, shaped like a long team drop, and they paced the large green light for maybe four or five seconds, then just disappeared. SKYLOOK carried a story given by a man as far west as Denver, Colorado. This coincides with my sighting.
The time of his sighting was about two or three minutes later than

mine, the altitude was about the same, 30 degrees, green in color and traveling east to west. After speaking to Walt Andrus about the topic, I learned that some people in Quincy had seen it also. The explanation of this also said to be "probably a meteor." To me it was a UFO, because of the green color of the object. In the 35 years I've been observing the skies, I have seen a number of meteors. But none of them h
