#### Oops! Rugs??! Response

In the May issue Terrence Rhore questioned a caption for a postcard in the January issue identifying a machine gun on a Harley Davidson motorcycle as a 1917 Marlin.

Oops! Could be he's right. Our research had indicated that, the Benet Mercie was issued through 1960 but the Army did not purchase Harley Davidson motorcycles until 1917, and at least some of these were equipped with Marlin machine guns. We also found a photograph of a 1917 Marlin that closely resembles the one on the postcard. After receiving your letter, however, we looked further, and found a picture of a Harley clearly armed with a Benet Mercie. If we were mistaken we apologize. The good news is we uncovered a wealth of great photos of machine gun equipped motorcycles, and if possible will reprint them in a future issue of MGN.

#### **Needs Accurate Statistics**

First let me say that MGN is my favorite read every month. I especially liked "A New Understanding" by Paul Craven (Feb. 92 issue) for its honest stereotype busting. As an academic I always enjoy the opportunity to bust stereotypes, when the derisive question comes up in my company "What kinda person would own a machine gun?" and I can reply, "You can start with me, friend!" "Well, OK," comes the feinting response, "you're an odd-ball professor. But what OTHER kinda people would wanna mess with mean machines of mayhem?" I then quote a New York Times report on the Texas Hill Country shoot two years ago: "The most decent damn people you'd ever want to meet!"

But I have a question that need clarification, on a tactic we want to be careful about, citing stats: Mr. Craven reports that "in the last ten years (only) 1/5000th of 1 % of the officers killed in the line of duty were killed by automatic weapons."

Now, the point is that hardly any officers are killed by full-auto weapons (and, even more relevantly, I believe, probably none by legally owned MG's), contrary to what Hollywood, TV and hoplophobic gun grabbers would have us believe. But we've got to be careful here: a slip of the decimal point is the kind of ammo the pointy heads will use to shoot down our credibility and obscure the truth. We need sure-fire ammo on our side.

The "1/5000th of 1%" (.000002) figure just can't be correct: By this figure, in order for only one officer to have been killed by an MG in the last ten years, the total death toll among police officers would have to be 500,000. Now we know that, according to the FBI, as of 1989, only one officer in the previous decade had been killed by a fullauto UZI (in Puerto Rico). I don't happen to know how many others have been killed by any other type of MG, if any. We can be sure that the number is very small, if not zero. WE can also be sure that the number of officers killed by legally owned MG's in the last 55 years is tiny, if not zero. But we need to be armed with precise figures if we are going to fight hysteria with numbers.

Can MGN find and publish the actual stats on officer deaths by MG for our information armory?

Editor's Note: The 1/5000th figure was taken from another magazine. We found they had made a mistake. They told us the figure should have been 1/50th. The figure quoted was for assault rifles. Unfortunately the Uniform Crime Reports "Law Enforce-

ment Officers Killed and Assaulted" put of by the Justice Dept. does not break the figures down by type of weapon other than handgun, rifle, shotgun, knife, and personal weapons. It then breaks it down by caliber so we're assuming the magazine came up with a guestimate on the assault rifle figure from the caliber used. We are reprinting those charts for your information.

You are correct about the fact that the number of officers killed by a legally registered m.g. would have to be one or zero. We have not been able to confirm the death in Puerto Rico. Readers???

# Raffica

have had numerous calls from the Rafficarians out there complaining about "M-60 thumb" from linking ammo, and many other problems that are inherent with prepping up for a shoot. I met Lloyd Hahn at Knob Creek in Oct '91, and was dually impressed with his products for easing the pain of loading, and speeding the process. He's the guy who advertises in MGN for M-60 belt linkers, and the company name is Hahn Machine Co. in St. Charles, MO. (314-946-9567). I want to throw him a serious plug here, his products are neat and worth having. The belt linkers are made for the different model guns, from the M-60 to the Minimi to the Browning, to H&K, by caliber- 30-06, .308, .223, .50 cal, etc. They are a tray type loader, where you lay the links in the grooves and the ammo after, then press a handle which slides the rounds into the links. Slick, fast, and painless, Lloyd makes a loader for any gun that uses a disintigrating link belt. He has two size loaders, that load from 18 rounds of 30-06 to 40 rounds of .223, and vary in price from \$125 to \$250. He offers trays made out of white aircraft nylon, solid aluminum, and solid naval bronze. One other thing- he has a hopper for the 1919A4 belt loader! It holds 100 rounds, has spacers for 30-06, .308 and 8mm, and lets one person dump boxes of ammo in while the other person cranks it. The hoppers are priced at \$35 each and fit into your belt loader. Try some of Lloyd's stuff, guys, I'm hooked on it!

WARNING: The following information was transcribed at the direction of the criminal investigation division (CID) from a message received from the Air Force Office of Special Investigation (OSI) Bowling

AFB, Washington D.C.

1. Information was received from ATF, Houston, Texas that AK-47 rifles recovered in the Middle East had been booby trapped by hollowing out the buttstock and installing an explosive charge and detonator. Apparently the detonator is designed to initiate the explosive charge as the weapon recoils when fired. Additionally only AK-47's with a fixed buttstock have been encountered with the booby trap device.

2. Information to date indicates the booby trap device are very simple and do not appear to contain any anti-tampering device. Law enforcement personnel should be advised that any AK-47 with wood but-

tstock which may have come from the Middle East should not be fired. If a suspected rifle is recovered, arrangements should be made with an EOD facility or Law Enforcement Bomb Squad to x-ray the stock of the suspected rifle. The local ATF office should also be notified. Important info there for the guys doing shows and business near military bases - watch anything that came back from Desert Storm!

Q I am interested in purchasing good quality audio recordings of different makers of automatic weapons as they are firing. Are you aware of anyone who retails such recordings? Appreciating your assistance, I am.

A Because of the self protecting circuits in most sound equipment, all shots tend to sound the same. I have never considered that someone would want the actual decibel differences in automatic weapons other than silencers for comparison, but even those tend to sound the same on tape. You could certainly compare rates of fire, however. Most of the tapes made by the Knob Creek Range have examples of individual guns firing 502-922-4457, as does the Dillon tape that was reviewed in MGN Vol. 5 #7. If anyone out there is selling a product like this, let Raffica know and we'll pass it on.

Q This is not a machine gun question, its an ammo question. I have some CBC 7.62 NATO ball ammo that was sold through Atlanta Discount Ammo. Enclosed is a copy of the warning recently issued by "Companhia Brasileria de Cartuchos" stating that the ammo is unstable, and that pressures can exceed 135,000 CUP. I have contacted both ADA and CBC. ADA said to call CBC. CBC had a recorded message.

Okay, so I have mass quantities of this ammo that I can't use, that I paid good money for. Since it happens that CBC never authorized sale of this ammo to the U.S. civilian market, it is logical that responsibility falls on ADA. In turn, it would seem that ADA is ethically, if not legally bound, to provide a refund or a reasonable replacement product.

I am obviously a free-thinking freedom loving American, or I wouldn't read this magazine. I don't want the shooting sport bogged down with legal issues, but I don't want to get stuck with a bunch of bad ammo

either. As a veteran shooter who is respected in the industry, what advice do you offer?

A Thank you for the compliment, and let me tell you that I am in the same boat you are in. I bought 50,000 rounds of this ammo for the North Country Shoot last summer, and we shot almost all of it there, between the guys who bought it and my own insane crew. Not one problem. That doesn't mean there won't be any, most of the guns that have had a problem were totally destroyed. Big danger. It is the 1975 CBC 7.62x51mm that is said to have the problem, but problems occured with 1977 also. One serious point - it is the opinion of many Reasonably Knowledgeable Individuals that it is physically impossible to achieve a pressure in excess of 130,000 CUP, using the same rifle powder as this ammunition was loaded with. Makes you wonder. The CBC hotline, 1-800-742-1094, takes your name and number to contact you about the ammo. I still have not received a call back, and will update you guys when I do. The CBC safety warning also advises again the use of any CBC 7.62x51mm that has the word "Reengastada" stamped on the box. CBC says that this was not stamped at the factory, and they have no idea why it is on there. We're just going to have to wait this one out, guys.

Q A friend recently loaned me a copy of MGN and I read it with relish. Living in New York State, we can only read about everyone else's fun or pretend, with our semi-autos.

I would like to question your statement in the April '92 issue on pg. 41, wherein you pointed out that a "Lightning Link" will allow select fire from an AR-15. I believe you intended to relate that a "drop in" auto sear would allow select fire but the "Lightning Link" or "auto connector" (such as manufactured by RPB then SWD) would allow full auto capability. Correct?

Perhaps I am mistaken, but I was of the opinion that the "lightning link" was the homemade version of the SWD "Auto connector", usually having a solid center of the trip portion as opposed to the split RPD/SWD design. If this is not true, could you please advise how the Lightning Lifunctions in allowing select fire?

A The terminology here is different with each person you talk to. To me, as an RKI, I call the SWD drop-in unit an "auto-connector", or "drop-in sear". The "Lightning Link" is a unit that mounts to the upper ecciver, simulates the position of the real auto sear, and interacts with the selector to achieve select fire. (Some dropped in the lower). There are many variations to these two, but you get the basic idea. I have heard the SWD unit called a Lightning Link, and those "Hellfire" units called Lightning Links also. The point is to make sure that you are talking with the person you buy one from, so that you know what you are doing.

I would like to take a moment to warn again, that the pre-Nov '81 drop in sears you see advertised are not a registered machine gun conversion, it is just that they are legal to own. They are not legal to own if you have an AR-15, and certainly not legal to put in one. If you purchased one believing that you could put it in an AR-15, you have been misled. Is this a big deal? Do the words "instant felony conviction" mean anything? Does "ruining your life and not ever being able to own firearms again" mean anything? Don't play with BATF, they can mess up your life enough without you helping by doing something stupid like owning one of these.

Q#1 Re: The question concerning the Vortex flash suppressor/muzzle brake: The Vortex design is not a muzzle brake but, a four prong flash suppressor only. In the latter function, it is superlative. The originals are made by Smith Enterprise in Mesa, Arizona.

Recently, SGW/Olympic Arms has introduced a design very similar in appearance. I have not actually tried one of these. The newer design does have a very nifty feature: A groove cut around the forward areas of the prongs into which a snap ring or wire may be inserted. This keeps the prongs from functioning as a salad fork when you are sneaking through the bush.

Please don't ever let this column die. The guy who wanted to know about Vortex may be the one who has the piece of information I may need the next time.

#2This is in response to the question about Vortex flash suppressors. I've included a copy of a review from SWAT magazine that featured this excellent item. It's four pronged, and I have one on my 14.5 barrel AR15 (as the Vortex is 1.5" long, with a little solder this works well to satisfy the ATF 16" barrel minimum. The ash is almost invisible and the accuracy is very good. The only drawback is the same tactical carry problem the original M16 3 prong suppressor had. This is probably

much less of an issue in the desert than it was in the viny jungle of S.E. Asia.

I'd like to know if anyone knows about the hydraulic buffer in the latest Colt M-16 light machine guns. What are these buffers, and are they available on the open market? My main interest is not in showing the rate of fire, but getting rid of the annoying "spring ring" you hear through the stock of the M-16, it gets old after awhile.

# Scattered Shots

ave you been following the case of NRA member Johnnie Lawmaster, the Tulsa, Oklahoma, man who returned home to find that ATF had come to call?

BATF agents, acting on an alleged tip that he had an unregistered auto-sear for his AR15, "served" a search warrant by battering open both doors to his home while he was away, cutting the locks from his safe, scattering guns, ammo and personal effects around, breaking furniture, and generally turning the place upside down. According to neighbors, some 60 officers participated in the raid. Then they withdrew, leaving Lawmaster's wide-open dwelling and his firearms protected only by a note that read, "Nothing found - ATF."

When the out-of-work Lawmaster called the local office to see who was going to repair the damage, he was curtly informed that, if he wanted it fixed, quote, "you're gonna have to pay for it yourself."

This smacks of the same arrogance and abuse of authority that some individuals within BATF demonstrated during the Jimmy Carter years, earning themselves the nickname, "The KGBATF." Back then, it took Ronald Reagan, a Congressional investigation and a thorough reshuffling of the agency to make the Gun Gestapo pull in its horns.

As with all good bureaucrats, though, they didn't go away; they just entered a stage of dormancy, and like Death Valley mosquitos after a rain shower, began wiggling to life when George Bush indicated he could be had.

ast month, we lauded the efforts of Mike Dillon to boost NRA membership.

No less deserving of praise is a fundraising drive kicked off in January by Midway Arms President Larry Potterfield. Dubbed the "NRA Round-Up", the project has already raised thousands of dollars for the NRA's Institute for Legislative Action.

It works like this: when you place a phone order for loading or shooting supplies, the Midway operator asks if you would like to "round up" the amount of your order to the next highest dollar figure (you can add more if you like). If the answer is "no", just say so. You can likewise indicate your wishes when you order by mail. Often the amount involved is only pennies, but it adds up: as of this writing (early April), Midway has "rounded up" over \$41,000, with 82 percent of their customers contributing. The non-deductible contributions are sent to ILA weekly, and a running total is printed on each statement the company sends out.

Above this, Larry has vowed to toss in \$1,000 a month of his own money.

Imagine what a program like this could do if spread industry-wide ... it would add millions a year to the badly-strapped ILA warchest, and no one would even feel the pinch!





#### **NEW RIFLE ACCURIZER FROM MWG**

Accuracy. It's the goal of any shooter. How to achieve it is yet another story. MWG Company, Inc., now has that story. The Accurizer. Developed by Mickey Finn, known for his silencer developments, the Buckmaster survival knife, the Titanium folding knife and the U.S. Army M9 bayonet, the Accurizer is, according to Finn "a unique piece of equipment that allows the user to attain the ultimate accuracy from his rifle utilising a broader range of ammunition than is normally possible." With the Accurizer, even less expensive ammunition, such as government ball ammo can be utilised with uncommon accuracy." Engineered to fit AR-15, M-16 and HK-91 rifles (with plans already under way for many other rifle types in the near future), the new Accurizer is aptly named. Installed over the barrel of these rifles, it reduces vibration, thereby ensuring greater accuracy. In effect, it converts an A1 M-16 to H-BAR accuracy and it will even tighten groups shot with the H-BAR. Easy to install in a few simple steps, the MWG Accurizer Kit is complete with the Accurizer, a retaining ring and custom made 1/4"

socket. Not included is a 1\4" torque wrench (or 3\8" torque wrench adapter) that features inch pound measurements (this handy device is also marketed by MWG). With the flash suppressor and washer removed from the rifle, the retaining ring is slipped over the barrel and snugged against the notched collar of the bayonet lug. The Accurizer follows and is screwed on finger tight. The MWG torque wrench is then utilised to slowly tighten the accurizer until a "click" is heard. At this point, the firing of a test group will determine the accuracy. An increase of torque in 5 inch pound increments (with testing after each increase) will result in optimum torque. With optimum torque achieved, the Accurizer is intended to be permanently installed, Lock-Tite can be applied. A result of MWG's constant search for innovative technology, the Accurizer, in the words of MWG President, Ned Scheer, "The Accurizer works...it's simply amazing!" The new device is now being tested by the Canadian Army as well as American Special Forces and the F.B.I.. The Accurizer will retail for \$59.95 and the MWG torque wrench will sell for \$74.95. 

# The ZB 47 Submachine Gun A Unique Solution




[Jiri Fencl, an engineer, lives in Czechoslovakia and has written extensively in that country about Eastern Bloc weapons, some of which, like the Czech ZB 47, are virtually unknown in the West.]


The ZB 47 submachine gun was the work of Czechoslovakia's most famous pre-war designer of automatic infantry weapons, State Prize Laureate Vaclav Holek (born: 1886 - died: 1954).

In designing the ZB 47, Holek undertook to systematically overcome some of the shortcomings of submachine guns then in use by the Czechs, as well as those of other countries that had been picked up on battlefields during World War II. The result of his work was a unique weapon that possessed many original features.

Holek felt that the typical submachine gun of the period possessed a center of gravity that was located too far to the front, and deviated too greatly from the axis of the barrel. Also, as the weapon was fired and the weight of the magazine decreased, the center of gravity would shift from front to rear, detracting from the guns overall operation and decreasing its stability and accuracy, particularly when fired in the fully

automatic mode at longer distances. This has been shown to increase fatigue in the shooter.

In most of these weapons, there also existed the possibility of an unintentional shot being fired when the butt was struck, if the cocking lever was snagged on clothing or equipment, or while the weapon was being dismantled for cleaning.

Vaclav Holek therefore set about designing a submachine gun that would fulfill the following requirements:

- deliver maximum firepower
- allow for maximum concealment of the shooter
- be free from snags and protrusions that might eatch on brush or other obstructions
- provide security against accidental discharge
- give maximum reliability

The ZB 47 (Holek System) submachine gun is a fully automatic weapon based on the unlocked blowback, or dynamic breech, recoil principle. Its most characteristic feature is the location of its double-row, ultra large capacity box magazine, which holds 72 9mm Parabellum cartridge. This magazine, rather than extending beneath the weapon in conventional perpendicular fashion, lies lengthwise along

the lower edge of the receiver just beneath the trigger guard/rear grip portion, with the bullet end of the cartridges facing upward.


Cartridges are stripped from e magazine and pushed up along a curved path and into the chamber by means of a revolving ratchet wheel feed system. (This system will be described in greater detail later in the article.)

Resembling a narrow wedge, the ZB 47 has a smooth and simple profile that offers several advantages. It is virtually snag-free, and allows a

shooter firing from the prone position to maintain an extremely low silhouette. It can be carried holstered with a loaded magazine inserted, ready for action at a moments notice. The center of gravity has been shifted as close to the barrel's axis and as near to the shooter's shoulder as possible. eliminating much of the barrel rise normally associated with full-auto fire; this has a positive effect on accuracy, especially at greater distances. Also, because of the nearly horizontal positioning of the magazine, there is very little change in the

weapon's balance as the magazine empties.

Sufficient space is provided in the "belly" of the lower receiver to accommodate a magazine long and wide enough to contain seventy two rounds - a capacity unprecedented in a box magazine. Although the magazine follower is advanced in the conventional manner through use of a coiled spring, the key to its ability to feed such a heavy load of cartridges lies in the fact that it is, in effect, recoil assisted. As the weapon jerks rearward at the moment of firing,





inertia forces the double row of cartridges forward toward the feed lips. The advantages of the in-line magazine system, however, are offset somewhat by the necessity for a more complicated feed mechanism, which, due to its complexity, can lead to occasional failures.

The magazines, which are equipped with indicators showing how many cartridges remain, can be loaded by hand,

or through use of stripper clips and a simple filling device. A light canvas pouch is provided to hold a second magazine, the magazine filler and a cleaning


Holek embodied his gun with numerous safety features. A manual safety catch, which locks the breech block in either the open or closed position, is designed so that it cannot be accidently disengaged, even if the weapon is dropped.

The most common causes of unintentional discharge in open bolt submachine guns of this era were a sharp blow to the butt or the cocking handle catching on an obstruction, either of which could carry the bolt just far enough rearward to allow it to chamber a round when returning to (continues)

This is insured against by the very design of the ZB 47's feed system: unless the breech block is drawn fully to the rear at which point it is held safely in engagement by the sear - it is impossible for the weapon to feed and fire a cartridge. Should, for some reason, the breech block slip the primary sear without the trigger being depressed, a safety sear will grab it and prevent its forward movement.

The submachine gun's mechanism is also secured against an accidental shot during disassembly, as the action cannot be opened unless the magazine is first removed.

The heart of the ZB 47's unusual feed system is a set of two ratchet wheels, each with four sets of teeth, that are positioned in the lower receiver, and rotate around the same eccentric shaft that serves as a hinge pin for the upper and lower halves of the firearm (see diagrams previous page).

When the trigger is pulled and the breech block begins moving toward the chamber, a pivoting rod (called a "repeating lever") that extends forward from the left side of the breech block engages one of the teeth in the smaller ratchet wheel, and rotates it by one pitch before disengaging. The larger wheel, meanwhile, also advances, one of its teeth mating with the rear of the cartridge residing in the magazine's feed lips and transporting the cartridge up and into the chamber. As the breech block closes, the weapon fires, and recoil again drives the breech block to the rear, extracting and ejecting the empty cartridge case. The firing sequence continues until the trigger is released.

To hold the weapon when firing, the thumb of the right hand goes through the large hole at the rear of the receiver, the index finger fits into the smaller hole (trigger guard), and the remainder of the fingers wrap around the lower portion of the receiver that houses the magazine. The left hand grips the perforated heat guard surrounding the barrel.

The ZB 47 is robustly made, employing the most modern methods and technology that were available at the time; more than half of the weapon's 24 parts are made of stamped steel. These parts make up 6 basic sub groups which should not be further dismantled.

Disassembly is as follows: push forward on the hooked magazine catch located on the right side of the lower receiver beneath the cocking handle and the magazine will fall free; depress a catch at the rear of the receiver, allowing the upper receiver to pivot forward on the hinge pin, and it is then possible to remove the return spring, the breech block/repeating lever assembly and the barrel; remove the eccentric hinge pin, separating the upper and lower receivers, and the ratchet wheels located in the lower can be disengaged from their retaining spring and lifted clear. The weapon is n ready for cleaning and oiling. To reassemble, reverse the procedure.

The gun was made in two configurations. The lengthier of the two was fitted with a fixed wooden stock, and this was the version that was designed to accommodate the long, 72 round magazine. A second design featured a telescoping stock constructed of stamped steel; a special shortened magazine, holding 36 rounds, was issued with this weapon, but the longer magazine could be inserted when the stock was extended.

Although the ZB 47, like any other submachine gun, is intended for close combat, it was found to be reasonably accurate at distances as great as 300 meters, allowing for the proper holdover. During testing on single fire at 100 meters, ten of eleven shots were held within an 8" X 8" square, and, when firing short bursts, 30 shots stayed inside a 12" square. Bullets retained enough energy at that distance to penetrate 6.2 oneinch spruce boards.

In the middle part of 1947, the Militan Technical Institute decided to test the ZB 47 in units of the Czechoslovak People's Army. Twenty of the submachine guns were produced at the Zbrojovka Brno (hence "ZB") plant. Before their issue, however, the general staff decided that submachine guns to be tested should be chambered for the 7.62mm Tokarev cartridge, as part of the equipment unification plan. This delayed the testing until April, 1948. Results of these tests were generally favorable, and several Czechoslovak army units requested that the ZB 47 be made standard army issue. This was not to be, however. The official decision was that it was too heavy, and that it contained too many parts. It was, therefore, passed over in favor of lighter, simpler designs, notably Holek's Models 23 and 25, which were issued in large numbers, and served as inspiration for the famous Israeli UZI.

In the end, Vaclav Holek's innovative ZB 47 submachine gun was destined to be come simply another footnote Czechoslovakia illustrious history of weapons design. MGN


# The Blaylock AP-9 Suppressor

Suppressor design has evolved at least ten-fold in the past few years. With the Machine Gun Ban of '86, Class II manufacturers all over the country have turned their talents in the direction of suppressors. This has brought about an astounding array of new devices designed to quiet the noise produced when a cartridge is detonated in a firearm.

With that many people honing their skills on the above mentioned problem, suppressors are bound to become smaller, quieter and easier to attach to the host firearm. Several years ago I met a man from Texas who was then building some of the best suppressors that I had ever seen and "not" heard. The man also did full-auto conversions but his suppressors were what I was really attracted to.

The man's name is Dale Blaylock and along with his wife Connie, he owns and operates Blaylock's Gun Works in Gun Barrel City, Texas. Yes, there really is a city called Gun Barrel City and if I were involved in building firearms or accessories I would want to live in a city with a name like this. Dale has been building suppressors for more years than a lot of Class II manufacturers have been in business. This experience has led to the design of what I consider to be some of the best suppressors in the business. His "cans", if you prefer to call them that, don't look like anything special on the outside. They're made of metal and come in one color, basic black. (They



are available in stainless if you have a preference for such.) Dale's suppressors are well built, will probably last longer than the firearm they're made for and they work very, very well.

I have recently had the opportunity to test one of his newest designs; the AP-9. This suppressor is made for 9mm weapons of the full-auto type. In other words submachine guns. The AP-9 uses a steel tube with various steel and aluminum internals. The suppressor is built to be user serviceable and can be completely disassembled. These suppressors are not difficult to take

apart and put back together and any with an I.Q. above 50 should have no problem doing so. For those that are not mechanically inclined (too lazy), the entire suppressor can be soaked in solvent without taking it apart. Dale recommends that his handgun caliber suppressors be cleaned every 1500 to 2000 rounds depending upon the ammunition used. If you happen to use any corrosive ammo the suppressor should be cleaned as soon as you are finished shooting. In other words, suppressors and corrosive ammo do not mix.



The suppressor uses the SCRC three-lug coupling which allows a very precise lock-up of suppressor to barrel. The coupling is quick detachable and allows the user to go from a suppressed to an "unsuppressed" weapon in seconds.

The AP-9 suppressor that I tested has a threaded interchangeable back cap that allows it to be attached to a variety of weapons. Most of my testing was done with the AP-9 attached to an MP-5. The suppressor that Dale sent me for testing was quipped with the patented SCRC three-lug muzzle coupling. This coupling allows the suppressor to be used on any MP-5 variant with a three-lug barrel. To attach the suppressor, you simply loosen the three-lug "nut" on the back cap, slide the suppressor over the lugs, turn the nut approximately one third of a turn till it engages the lugs and then tighten the suppressor back against the lugs. The AP-9 can be installed and taken off of the host gun very quickly. This style back cap allows a much more precise lockup of suppressor to gun than the H&K style three-lug locking mechanism. It also keeps the center line of the suppressor concentric with the weapons bore. This allows much better accuracy than with other types of attachments.

The AP-9 suppressor was also tested on a closed-bolt Mini-Uzi and a Mac-10. The Mini-Uzi back cap is basically a copy of the Uzi barrel nut. It has teeth on the back edge that engages the ratchet lock on the Uzi to keep the suppressor from coming loose.

Dale also supplied me with his special "extended" MP-5 backcap. This cap has a slightly longer neck and positions the suppressor farther forward so that it can be used with the excellent Tactical Light Forearm made by Laser Products. These are just some of the back caps that are available and caps can be custom made to fit virtually any 9mm weapon.

When H&K introduced their MP-5 SD it took the tactical and clandestine military world by storm. Elite military units and SWAT teams all over the world immediately armed themselves with this integrally suppressed wonder. They could have MP-5 reliability and accuracy and still have the capability of a suppressed weapon for those "special" times.

Years later, as these weapons have had their "trials by fire", it has been noted that sometimes subsonic bullets fired from SD's don't penetrate as well as needed. While some say that these are just rumors. I have it from "the horses mouth" that on at least two occasions 147 grain subsonic ammo failed to penetrate heavy clothing reliably. The recipients received only minor flesh wounds and were still able to return fire. I had my first hands on experience last year when we had one competitor in the

Colorado Subgun Shoot shooting an SD and his bullets were bouncing off bowling pins instead of penetrating them.

While most subsonic ammo has a muzzle velocity around the 1000 to 1100 f.p.s. range, when it is fired through a ported barrel weapon such as the MP-5 SD the velocity is bled off to around the 700 to 800 range. Hey folks, this is getting down to pellet gun velocities. This is the main reason that some agencies are switching to MP-5 muzzle mounted suppressors instead of the integral units. Muzzle mounted suppressors keep the 9mm round at higher velocities for deeper bullet penetration. Yes, higher velocities does mean more noise but when the maximum suppression is needed you can use subsonic ammo and still have use of its 1000 to 1100 f.p.s. velocities.

The AP-9 suppressor was tested against an MP-5 SD for noise comparison. In all tests, the muzzle mounted AP-9 performed as well or better than the SD with subsonic loads. The exceptions were the 9mm "combat" loads that produced a noticeable bullet crack. This ammo uses a 115 grain bullet loaded to around the 1500 f.p.s. range which is naturally a +P loading. All subsonic ammo tested was very quiet with the

bolt slap of the gun making the predominant noise.

For those of you interested in db readings, we tested the AP-9 with a Quest Electronics Model 2700 decibel meter. The meter was placed 1 meter from the muzzle at a 90 degree angle. Test ammo was Winchester 147 grain subsonic, which is the load favored by most police and government agencies. This ammo produced 156.8 db when fired from an unsuppressed MP-5. With the suppressor attached, the 10 shot average was 117.6 db with an average velocity of 1018 f.p.s.. This computes to a 39.2 db reduction in noise. All velocities were measured with the P.A.C.T. Mark III Championship Timer/Chronograph.

An assortment of other brands of subsonic ammo was also tested for velocity. These included Black Hills 147 grain Subsonic Hollow Point, Fiocchi 147 grain Hollow Point, Samson 158 grain low velocity blue tip and the authors 147 grain subsonic load which is loaded with 4.9 grains of Accurate Arms #5. Also tested was Winchester 115 grain Silver Tips.

Velocities shown are five shot averages.

These loads were not checked with the Quest db meter, but perceived noise (that which you can actually hear) was least loud with the author's handload. Speer publishes this load at 979 f.p.s. but you can see it runs somewhat lower. The Fiocchi load came in a close second.

The best accuracy and weapon functioning was obtained with the Black Hills load. If I had to use an MP-5 in an armed confrontation, this is the load that I would use. This load expands to approximately .460 in soft tissue at its 1000 f.p.s. velocity. As a side note, this load will also defeat steel belted radial tires, punching a nice clean hole and deflating the tire within seconds.

While the AP-9 muzzle mounted suppressor offers the advantages of higher velocities, weapon interchangeability and the ability of going from an unsuppressed to a suppressed weapon in seconds, it does have a couple of disadvantages. First, when attached to an MP-5, it makes the overall length of the weapon about 6 inches longer than a SD. Second, an SD will bleed the velocities of most supersonic ammo to subsonic. Personally I think the increased penetration with the AP-9 more than offsets the slight noise increase when using supersonic ammo. If you are using strictly subsonic ammo then the AP-9 has a the obvious advantage of higher velocity. With the ammo tested, an SD will produce an average of 200 f.p.s. slower velocities. As you can see, by the chart, this puts it in the 700 f.p.s. range.

As for the extra 6 inches in length, an MP-5 is still very compact and manageable even in small spaces such as hallways and staircases. The Prowers County Special Emergency Response Team (SERT) tested an MP-5 with the AP-9 suppressor mounted and found that the extra length posed no problems at all.

One other advantage to the AP-9 unit is cost. The cost of an MP-5 and the AP-9 suppressor is much less that an MP-5 SD. Cost is always a factor whether the gun and suppressor is purchased for department use or by an individual for recreational shooting. In my opinion the AP-9 gives you the best of both worlds at a reasonable price.



# JR Customs Navy Suppressor



im Ryan of JR Customs has been best known as a gunsmith, specializing in custom work on the Colt Model 1911 and Browning Hi-Power since 1988. His innovative Bell Collar System replaces the barrel bushing on the Colt 1911 to provide a more durable and accurate pistol. (Brownells markets the system nationally.) Ryan also builds short-barreled rifles and shotguns, destructive devices, and suppressors. Ryan's three years of experience as a military armorer

give his work a practical, no-nonsense edge. This article will evaluate the performance of Ryan's .22 caliber muzzle can on oth a rifle and pistol.

While the JR Customs Navy suppressor was originally designed as a "special environ-

(17.7 cm) long, 1 inch (2.5 cm) in diameter, and weighs a hefty 12.3 ounces (350 grams). The suppressor features seven exotic thick baffles with complex surfaces machined on both sides of each baffle. Two different baffle designs, which are quite different than competing baffles, are employed within each suppressor. Asymmetrical spacers precisely align each baffle and provide variable spacing that is conspicuously different than the appropriate spacing for conventional baffle

ment" pistol can designed to be shot wet, the Navy works well as a rifle suppressor when shot dry. The Navy's sound suppression will be compared to new data on two competing .22 liber muzzle cans.

The Navy suppressor is constructed entirely out of 304 stainless steel. It is 7.0 inches

designs. The sophisticated nature of this suppressor belies Ryan's recent entry into the suppressor field.

In spite of its ample length and weight, the JR Customs Navy suppressor handles surprisingly well on the Walther TPH pistol. While the diameter of the can obscures the pistol sights, the Walther's colored inserts allow acceptable shot placement at 15 yards, which is a reasonable effective range for

an unsuppressed TPH. Accurate shot placement with the Navy can on the TPH requires that the operator aim with both eyes open and focus on the front sight with the dominant eye. Align the front and rear sights as normal. The bright inserts and stainless suppressor allow the sights to be used in an analogous fashion to an occluded gunsight. This technique will allow consistent shots into the center of mass on a

Pepper Popper at 15 yards.

The Navy suppressor handles quite well on a Ruger 77/22 rifle, too. One scarcely notices the extra length or weight.

The performance of the JR Customs Navy suppressor was tested

on a Walther TPH pistol and a Ruger 77/22 rifle. Ryan built an adaptor so the 3/8x24 TPI suppressor could be mated to the 1/2x28 TPI rifle barrel. The JRC Navy is also (continues)

available with 1/2x28 threads for customers who will only use the can on a rifle.

The JRC Navy suppressor tested for this article could be disassembled for cleaning, but subsequent production will be sealed units. The complex, asymmetrical baffles and spacers are a very tight fit in the tube, and their complex geometries make reassembly very difficult indeed. Furthermore, the rear end cap on the can tested in this study tended to loosen up after a lot of rounds had heated the tube. Finally, the complex baffles would be very difficult to attack with a bronze brush. Sealing the unit seems a reasonable judgement call.

When shot wet with Break Free as designed, maintenance

of the sealed suppressor will be simple, since residue tends not to accumulate. Clean the JRC Navy every 2,000 rounds when shot wet. Clean every 500 rounds when shot dry. Soak the suppressor in a solvent such as Varsol or Kroil. Hoppe's Number 9 can

also be used, since the suppressor has no aluminum components. Let soak for two or more days. Drain. Pour some dishwashing detergent and hot water into the central core. Sealing the unit with both hands, shake vigorously for several minutes. Rinse repeatedly with very hot water

until no signs of detergent remain. A thin coating of carbon will remain on the inner components, which may function as an acoustic buffer, according to one school of thought. Stand the suppressor on its rear end to drain and air dry, or blow dry with compressed air.

The performance of the JRC Navy suppressor was compared to its primary competitors, the AWC Warp 3 and the AWC Archangel. While the Archangel is no longer listed in AWC's catalog, it remains one of the very best .22 muzzle cans of all time. AWC has

developed an updated version, the Archangel 2, which has not yet made it into the catalog at the time of this writing.

The Warp 3 was cleaned with Gun Scrubber halogenated solvent and dried for tests in the "dry" mode. Break Free wa added to the rear of the Warp 3 every three shots for tests in the "wet" mode. The coolant can also be added to the front of the Warp 3, if necessary. The Archangel suppressor was shot dry, as designed.

Prior to testing the JRC Navy suppressor on a rifle and pistol in the dry mode, the suppressor was thoroughly cleaned with Gun Scrubber solvent and dried. Then the Navy can was charged with Break Free for tests in the wet mode. The suppressor was charged by inserting the tube from a 16ounce aerosol can of Break Free into the front of the suppressor and spraying while withdrawing the tube from the suppressor. The Navy suppressor was recharged with coolant after every magazine (6 rounds).

Sound signatures wer measured using a Bruel and Kjaer Type 2209 Impulse Precision Sound Pressure Meter

(set on A weighting) with a B&K Type 4136 1/4-inch condenser microphone. The microphone was placed 1.00 meter away from the front of the suppressor or muzzle, at an 90 degree angle from the bullet flight path. The meter was calibrated just before and just after the tests with a B&K 4230 calibrator. No instrument drift was observed. The ambient temperature during each test is listed in the accompanying tables. Three kinds of long rifle ammunition were tested: Federal high velocity, Hansen standard velocity target, and RWS subsonic. The rifle tests also used Federal CB Longs. elocities were measured using

a P.A.C.T. MKIII timer/chronograph with MKV skyscreens set 24.0 inches apart and the start screen 8.0 feet from the muzzle. More than 1,100 new individual measurements were made while conducting tests for this article.

Initial tests of the JRC Navy suppressor in wet mode demonstrated that results could vary substantially, depending on the consistency of technique when charging the suppressor with Break Free. The learning curve was much longer than with the Warp 3 suppressor, and the tests were repeated using the

same kind of ammunition until an optimum and consistent charging technique was developed. These initial data were discarded, and subequent data are ported here.

The rifle results are summarized in Tables

1-4 and the pistol results are summarized in Tables 5-8.

Table 1 shows the sound signatures of an unsuppressed Ruger 77/22 and the suppressed signatures using the same rifle with the JRC Navy, AWC Warp 3 and AWC Archangel suppressors. The Navy

and Warp 3 cans provided excellent sound suppression in spite of the fact that they were shot dry (they were both designed to be shot wet). The Warp 3 outperformed the outstanding Archangel with high velocity and standard velocity ammo. But the Archangel outperformed the Warp 3 with

subsonic LR and CB Longs. Since the Warp 3 was optimized to use the velocity of combustion gases as a suppression tool, these results seem reasonable. The Warp 3 works best with the highest velocity gases.

The JRC Navy suppressor outperformed both AWC suppressors with long rifle am-

munition. Using CB Longs, the Navy outperformed the Warp 3 and equalled the performance of the Archangel. The Navy's performance also compares well to an integral suppressor. Ciener's integrally suppressed Marlin 780 bolt-action rifle, for example, produced sound signatures of 124 dB with Federal high velocity ammo, 121 dB

with Hansen standard velocity, 115 dB with RWS subsonic and 111 dB with Federal CB Longs at 83 degrees Fahrenheit. The Marlin's signatures represented net sound reductions of 19, 19, 25 and 23 decibels, respectively. Ciener's integrally suppressed Marlin performed well. As Table 2 shows, Ryan's Navy muzzle suppressor on the

Ruger 77/22 performed even better (except with RWS subsonic ammunition).

Whether comparing the JR Customs Navy to a Ciener integral suppressor or an AWC muzzle can, the JRC Navy suppressor provides world-class performance on a .22 rifle.

Tables 5-7 tell the sound suppression story when the JRC Navy suppressor is mounted on a pistol. The Navy suppressor was quieter than the AWC Warp 3 suppressor, whether the cans were shot wet or dry. That should not be surprising, since the Navy has much more length and volume. The Warp 3 was specifically engineered to promaximum vide the performance in the smallest possible package. In that sense, the Warp 3 has no equal. Nevertheless, the Navy is noticeably quieter and requires recharging with coolant every six rounds, while the Warp 3 requires recharging with coolant every three rounds for optimum performance.

The Navy suppressor also generated more back pressure than the Warp 3. This increased the pistol's reliability, especially when the pistol was dirty. The increased back pressure also forced more hot gas and particulates out the ejection port toward the shooter. This makes eye protection mandatory. When shooting the Navy can wet on the Walther TPH, sooty droplets of Break Free spatter the operator's forearms, torso and face. Don't wear good clothes. This is the price of outstanding sound suppression on a pocket pistol.

The performance gap between the Navy and Warp 3 widens with lower velocity ammunition. As Table 6 shows when both suppressors are shot wet, the net sound reduction of the Navy suppressor is 3 dB better than the Warp 3 with high velocity ammo, while it is 6 dB better with standard velocity and subsonic ammo.

The Navy's net sound reduction becomes particularly dramatic when expressed in linear terms (decibels are a logarithmic scale that approximates the response of the human ear). Table 7 shows net sound reduction as the fraction of the original (unsuppressed) sound pressure level. The Navy can (shot wet) produces only 1/5,000 of the sound pressure level (SPL) as the unsuppressed pistol using high velocity ammo. Using standard velocity ammo, the Navy suppressor produces 1/8,000 of the unsuppressed SPL. And using RWS subsonic ammunition, the Navy can produces a mere 1/13,000 of the unsuppressed SPL.

The JR Customs Navy suppressor packs powerful performance in a reasonably sized package. As Tables 4 and 8 show, the Navy suppressor and the other muzzle cans do not adversely affect projectile velocity. This is a conspicuous advantage over integral suppressors with ported barrels. Higher velocity means flatter trajectory, more killing power on small and medium animals, and a longer effective range.

Another advantage of th JRC Navy is that a single muzzle suppressor may be fitting to a variety of rifles and pistols, which need not be dedicated to suppressed shooting. Thus, for example, one's favorite .22 rifle with trigger job and expensive optics can be used for discrete suppressed shooting, and the suppressor can be removed for hunting. (Most states prohibit the use of silencers for the taking of game.)

A .22 caliber muzzle can makes sense for many applications. JR Customs has produced a winning design. The JRC Navy suppressor is an outstanding muzzle can. MGN

October morning, the smell of fresh brewed coffee in the air, and plenty of friendly folks marked the beginning of what was to be a weekend of fun and excitement filled





U.S. Military Academy

Col. Isaac Lewis is credited with many inventions, both civilian and military. The reputation of his famed Lewis light machine gun has totally overshadowed another of his WWI designs, an automatic rifle as good as the modern assault rifles that fought in WWII.

A brilliant military officer, Lewis was a prolific, imaginative inventor and an unselfish, patriotic man. He not only gave the design of his original light machine gun freely to his country, he also donated all of his royalty payments back to the U.S. Treasury.

Highly distinctive in appearance, the Lewis gun has a

large, round ammunition pan on top of the receiver and its barrel is enclosed in a long, round aluminum tube, fluted at one end.

In its day the Lewis gun was a real innovation, weighing just 26 pounds against its competition: Benet Mercie (30

pounds); Colt (93 pounds); Vickers (68 pounds); or the bulky Maxim at 153 pounds.

The Lewis light machine gun was also an amazing WWI success story. By the spring of 1916, more than 50,000 Lewis guns were in combat use by allied troops. By the close of that year, the British alone had fired more than 7 billion rounds through their Lewis guns.

The late British ordnance expert, Maj. F.W.A. Hobart, wrote, "During the battle of the Somme, our people estimated the ra of Lewis gun fire in excess of 15 million rounds every 24 hours."


An American marine officer related the combat soldier's love for the old Lewis when he related in 1918, "A single Lewis gun in the hands of a good man will work as much destruction as 50 riflemen."

Born in Pennsylvania in 1858, Isaac Lewis was interested in nature and mechanics and studied to be a science teacher, which he was for two years. He then entered West Point, graduating in 1884 with top grades and plaudits for his design ideas conceived while he was still a cadet.

Retired from active duty after 30 years of distinguished service and contribution, Col. Isaac Lewis traveled to Europe during WWI to oversee the production and training programs for his famed light machine gun.

Yet, never content to sit still, the 58 year old Lewis was already designing future military weapons. In 1916, he announced plans "to build a strong arms company in the U.S. which will be fully equipped to meet the inevitable future demand"

rifles, machine guns, other small arms and trench weapons."

Lewis had begun modifying his existing Lewis gun even as the first production models rolled out of the factories in 1915. Never a shy man when it came to promoting his weapon, Lewis explained, "I wanted to develop an even lighter weapon for the individual American soldier."

He said that his basic design was good, but, "I need to lighten the weapon. What I've seen here (Western Europe in 1916) the need is for a mobile, one-man automatic gun for trench and other attacks.


My first mobile design was late in 1915, when I removed the gas cylinder, radiator and casing, then altered the mechanics to operate the piston by blow discharge alone," Lewis explained.

"The result was a 16 pound weapon and it worked well, but I knew I could do better. I could not devote full time to it because, after all, we were still in the midst of a serious world war."


Despite the successful trials, the inventor was not satisfied with his lighter Lewis gun. Ironically, this stripped-down, modified Lewis gun would be adopted by the British for ship and anti-aircraft use in WWII.

By the end of 1916, Lewis had produced a 14 pound automatic weapon. He said, "I can do better. This one is still between and betwixt, not a rifle and not a machine gun. I will go back to a design idea I first had early this year, a light automatic rifle that can be used in the assault by a soldier."






at an assault rifle was this top-loading automatic rifle developed in 1917. Savage Arms Company

Although he did little with that design, Lewis still contacted U.S. Navy Commander J.P. Jackson, a small arms ordnance expert, to show him the plans for the new

Lewis's 1916 design for what he called his "assault phase rifle" would weigh 13 pounds, compared to the BAR's 8 1/2 pounds, was clip fed with select fire capability. When he demonstrated his prototype weapon, he announced, "This rifle is as accurate as any weapon our services now use. But, when switch to fully automatic firing the new Lewis gun will give one man the firepower of many men."

Obviously, this was Isaac Lewis's answer to the BAR and he immediately patented his design. At the end of 1917, Lewis and Commander Jackson made the rounds of the War Department trying to interest ordanance people in the new weapon.


The new Lewis gun did as well as the old Colonel predicted it would," noted a New York Times writer in the spring of 1918. "He also announced that at 12 pounds it was a pound under the design specifications and nearly seven pounds lighter than its official competition, the John Browning gun."

Also commenting on the weapon, Wayne Mellon, a veteran military journalist of that era, wrote, "Colonel Lewis has treated us to another excellently designed weapon. He's proving that his great

machine gun is not his last word in ordnance design and now has this marvelous new shoulder weapon for American soldiers."

Unfortunately for Lewis, the U.S. War Department didn't agree. The Colonel's old friend, Gen. Leonard Wood, wrote to him privately early in 1918, "Isaac, they have many Browning guns and contracts for more Browning are coming in. I don't think your design will sell to the Ordnance Board now, though it seems to be superior to the Browning."

That response fired the sixty year old Lewis with an inventive challenge. He developed his "Third Model" assault rifle, features of which he kept secret from all but a few of his trusted assistants. All plans and designs were done "in house" by Lewis personally and those few close assistants.

By late August, he ran Ordnance Board of the U.S. War Department. In part, it read: This light shoulder gun is fully automatic or single shot. It fires as rapidly as any auto or as accurately as any single shot. It has a

quick switch combat sight or a marksman's long range sight....The cooling of the shock-operation piston is amazing, even in sustained automatic fire...

Tested the gun fires automatically about 400 rounds per minute and is very accurate even at that volume....It weighs just 12 pounds and is the same length as the standard service rifle the (the '03 Springfield was about 43 inches long)... it would utilize a standard (BAR) 20-round magazine...

This light automatic rifle has very little recoil... far less than my original Lewis gun... The balance is best for shoulder firing by the individual soldier .... It is perfect for automatic firepower in the assault by every single soldier... I stake my name that this rifle is more accurate and stronger than the Browning gun.

The bombastic Lewis estimated that each rifle could be produced for less than \$25 each in quantities of 10,000 weapons per order. He and the now retired Commander Jackson urged the War Department to consider this "new age, new military era automatic rifle" as they called it.

But, it was late in 1918, the war was over, peace had broken out and military budgets, especially for new weapons, were not in favor. Despite several successful field trials in which the new Third Model Lewis rifle did outperform the BAR, the sale was never made and production orders never materialized.

Lewis wrote to his partner, Commander Jackson, "When the war ended there was no pressure for new weapons or even to replace the old ones. The Browning system is in favor and in production. There is political pressure to cut the (War Department) budget. It is unlikely anyone will buy our new rifles."

Disjointed by Washington politics and the power of the established small arms industry, Isaac Lewis retreated to his New Jersey home and semi-retirement. He only tinkered with firearms designs from that point on.

Isaac Lewis could afford to retire. At 65, he was wealthy form foreign sales of his Lewis machine guns and wise stock investments. Even though he'd returned to the U.S. Treasury every cent of money from the sale of his guns to the American military, the money from sales to other governments had made him a tycoon.

Shortly before his death of a heart attack in 1929, Isaac Lewis told a friend, "One of man's immortal claims is the pride of his name. No one can take that pride away from me, my family or my guns."

# MACHINE GUN BAN

# RULED — UNCONSTITUTIONAL

ate last week Neal Atkins, NFA's Texas Legislative Liaison, phoned me and asked if I had heard anything about a Federal case out of Illinois dealing with machine guns and the Rock Island Armory. I told Neal that I had not heard anything but that I would check the case on Westlaw. That is a computerized legal database that my office uses to keep current on caselaw. It is horribly expensive to use so I seldom access it. But it can't be beat for up to the minute caselaw reports. Since I had heard nothing about the case, I assumed that it was brand new. After a few minutes of searching, there it was: U.S. vs. Rock Island Armory, Inc and David R. Reese, (773 F.Supp 117, Dist. Ct., Ill.)

This was no "new" case. It had been decided way back in June of 1991. When I downloaded the case, I could not believe my eyes. It seems that the Defendants, Rock Island Armory and David Reese had been charged with manufacturing and delivering machine guns in interstate commerce (guns manufactured after the May 19, 1986 ban). They were charged under the National Firearms Act of 1934 which required registration of the guns at the time of manufacture.

The Federal District Court of Central Illinois, Rock Island Division quickly got to the meat of the matter. The Court pointed out that the National Firearms Act of 1934 and the Gun Control Act of 1968 had both been constitutional because they were "revenue" acts and thus Congress had the enumerated power to raise revenue. When 18 USC 922(o) [Ed. the McClure-Volkmer "Firearms Owners Protection Act"] became effective, it repealed the earlier acts as to guns manufactured after May 19, 1986. Not only did it repeal the earlier acts, it changed the character of the regulation from one of "revenue raising" to an outright ban since the government refused to accept the tax for registration. Since no taxes were accepted, it could not qualify as a revenue act.

The Court then went on to cite from the Congressional hearings of 1934 wherein the US Attorney General was questioned by Congress about their ability to regulate machine guns, stated that they had no authority to ban machine guns since Congress had only those powers enumerated to it, and a ban was not one of them. He then went on to say that "... If we made a statute absolutely forbidding any human being to have a machine gun, you might say there is some constitutional question involved. But when you say, 'we will tax the machine gun,'... you are easily within the law." Hence the evolution of the tax on machine guns.

The government argued that the law was still a taxing measure, but the Court wasted little time in disposing of the argument by correctly pointing out that manufacturers can only manufacture for government entities and they are exempt from tax.

#### THE RULING

The Courts ruling is contained in the final lines of the decision: "As applied to machine guns made and possessed after May 19, 1986, the registration and other requirements of the National Firearms Act, Chapter 53 of the Internal Revenue Code, no longer serve any revenue purpose, and are impliedly repealed or are unconstitutional." (emphasis added)

The Government appealed this decision, but we are told by a reliable source that word came down from "on high" that the appeal should be dismissed and the government did just that. Why you ask would the government want to avoid appealing a case that had just ruled the machine gun ban unconstitutional? Several possible reasons spring to mind:

 This was a criminal case and it would not necessarily open the flood gates for manufacturing, especially if no one knew it had occurred;  By avoiding the appeal, the lower court's decision was more likely to be overlooked than that of a Circuit Court of Appeals;

3) The government knew it would lose on appeal, thus giving the District Court's opinion even more legitimacy and far reaching effect;

4) If the appeals court ruled in Rock Island's favor, there would be two possibly conflicting Appeals Court rulings (remember the Farmer case in GA.) and the Supreme Court is under a stronger obligation to review the case when such a situation arises. If the Illinois case were left as it was without the appeal, its immediate effect is felt only in its area. If the Supreme Court rules, its decision is law all over the Country immediately. I suspect the latter reasoning to be the case. They are hopin, that similar results in other jurisdictions will be slow in coming and by then the Congress will have had time to react and come up with an alternative.

It would seem that if you are a manufacturer in the jurisdiction of the Rock Island District Court, you might be in a position to turn out a lot of totally federally unregulated full auto firearms in the intervening months, at least until the hole is plugged.

## THE BEAST

This case has opened our eyes as to the nature of the "beast" that put so many legitimate machine gun dealers and manufacturers out of business without the blink of an eye. It did so probably knowing full well that its actions were unconstitutional and would not withstand a legitimate scrutiny. No remorse, no apology, in fact, it still seeks to limit the disclosure of its duplicity until some other way can be found to screw the American gun owner.

NOTE: Prior to any NFA members misconstruing the holding of the court in the Rock Island Armory case, it should be understood that the Court held that th registration and taxation provisions of the National Firearms Act, as amended, do not apply to post May 19 automatic firearms.

# However, the ban on their possession has not been invalidated. Stephen P. Halbrook, the esteemed attorney and legal scholar has noted that while he has successfully challenged the indictments which alleged violations of the National Firearms Act for failure to register and pay tax, in two different cases, the Government re-indicted the parties for their illegal possession. Future legal battles must be waged in urging federal courts that such a ban under the 1986 Act is not sufficiently tied to the appropriate clauses of the United States Constitution which enable the federal government to pass legislation. Conse-

quently, no one should misinterpret the Rock Island Armory case and begin manufacturing automatic firearms. Rock Island Armory has done good work for us with this case and David Reese is probably not very rich after battling the "G" men. If you need guns or parts, think about Rock Island Armory.

# Bayonet Lug

One persons quest for authenticity and Constitutionally guaranteed freedom pays off - finally!

Inspired, at least partially, by the successes of U.S. Ground Forces in Operations Desert Storm and their M16A2 rifles— I resolved to obtain a semi-auto version of that fine weapon "as close to the G.I. original" as possible!

One of the most distasteful changes in C.M.C's (Colt's Manufacturing Co.) recent "Sporter" versions of the former AR-15 series of semi-auto rifles includes milling the bayonet lug completely off the weapons. Colt Industries, former owners of the Colt Firearms Division, had arbitrarily jerked all versions of the AR-15 from the civilian market simultaneously with "progun" President George Bush's decision to "temporarily" ban (later made permanent) 42 foreign-made (imported) semi-auto weapons subsequent to Patrick Purdy's deranged attack on a Stockton, CA schoolyard with a Chinese AKS (AK-47 lookalike) 7.62 x 39 m/m semi-auto.

As literally tons of prohibitive, restrictive anti-assault rifle legislation was pushed through both houses of the U.S. Congress (as well as the various State Houses) one of the most asinine provisions

included in several of these yet to be enacted bills was that any semi-automatic weapon capable of mounting a bayonet would arbitrarily be banned as a "weapon of war" - instantly exiling it to the dreaded "assault rifle" category!

One would have to delve far back into U.S. Armed Forces history to record the last great military bayonet charge. My research indicates that there has never been a recorded civilian bayonet charge — either by an individual or by a group of law-abiding American citizens! Even criminals have shown a marked reluctance to take on either the police or their own competitors by means of the bayonet. Yet, the simplistic do-gooders "know" that bayonets — and, therefore, any gun capable of mounting one — must be bad, even though one has probably never been used to commit a crime, at least not while affixed to a rifle!

The bayonet has, both in this and other countries, a noble history. It was especially useful as a serious fighting tool during the era when most military firearms were slow-to-reload single shots. It was the large capacity, detachable box magazine of


America's most recent military rifles (the M14 and the various M16s and to a lesser extent the .30 M-1 Carbine, because of the latter's puny cartridge) that began to limit the necessity of the bayonet as a combat tool. Much faster to reload than their predecessors and holding many more rounds per charging, meant that the bayonet would see lessened usage as a last resort arm.

Today, however, the bayonet still serves a valid purpose as a control device, i implied threat usually being sufficient to attain the desired result. Even if the bayonet were to be employed, there is little argument that the resulting wound would be far less serious than if the rifle actually had to be fired! Additionally, many bayonets are very collectible — often adding significantly to the historical value of the weapon for which it was designed!


Partially then, because of recurring glimpses of "real" M16A2s on television (a result of the now successfully concluded Persian Gulf War), but mostly due to a desire for authenticity as well as the exercising of my Second Amendment rights I

vowed to obtain a Colt manufactured semiauto "lookalike" as close to the selective-fire (3-shot burst) U.S. Service version of the M16A2 as possible. While not everyone may be willing to commit the time, effort and expense that I have to attain this goal, there are ways to remilitarize Colt's current crop of "Sporter" .223 caliber semi-auto rifles!

Since my goal evolved after Colt Industries had "pulled the plug" on all civilian sales of the AR-15, my quest appeared to be a difficult one. Fortunately, about the time my search began in earnest, C.M.C. (successors to the Colt Firearms Division of Colt Industries) announced that they planned to "re-enter the sporting long gun market". Their stated objective was complicated by the fact that 47% of C.M.C. was owned by the State of Connecticut (more correctly, the pension fund thereof) - to whom C.M.C. had promised that they "would not sell assault rifles for civilian use" - in order to obtain the State's financial backing.

Three initial changes were made by C.M.C. to the former AR-15 series of rifles in order to comply with their promise to the State of Connecticut (this in addition to deleting the "objectionable" AR-15 designation from the vast majority of such rifles subsequently sold by C.M.C.). First, bayonet lugs were ground off of the weapons completely. Second, floorplates of the two 5-round magazines shipped with each gun were permanently riveted in place (while Colt had always provided "5-round" magazines with semi-auto AR-15s, these were actually 20-round mags, limited to five shots by an easily removable "baffle"). Third, (at least upon initial resumption of shipments) the mandatory inclusion of Colt's R6222 .22 Long Rifle Conversion kit (first introduced, about the same time that the AR-15 itself was subjected to Colt Industries' self-imposed civilian sales ban) with each gun sold.

Obviously Colt (C.M.C.) has knuckled under to proposed bayonet lug and large capacity magazine bans in advance of either Draconian measure actually being passed into law; the R6222 conversion kit was yet another facade designed to enhance the "Sporter's" non-assault rifle image. The obvious intent of all such measures is a blatant attempt to exempt the guns from existing or future bans. Only time will tell if these rather questionable tactics will be successful.

Initially, I purchased a shiny new model R6550K (the "k" suffix indicated the inclusion of the R6222.22 LR conversion kit)

"Sporter/Target Model". This early transitional gun had obviously already been in the production "pipe line" when Colt Industries had banned civilian sales, as its receiver was still clearly marked AR-15A2 Government Model — with Colt Firearms Division/ Colt Industries listed as its maker. My rifle's bayonet lug, however, was completely milled away — a fact that I found sickening both from an authenticity and a Constitutional freedom point of view.

No problem, I thought, I'd offer someone a few bucks and trade my lugless front sight housing (this is the part that contains the guns front sight, gas tube orifice, and bayonet lug) for theirs, and install their part on my rifle (this would have been almost impossible anyhow, as we'll see later). But, nobody of my acquaintance was willing to part with their bayonet lug — whether they were planning to use it or not!

Checking through the latest Gun Parts Corporation (successors to Numrich Arms Corp. Parts Division) catalog I found "my" part. Colt Front Sight Housing #62385 was shown at a price of \$55.15 (plus shipping), and was said to fit all "A2" versions. I placed an order for same, stipulating new condition/bayonet lug intact only. Upon arrival, after several weeks of waiting, I was initially thrilled when I saw the part that had come. The bayonet lug was indeed complete and intact, plus the piece was obviously brand new. The housing was even equipped with the latest "square" post front sight assembly.

Closer inspection, however, horrified me as to what the new part did not possess.

It was totally undrilled to accept the two under-barrel "taper pins" that secure the housing to corresponding barrel reliefs or "notches". A quick phone call to C.M.C.,

confirmed my worst fears. An undrilled barrel and an undrilled front sight housing are mated and aligned at the factory in a "jig", where both are drilled simultaneously. Colt also said that due to slight tolerance variations that it was nearly impossible to swap one pre-drilled

housing to another pre-drilled barrel (a fact later borne out by actual trial and error). No, Colt didn't have any complete #64575 "A2" barrels, with bayonet lug intact either — and, at a list price of \$396.00, I probably wouldn't have cared at the time anyway. GPC graciously refunded the complete price of the #62385 front sight housing — as it was not listed as a "gunsmithing only" part in their catalog.


I had just about resolved myself to living with the gun I had when a new variation came to my attention. Many are aware that Colt had lost the U.S. Military contract for the M16A2 to F.N. of Belgium (C.M.C.'s recent "token" U.S. Government order for approximately 12,000 M16A2s probably represents more of a post-Gulf War "fill-in" than a "return to grace" as the primary supplier of the weapon). In fact, it is widely accepted that Colt Industries' withdrawal of the civilian version of the AR-15 from the market had much less to do with their stated intent of "helping" President George Bush limit public access to "assault rifles" and much more to do with "kissing up" on certain anti-gun politicians - hoping, thereby, to have their M16A2 contract reinstated!

Apparently, however, when Colt finally accepted the fact that they had actually lost the Government contract they decided to make use of the remaining military lower receivers that had not already been drilled to accept an automatic sear (thus rendering such drilled receivers "machine guns" — at least according to Federal Law). The real significance of this development (continues)



is that all M16A2 lower receivers were equipped with a raised "cage-type" protector surrounding the weapon's magazine release button. This cage is not only functional (preventing the inadvertent detaching of the magazine by accidental or unintentional contact with the release button) - but more importantly, from an authenticity point of view, makes guns so equipped even more similar in external appearance to the M16A2 - my stated goal from the outset!! Additional research indicates C.M.C. "Sporters" including this feature are the first ever so equipped. As a matter of fact, "Sporters" with the "cage", when fitted with an aftermarket "push pin" retainer (replacing the Colt factory "double screw" forward upper/lower receiver retainer) are virtually identical externally to the M16A2 — except for that missing bayonet lug!

I knew a friend who had gotten one of the "cage" equipped guns and who could have cared less about that feature. He did, however, admire my guns AR15A2 markings and its R6222 .22 conversion kit. There was about \$125.00 difference in wholesale cost between my R6550K and my buddy's R6551 Sporter/Target Model (primarily the additional cost of the .22 conv. unit), we swapped and my friend paid me the \$125.00 balance in cash. I decided to invest that much (and perhaps, "a little extra") to complete my goal by restoring the missing bayonet lug. Had I known then that the ultimate total to attain this would be over three times the \$125.00+ I'd allotted. I might well have stopped right there!

As an additional unexpected bonus, my "new" gun while marked Colt's



Sporter/Target Model on its lower receiver, had been previously roll-die stamped with the Colt Firearms Division/Colt Industries logo - proof positive that this particular lower receiver was a genuine ex-M16A2 part — at any rate, current regular production C.M.C. sporters do not have the "cage".

Gun Parts Corporations' Dan Daly was sympathetic to my cause due to my earlier problems with the undrilled #62385 front sight housing bought from them earlier. Dan sold me an original Colt #64575 "A2" barrel, with bayonet lug intact. List for the barrel at the time was still \$396.00, but is undoubtedly higher than that now (no, I don't know whether GPC has any similar barrels left. When I opened the GPC package I finally had "the barrel of my dreams".

Nothing had come easily on this project and that applied, at least initially, to the #64575 barrel as well. An understanding local gunsmith offered to do the barrel swap for me gratis in order to gain experience with the procedure. We did not have a set of genuine "G.I." barrel vise jaws but did have a proprietary set from a wellknown gunsmithing supply house. For nearly two hours we tried every trick that we knew to get the original barrel off my rifle - to no avail. Since we'd removed both front sight housings in attempting to make the barrel swap, as a last resort, we tried the lug-equipped housing from the GPC barrel on my rifle's original barrel sure enough, the holes did not line up properly.

Because I already owned the barrel, and had purchased it from an outside supplier and not directly form Colt, C.M.C. service

genius Dick Welsh installed, headspaced, and test fired the barrel on my R6551 Sporter Colt's very reasonable \$42.00 one hour minimum service fee. When the box containing the rifle arrived back from West Hartford, several months of prior failure and frustration had finally ended! The bayonet lug equipped barrel was mated perfectly to my R6551's upper receiver.

Test firing, when

using the correct 62-64 grain bullets (compatible with the guns Machine Gun News - June 1992 1/7" rifling twist rate), has repeatedly yielded MOA groups from this rifle at 100 yards — using the weapon's standard open "peep" sights. Best of all, I have never experienced any type of failure or malfunction!

Since I desired an "all-Colt" ensemble, choosing the proper bayonet for my "\$450.00 lug" was relatively easy task. I selected a scarce Colt Logo (#62316) bayonet of the M-7 (M16/M16A1) stiletto pattern. My particular bayonet was made in West Germany under contract to Colt (there was a rare U.S. produced model that also carried the Colt emblem). Even had there been a Colt manufactured (or contracted) M-9 bayonet (the current U.S. issue design for the M16A2) available, I'd probably have stuck (no pun intended) with the M-7 regardless. While the M-9 has several interesting features such as: "knife" blade pattern; lightweight glass filled nonmetallic grip; bottle opener; built-in wire cutter (when combined with a stud on its sheath), etc. -- it simply does not fit this writer's view of a "classic" combat bayonet!

Although certainly not original, perhaps here is the place to mention a viable, less expensive, alternative for those simply desiring to equip their "A2" Sporter rifles with a bayonet lug. Gun Parts Corporation now offering their part #CLT-SP-1071, which is a bayonet lug equipped replacement front sight housing for most of the lugless "Sporter" models (including R6550K and R6551 Sporter/Target Models; R6600k and R6601 plus R6601DH Colt Sporter/Match HBAR and Delta HBAR's). This part will not work, however, on the new R6530 Sporter/Lightweight models due to the guns smaller diameter barrel. While the GPC housing is indeed pre-drilled to accept the under-barrel taper pins, Dan Daly of Gun Parts states that very few have been returned. The price for this GPC piece is a very modest \$27.50, however, this price is for the housing only — the purchaser must trade out other necessary parts from their rifle (front sight, etc.).

In case you've not been keeping a running total on my project, the barrel would cost a minimum of \$396.00 today (if you can find one); add \$42.00 for Colt factory installation; toss in \$12.00 for UPS shipping and you'll arrive at the \$450.00 total this piece. The gun pictured is virtually entical externally to the U.S. Military M16A2! Persistence literally paid off in this case — FINALLY!


# SNAP SLING

by CHRIS A. CHOAT

through the years from simply holding them in ones' hands to the fancy and sometimes ingenious slings and straps of today. In between, I'm sure shooters have used everything from vines to rope or even wire to keep a firearm close at hand.

Some firearms manufacturers supply a sling with their guns. These include everything from the simple Colt M-16 "black, silent sling" type to the more complex slings such as the Heckler & Koch green canvas sling. The latter, when understood and used properly, is probably one of the best tactical slings around today. (The proper use techniques are explained in the H&K MP-5 red manual.) As good as this sling is, it has two main drawbacks.

First, it is too narrow to be comfortable when a weapon has to be carried for long periods. The sling tends to "dig

in" at the shoulder, especially with heavier weapons such as the G-33 or G-3.

Secondly, once the sling is adjusted for a certain carry position it cannot be readjusted to a firing position very rapidly. When carrying an MP-5, for instance, if the sling is adjusted to a comfortable mid-torso carry position the weapon cannot be shouldered because the sling is too short. With the sling ad-

justed to be easily shouldered the weapon will hang slightly below the belt line. This may be comfortable for some but the mid-torso carry position allows the firearm to be more quickly and accurately fired.

Now there is a sling system that addresses these problems and in my opinion is the best tactical and competition sling on the market today. It is called the SNAP SLING.

The Snap Sling was designed to carry a weapon in a safe, secure and comfortable position for extended periods but allow it to be ready to fire in an instant. The Snap Sling, when adjusted to the user, allows the firearm to be held in a basic carry (or patrol) position and then can be snapped into a ready (shoulder fire) position instantly. This is accomplished with a rapid adjustment system and a patented automatic quick release. This allows the sling to extend to the extra length needed to shoulder the weapon. This takes a lot longer to tell about than to actually do.


The Snap Sling is very comfortable. It is made from 1.5 inch black webbing that spreads the weight of the weapon over a larger area. The black also looks better than the olive drab colored H&K sli. All hardware, whether metal or plastic, is also black. All stitching on the sling is doubled for




The sling uses H&K type quick detachable hooks that secure it to the weapon so that it won't accidentally come loose. Shown in the locked "carry" position, the sling can be "snapped" out to the fire position instantly.



For attachment to H&K weapons the sling comes with an adapter for the A2 type stock. No adapter is needed for the A3 type stocks. Other adapters are available for different weapons.



The Snap Sling holds the weapon close to the body yet instantly accessible even in the "un-snapped" position. The height that the weapon is carried is adjustable to shooters preference.



With the sling in the carry position the weapon rin the mid-torso position. Even from this position the gun can be fired accurately.



Here the sling is shown "unsnapped". All the shooter has to do is snap the sling out and up to un-snap its built-in lock buckle.

added strength to joints. The sling does use the same spring loaded hook and eye type swivels as the H&K slings. This is a proven design and works very well.

Besides the basic front carry position, this sling can also be used to carry a firearm on the shooters' back in a muzzle down position. This is very handy for rapelling or when quick weapon access is not a require-

While this sling is the best of its kind, it does have one limitation. It can only be used on firearms that have side mounted ling attachment points. It also has to be attached on the side opposite the ejection port. This limits the Snap Sling to right handed shooters. GRSC, the company that manufactures the Snap Sling, is working on adapters for weapons that have bottom mounted sling swivels. At this point they have a very well made adapter for the AR-15/M-16 type guns and others will be following soon.

The sling is ideally suited for the H&K line of firearms and will also work well on the Sig 550 and 551 rifles, the Galil, the FNC and FN Para.

The Snap Sling is a very innovative design that solves several of the problems of todays existing slings. It is rugged and durable and carries a full one year warranty. Best of all, it's made right here in the good ol' U.S.A.. Oh, by the way, several of these slings were used in Operation Desert Storm and got very favorable reviews. MGN



# Tinkering With Thompsons



by JIM KLODZINSKI OF GUNMACHINES The Suppressed Thompson

In past issues of MGN I wrote about a quick change barrel set up for the TSMG. The reason that I was interested in such a system was because I had a custom suppressor commissioned and I wanted a method that would make putting the suppressor on and off easy. I didn't want to have to go through the rigors of a normal barrel change operation for utilizing the suppressor.

Photo A shows the 1928 AO TSMG with the suppressor screwed into the receiver in the place of the barrel. With the suppressor, I grip the TSMG with my left hand around the suppressor itself so no vertical foregrip, or a horizontal one, for that matter, is needed. However, it is necessary for me to use a glove on my left hand because of the heat developed when firing.

Photo B shows in closer detail the area where the suppressor is screwed into the receiver. Note that without the forward grip mount a space shows when the suppressor is installed. Of course, a grip mount cut off at the forward part of the receiver would act as a blank and fill in this space; but this would only be needed for cosmetic purposes.

Photo C shows the TSMG with other suppressor alternatives. The top being the use of the short barrel with a MAC suppressor attached. The bottom shows the custom commissioned suppressor. The middle one is another MAC suppressor.

The customsuppressor was made utilizing a brand new Savage barrel for the core. The barrel was turned down its complete length and appropriate holes were drilled into the barrel core. The baffles were placed

around the barrel core. The outer tube covers the internals. Although the length of a TSMG barrel is 10 1/2 inches, the overall length of the suppressor is 14 inches. Since the suppressor uses a TSMG barrel as its core, the threads attach to the receiver without a problem.

Shooting the TSMG with the suppressor is a kick; and no ear muffs are needed. My preliminary tests indicate that the bolt cycles about 50 RPM quicker with the suppressor than with a regular barrel. Also the velocity is about 50 ft. per sec. greater with the suppressor.

The suppressor becomes extremely hot even after just going through one 30 round stick magazine.

Although the suppressor totally silences the muzzle blast, the TSMG still makes racket when shot with the suppressor. Remember that the bolt cycling through the receiver itself makes noise. So when shooting you do hear a loud clackity-clack. With an empty TSMG manually cycle the bolt as quick as you can. This gives some idea of what I heard even with a suppressor. Under the dynamics of firing the bolt cycling noise is exaggerated about by a factor of three. Frankly, other than the convenience of not wearing muffs, the novelty of it, and cutting down on the noise that a neighbor might hear, I'm not too sure that I would recommend getting a suppressor for a TMSG, unless a shooter just had to have one. But if a suppressor touches your fancy for your TSMG, it certainly can be done. And with the quick change barrel system and a suppressor made from using a TSMG barrel as the core, the shooter can very conveniently change from a suppressor to the standard configuration in about 30 seconds.



# The Forms



by DAN SHEA

he Special Occupational Tax (SOT), is due soon, so we will take a few minutes to go over it. New Class 3 dealers and Class 2 manufacturers must have the appropriate FFL, then obtain an Employer Identification Number. The SOT is paid to the Pittsburgh lockbox - this procedure is gone over very thoroughly in the Machine Gun Dealers Bible. Existing SOT's will receive a tax bill from BATF. It is to your benefit to send it in as soon as you can. If you wait till July 1, it is doubtful that you will be recorded in the system until October. NFA starts kicking back transfers to people who are not in their computer as tax paid in August. This means delays for late payers. Use a company or personal check so that you have a canceled check to prove that you paid, or use a money order for fast processing if you are early. Just remember that a money order means trouble for tracking if there is a problem. Make sure that you fill in any changes, and that you fill in the appropriate tax period that you are paying. 1992-93.

I have been working for a long time to get a determination from NFA branch on how we can transfer Destructive Devices interstate, to states that have no type 9,10, or 11 FFL holders. It has finally happened, I got the letter back in April. DD's CAN NOW TRANSFER INTERSTATE ON TAX-PAID FORM 4'S TO HOLDERS OF A TYPE 01 FFL - Regular Dealers! This opens up every state that has no prohibition against NFA registered DD's. That's M-79's, M-203's, mortars, cannons, recoilesses, A-T guns, etc. Have at it, guys!

Another item of interest is that importers are not the only ones required to register under the Arms Export Control Act of 1976, for which we owe many thanks to the peanut farmer, Jimmy Carter. Manufacturers are required to register even if they don't do any exports! It costs \$250 per year. We didn't want to print the form in this issue because it is specific to a small quantity of our readers, but the correct form:

ATF FORM 4587 +(5330.4) Application To Register As An Importer Of US Munitions List Articles is available from the government, or send an SASE to MGN and we'll send you a copy ASAP.

I was reading the Q & A section in April '90 issue and found the Kevin White story intriguing (copy enclosed). Now, keep in mind this is was on a Friday. Throughout the day my mind wandered and I fantasized on how wonderful and exciting it would be to find such a treasure.

We went to an old WWII gunnery range that was used by General P—- and has been open to the public since the 1940's. We have been to this range many times and occasionally have been lucky enough to


find a few .50 brass cartridges and 20mm vulcan brass.

I walked about 1 1/2 miles farther than usual from where we were shooting and bent down to pluck a cartridge from the dirt of a small mound when I noticed a bunch of debris from what looked like an old WWII plane crash strewn about. I followed the trail of debris for a short distance and found a piece of mangled plane landing gear and tires. Thinking that the USAF had a crash and picked up the bulk of aluminum and the ever elusive black box, I decided to go get the little lady and show her the great find.

I walked about 50 ft. further over to another small mound and Kevin White's letter that I had read on friday jumped into my mind like an ambush.

Below me in a gully was not one betwo (see enclosed pictures), M-3A Aircrare Browning .50 caliber machine guns partially buried in dirt, sand and aging sage brush. One was still mounted on part of the wing! Wow! The excitement that ran through me left me shivering in the calm, hot desert air.

From what little I know about .50 cal





guns, one gun was totally demolished from the plane crash. The side plates are bent beyond repair and there are no internal parts.

It looks like the other one needs a new barrel, the original one is bent. Otherwise, it looks like it just needs a good cleaning to be fired ?????

I ask that this letter be kept anonymous der all circumstances because I don't anow if the guns I have described are legal to own, to look at, to touch, etc....That's why I am writing to you to ask for your advice.

Can they be rebuilt with new sideplates? Should I keep them as they are for "Historical" purposes and conversation pieces? Or should I run with the fear of the BATF breathing down the raised hair on my neck and return them to their resting place from whence they came?

Your helpful advice will be greatly appreciated.

Also, a couple of weeks ago I purchased an M-68 105mm gun barrel. It's 18ft. long and weighs 1600 lbs. It has two torch cuts, one at each end. I want to restore said barrel and mount it on a carriage to be fired. How do I register it? What type of paper work is needed, etc.

I am looking forward to your reply and hope to meet you at the SOF convention in Las Vegas in September.

I love stories like this one, but I hate giving the bad news. You are in illegal possession of unregistered machine guns, and, basically, stolen government property. The proper method of disposal is to call the agency that supervises the range, and alert them to the fact that the guns are out there, then to make sure that guns are in fact out there. You could destroy the right side plates, then build the parts onto a registered receiver, but the .50 Cal Browning is noth-

ing to play with. Improperly built .50's kill people, and they scare the hell out of me when I see them on the line at shoots. You would still be guilty of possession of stolen government property. It's your decision. About the 105 barrel - it sounds like a neat piece, but once again, you are dealing with massive amounts of pressure here. I would hesitate to advise you to weld it up to fire without seeing just exactly what "cuts" were made in it. The procedure to manufacture it is to file a form 1 tax paid to make a Destructive Device. You really need the breach block to register it, though.


Q I don't claim to be a self expert on ATF rules. I have contacted ATF in regards to the Form 5320-2. I have asked them if I move in the same state, would I still have to fill out the form? They reply yes! Even if I move across the street they have to know. It makes sense so they can keep you under their thumbs!! Like they say "Big Brother is watching". So you might want to check in to that yourself. Someone might have given you the wrong information. So what's the deal, check it out.

Machine Gun prices are fluctuating as usual. One person may buy all of one type gun, as happened to the Colt Thompsons and Maremount M-60's, and there will be a run on these guns with prices going up and up, until they reach the point no one is willing to pay, then the dealer who pumped the prices gets stuck with a large overpriced inventory, and has to lower prices to move the items. It happens in every collectables business. I just wish people would stop doing it, it put the Colt Thompsons out of reach for most shooters, and made it hard to talk to people who see the inflated prices. They're all positive that the Navy overstamp in the back of the local police closet is worth \$25,000, even with the cracked stock and "Bonehead P.D." stapled on the side with a 16 penny nail. Adds character, I guess. The other thing affecting MG pricing is the persistence of rumors of the 1986 ban being overturned. Every other day someone who is wishing and knows better or to numb to read the writing on the wall says "the ban is overturned". It isn't. Prices go down, then skyrocket again after the truth is known. To be quite honest, I believe we will overturn the GCA-68, The 1986 ban, and probably the NFA 1934 within the next ten years. There are many cases working their way through the courts, and this writer is privy to most of them. When some real earthshaking news is imminent, I will blazon it across the front cover. Until then, figure that most of what you hear is wishful thinking. As to whether you buy an expensive machine gun that you want, figure whether you want to wait 5 years without the gun, then have us lose to some unforeseen anti-gun Nazi group gaining control. Now your dream gun costs ten times as much, if you can find it, and you wasted all that time, sitting in your house, a lonely wallflower, pining away the hours dreaming of your secret love, when you could have been at the range, shooting it!

Q The Shotgun News offers a list of FFI holders who will send/receive firearms/ammo for non-licensees. Is there any chance you guys might offer such a service for Class 3 transfers?

A No.

It is anti-dealer for a magazine to publish people who will undercut regular businesses as a directory. Dealers who wish

to do transfers for a fee into their state should place an advertisement in the classifieds. That is called overhead, and is a legitimate business expense, the type of expenditure that BATF looks for in determining if a dealer is "engaged in the business". MGN is not competing with the dealers, we are providing news, a forum for the industry and enthusiasts, and a place to advertise. Many dealers advertised in the back of the Machine Gun Dealers Bible. (There you go again, Dan, - Vida)

Q Enjoy your articles in MGN each month. Have your Bible and read some each day for my information and am trying to digest as much as I can. Now I have a question cause I'm not clear on this situation.

If I obtain a registered tube MP-40 receiver from a Class 3 dealer, install same into a parts kit and complete an MP-40, Do I send a Form 2 within 24 hrs. to BATF or send Form 2 only when it leaves my premises on a sale? I'm a new Class 2 manufacturer and help will be greatly appreciated. Keep up the good work.

P.S. Also, must I stamp my name and address into the receiver tube with the original MFG's name before I sell the MP-40?

A The Form 2 is not filed, you have not "manufactured, remanufactured, re-activated or imported". You have completed an existing machine gun. Your company information must be put on it, and, BATF is saying that you must pay Federal Excise Tax when you sell it, if it does not go directly from you on a form 4. When the transfer paper work is sent in, correct the lengths, it is now a machine gun, and your company info goes in section 3 or 4-h. Include a note that you have completed the registered receiver into a machine gun.

Q How can we (I) help to repeal the Gun Control Act of May 1986, or at least make it legal for individuals to legally make a Class 3 weapon?

From 1934 to May of 1986, persons wanting to make a Class 3 weapon, had to submit to many strict police checks, fingerprint cards, photographs, to send in with their \$200.00 "making tax" for BATF to approve. I am not talking about a manufacturer but an individual. This was done on BATF Form 1.

These legal Class 3 weapons are not used in crime as all statistics will show. Please let me know how I can help to repeal this law or at least this section.

Sincerely, Richard S. P.S. in 1968, when the 30 day amnesty period for Class 3 was allowed by the Director of BATF, what happened to the other 30 days, (60 days total) I've heard this from many different people at different times and places. Can we get him to give those to us now?...now that we have the 1986 law?

A You can write to your congressmen, work to throw out anti gun representatives, support NRA, the National Firearms Association, and the Second Amendment Foundation. Lobby the hell out of them so they know why you are there (they tend to forget, and, NRA especially, swallow the "duck hunting" interpretation of the 2nd Amendment). The Amnesty lasted for 30 days. He won't give us another, no matter how much we ask.

Q I was just going over the April issue of MGN and have a question on the BATF, NAF registration activity—Annual-

Comparison. In regards to the column under Form 4467 "Registration of Certain Firearms during November 1968" this is the famous Amnesty which lasted 30 whole days and was never to be seen again. Now, I see in '68 that 54,480 units were registered, then in 69 another 2001 units, I understand this could be back log. What I don't understand is units being registered as late as 1987. Are there special cases? How can they use a form that was obsolete in? days? I had an examiner in from ATF doing a physical inspection yesterday and she couldn't shed any light on it. Inquiring minds want to know!!

A The NFA Registry used to be on a Rolodex. No kidding. Updating the files has been subject to human error. BATF on several occasions has been asked in court if they can unequivocally say that they have complete records of all of the registered NFA firearms. They have answered "No". This is where the discrepancy in forms from the Amnesty come in. Every once in a while, someone tries to transfer a gun that NFA has no record of, and the owner shows the Amnesty form to them, and they must add it to the registry. I have heard of several unsuccessful forgeries, but NFA was able to see through them, so don't get any ideasthey prosecuted!
