An author should submit the original and one copy of the manuscript and retain one copy. The author may suggest an appropriate editor for his paper. It is recommended that the author acquaint himself with the pertinent material contained in "Information for Contributors to Mathematics of Computation" and "Manual for Authors," both of which are available upon request from the American Mathematical Society. All contributions intended for publication and all books for review should be addressed to Eugene Isaacson, Chairman, Editorial Committee, Mathematics of Computation, New York University, Courant Institute of Mathematical Sciences, 251 Mercer Street, New York, New York 10012. Institutions sponsoring research reported in the journal are assessed page charges.

Beginning with the January 1969 issue of MATHEMATICS OF COMPUTATION, an author's abstract is being published at the head of each article. Authors should submit a brief and reasonably self-contained abstract with each paper.
