An author should submit the original and one copy of the manuscript and retain one copy. The author may suggest an appropriate editor for his paper. It is recommended that the author acquaint himself with the pertinent material contained in "Information for Contributors to Mathematics of Computation" and "Manual for Authors," both of which are available upon request from the American Mathematical Society. All contributions intended for publication and all books for review should be addressed to James H. Bramble, Chairman, Editorial Committee, Mathematics of Computation, Department of Mathematics, Cornell University, Ithaca, New York 14850. Institutions sponsoring research reported in the journal are assessed page and microfiche charges. Each article submitted for publication must be accompanied by a brief and reasonably self-contained abstract, and by AMS (MOS) subject classification numbers. If a list of key words and phrases is included, it will be printed as a footnote on the first page. A list of the classification numbers may be found in the Index to Mathematical Reviews, Volume 39 (June 1970).
