Finally, we wish to highlight the increasing impact of *Mycorrhiza*. The CSI impact factor of the journal rose to 1.09 in 1999. This indication that articles are read and subsequently cited is especially gratifying for a relatively young, specialty journal like *Mycorrhiza*. We congratulate our editorial advisors, reviewers, and especially the authors of submitted works for attaining this level of distinction. We look forward to the engaging and stimulating volumes to come.
