## IMPORTANT NOTICE TO AUTHORS

1. Beginning with the October 1991 issue, *Organic Preparations and Procedures International* has used new computer-based technology for its cover-to-cover production, and all future issues will be prepared in this way. It is the hope of the Editors that the new technology will not only improve the presentation and readability of the Journal but will also have the practical benefit of substantially shortening the time between initial submission and final publication of an author's work. The directions for the submission of diskettes for those articles prepared on a word processor are given in the "Instructions for the Preparation of Manuscripts" which appear in each issue and are reproduced below. For those authors not able to send us diskettes, it is all the more imperative that we have a clear sharp original of the final text so that it may be scanned into our system by the Journal staff.
2. The Editors wish to urge authors to take great care in preparing, proofreading and typing their initial submissions by means of following the "Instructions for the Preparation of Manuscripts". In order to be able to give each paper fair and expeditious treatment, the Editors and referees should be fully focussed on its chemistry contents and not distracted by errors in typography, grammar and syntax. OPPI stands ready to assist authors whose first language is not English; even so, prior to the initial submission such authors should endeavor to seek help at their home institutions in the preparation of their manuscripts to assist the Editors and referees in making timely evaluations of the work. Carelessly prepared papers will be returned unedited. In this respect and in contrast to trends in the field over the past several years, the editorial policy of this Journal continues to strictly **require that satisfactory elemental analyses ( $\pm 0.30$ ) be reported for all new compounds**. Occasionally, exceptionally unstable materials may not themselves be properly analyzed; in such unusual cases it is expected that the intractable substances will have been degraded to known compounds for comparison with authentic standards or will have been derivatized to samples which may in their own turn be satisfactorily analyzed. Whenever known compounds are prepared, comparison of the appropriate physical constants with literature data must be made, including all proper literature citations. Manuscripts which do not meet these criteria for full characterization of all compounds prepared will be returned unedited.
3. OPPI will celebrate a quarter century of publication in 1993.

## NOTE TO AUTHORS OF PAPERS

If the text was prepared on a computer and can be saved on a 3.5 (or 5.25) inch disk [in the following formats; MSDOS (IBM compatible) - MacIntosh - ProDos (Apple II)], please send it along with the three hard copies of the text. Make sure that you indicate the name of the program used. We have the facilities to convert from several different formats without losing character attributes such as bold, Italics and superscript. For Structures, we can access Chemwindow, Chemintosh II, ChemDraw, ISIS Draw, EPS, PICT and TIFF. Please send an original copy of the document and if possible, an ASCII text file. This will allow us to expedite the processing of your paper and to enter any last minute correction. Thank you for your cooperation in this matter.
