## FULL DISCLOSURE POLICY OF THE AMERICAN ASSOCIATION OF PHARMACEUTICAL SCIENTISTS<sup>1</sup>

- 1. Authors of manuscripts submitted to *Pharmaceutical Research* are requested to state the source of all funding which enabled the research described to be undertaken.
- Podium presentations, posters, and abstracts intended for Association-sponsored scientific meetings, symposia, or workshops should likewise contain acknowledgment(s) of financial support.

These policies are proposed to minimize potential conflicts of interest which may arise in investigations funded by nongovernment sources. The arguments for such policies were eloquently presented in an editorial in the *New England Journal of Medicine* [*NEJM*, 310: 1182(1984)].

AAPS believes that compliance with these disclosure requests should be voluntary and that the absence of such a statement cannot preclude consideration of the reported work for publication or dissemination. It appears to AAPS that most of the pharmaceutical science community is already in compliance with these recommendations. However, formalization and statement of this policy seems, at this time, an appropriate means to ensure and strengthen the integrity and scientific credibility of pharmaceutical research.
