March 26-28, 1990. Topical Drug Products Workshop: Principles and Criteria for the Development and Optimization of Topical Therapeutic Products. An AAPS/FDA/Industry co-sponsored workshop is planned to discuss problems, issues and possible solutions in the development and optimization of dermatological topical drug products. The workshop will be held at the Hyatt Hotel, Crystal City, Virginia (about 1 mile from Washington, D.C. and National Airport) March 26-28, 1990. The major objectives of the workshop are to: Review and evaluate available information on topical drug products; Evaluate relationships between pharmacological activity, drug delivery and clinical efficacy; Identify important principles in the development and optimization of topical drug products; Identify ways to optimize topical drug delivery to target sites; Raise possible concerns related to the local and systemic toxicity problems arising from optimization of drug delivery; Discuss regulatory concerns in the evaluation of topical drug products.
