#### Small Pharma Approach for Predicting Human Pharmacokinetics Rene Braeckman, Ph.D.

This 45-minute course outlines a practical strategy for the implementation and integration of *in vitro* and *in vivo* preclinical testing for pharmacologic, pharmaceutic, PK, and toxicologic drug characteristics, for a young, small pharmaceutical company. As resources may be limited and most activities are outsourced, the "Small Pharma" implementation uses a tiered approach where fast, cheap, *in vitro* tests are done first, and more expensive, elaborate experiments (mostly *in vivo*) are done later. Therefore, particular attention is given to the sequence and the costs of experiments. To optimize decision-making, selection characteristics of the ideal drug candidate and go/no-go criteria are well defined at each stage.
