► Physical Pharmacy and Biopharmaceutics Section—focuses on a quantitative understanding of the intrinsic properties of the small drug molecule and the interacting biological system, enabling the selection of developable drug candidates and the identification of potential strategies for optimal drug delivery.

► Regulatory Sciences Section—analyses information on product performance, addresses issues regarding drug law and resultant regulations, and promotes science-based regulations to help drug regulatory agencies protect public health and safety.
