A. Sosa *et al.* (1977) *Phytochemistry* **16**, 707. The authors regret errors on p. 709: in the Experimental section 3rd para., lines 10 and 11, "25 mg/kg" should read "250 mg/kg" and "98 mg/kg" should read "980 mg/kg"; ref. [4], last line should read "40, 1084" instead of "33, 1050".

S. Marcinowski and H. Grisebach (1977) *Phytochemistry* **16**, 1665. The authors regret that in their paper the common name of the plant was given as "pine" instead of "spruce".

R. Hartenstein *et al.* (1977) *Phytochemistry* **16**, 1855. The authors regret that on p. 1856, the value of 3000 (2nd column, line 14) should be 500.

J. F. Manville *et al.* (1977) *Phytochemistry* **16** 1967. The publishers regret that on p. 1968, *Tree 1*, line 10, 4S was set instead of 4R. Also, the author wishes to clarify that subscripts 7 and 8 in formulae 3 and 4 refer to ¹³C-NMR assignments only; 3 and 4 are C-1' epimers of 1 and 5 respectively.

W. Vichniewski *et al.* (1977) *Phytochemistry* **16**, 2028. The authors regret that several assignments in Table 1 were inadvertently interchanged. Correct assignments are as follows:

C-19, 184.25s
C-1', 166.90s
C-2', 188.61d
C-7', 130.15d.

D. A. Okorie and D. A. H. Taylor (1977) *Phytochemistry* **16**, 2029. The authors regret that in structure 1, a C(Me)₂ group is missing from ring A between C-5 and the ring oxygen atom.

J. F. Treimer and M. H. Zenk (1978) *Phytochemistry* **17**, 227. The publishers regret that Figs. 3 and 4 were inadvertently transposed. The legends are correct. The authors also wish to

point out that due to a change in terminology "vincoside" (p. 229, 2nd column, lines 2 and 11) should read "strictosidine".

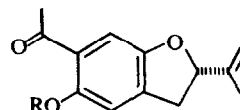
R. Tochesche and M. Spindler (1978) *Phytochemistry* **17**, 251. The publishers regret that on p. 251 (Abstract, line 3) "coladulcicine" should read "soladulcicine". Also, the last two lines of the first column ("aussagekräftig... zusammengefaßt") should be deleted and "5g" (p. 253, Experimenteller Teil, line 3) should read "15g".

W. Majak *et al.* (1978) *Phytochemistry* **17**, 301. The publishers regret that on p. 302 (line 21 of the Experimental section), "2A" was misprinted as "24".

A. Rother and A. E. Schwarting (1978) *Phytochemistry* **17**, 305. The publishers very much regret the omission of the authors' names from this article, which is being republished as a loose insert in this issue.

J. Chopin *et al.* (1978) *Phytochemistry* **17**, 332. The publishers regret that on p. 333, line 27 was repeated on line 24. Line 24 should read "methanes. The chelated phenolic hydroxyl groups".

F. Bohlmann *et al.* (1978) *Phytochemistry* **17**, 763. The authors regret that formula 14/15 was set incorrectly. The correct formula is:



Also, Table 2, "6-H" should be "7-H" and in the Experimental section (p. 765, 2nd column) compound 14, should be identified as "5-Hydroxy-6-acetyl".
