

Errata

In the January 2000 issue of the *Journal*, in table 2 of the article titled “The Number of Trait Loci in Late-Onset Alzheimer Disease” (66:196–204), by Daw et al., the apoE genotype counts (shown in parentheses in the

five “apoE Genotype” column heads) were scrambled; the correct counts are as follows: $\epsilon 4/\epsilon 4$ ($n = 67$), $\epsilon 3/\epsilon 4$ ($n = 207$), $\epsilon 2/\epsilon 4$ ($n = 15$), $\epsilon 3/\epsilon 3$ ($n = 111$), and $\epsilon 2/\epsilon 3$ ($n = 19$). The authors apologize for these errors.

In the April 2000 issue of the *Journal*, in the article titled “Homozygosity Mapping Identifies an Additional Locus for Wolfram Syndrome on Chromosome 4q” (66:1229–1236), by El-Shanti et al., the list of authors should have included two additional names, “Mary L. In the article “The Mutation Rate in the Human mtDNA Control Region” by Sigurðardóttir et al., on pages 1599–1609 (in this issue of the *Journal*), there is a notation error on page 1607: in the paragraph beginning

at the bottom of the left-hand column, in all three occurrences the subscript to “ k ” should be “ s ”; that is, the notation should be “ k_s ” (not “ k_a ”). The *Journal* regrets this error.

In the article “Mapping of a Locus for a Familial Autosomal Recessive Idiopathic Myoclonic Epilepsy of Infancy to Chromosome 16p13” by Zara et al., on pages 1552–1557 (in this issue of the *Journal*), the order of the “ θ ” column heads in table 1 (p. 1554) is incorrect: the θ values should have been listed in numerical order (whereas the values in the body of the table remain unchanged). The correct table is as shown here.
