

Dr. Hardy, our new Associate Editor, holds degrees from the University of Chicago (PhD-Physical Chemistry), the University of California (MS-Physical Chemistry) and the California Institute of Technology (BS-Chemistry).

Upon graduation he joined Allied Chemical Corporation in Glenholden, PA as a Research Chemist. When he left Allied in 1963 to join Celanese Research Company he was a group leader in polymer development.

He joined Celanese, in Summit, NJ, as a Senior Research Chemist.
