

EURADH '92—European Adhesion Congress and Exhibition

Karlsruhe (Germany) – 21–24 September 1992

Given the success of their recent conferences in the field of adhesion, held in Bordeaux/F and Bremen/D, ADHECOM, Société Française d'Adhésion et Adhésifs, DECHEMA Deutsche Gesellschaft für Chemisches Apparatewesen, Chemische Technik und Biotechnologie e.V. and DVS Deutscher Verband Schweißtechnik decided to organise a joint international congress. The topics will cover all aspects of adhesion science and technology including bonding, coating and paints, sealing, composites and other multicomponent materials, bioadhesion and biomaterials. It is planned to have plenary lectures, oral and poster presentations. In addition, industrial and scientific participants will be brought together in workshops and in an industrial exhibition.

The official languages will be English, French and German. Simultaneous translation will be provided.

The Scientific Committee, co-chaired by Professor W. Brockmann (Germany) and Professor J. Schultz (France), is composed of leading scientists from the European Community. The German-French cooperation and the choice of Karlsruhe, centrally located in Europe, could be considered as symbolic for the opening of the European single market.
