## PREPARATION OF CAMERA COPY (Communications Section)

For rapid publication of papers, authors must prepare their papers exactly as specified in the notes below, and submit them in triplicate. The preferred maximum size of submitted papers is 6 pages in the prescribed form (approximately 2000 words with 2 figures/tables).

Manuscripts must be typed on good quality white bond paper (8½ × 11" or A4) using a black ribbon, and preferably using an electric typewriter. Use single spacing or 1½ line spacing. The finished paper must be ready for direct litho reproduction, and hence must be clean and as neat as possible; messy erasures and alterations will show up in the printing.

The typing area is 5 in. wide by 8⅞ in. deep. However, the width may be exceeded by 2 or 3 characters if necessary.

On first page, leave ⅝ in. space, then type the paper title all in capitals, indented 5 spaces from left. Leave ½ in. space then type author's name in capitals, indented 5 spaces. Author's affiliation follows on the next line, in upper and lower case, indented 5 spaces. The next line should read: Submitted for publication ... (appropriate date). Leave ⅝ in. space then type abstract, all lines indented 5 spaces. Leave ½ in. space before the text begins.

Type text to full (5 in.) width. Main text headings should be typed in capitals, to the left. Leave extra space above and below headings. Second weight headings should be typed in upper and lower case, to the left. Indent all new paragraphs 5 spaces.

At the beginning of each page (except the first) type in capitals the author's name to the left on the left-hand (even-numbered) pages, and the paper title, to the right, on the right-hand (odd numbered) pages. Leave one line of white space before starting the text.

All equations and formulas should be typed in the appropriate place in the text. Where symbols cannot be typed, write them very neatly in black ink.

Type tables in the appropriate place in the text. Type TABLE 1, in capitals, then run on table title after 3 typewriter spaces. Add only three horizontal lines—at the top and bottom of each and one after column headings.

Figures should be reduced to the appropriate size, then pasted into the text. The figure captions should be typed as FIGURE 1, etc., then the caption run on after 3 typewriter spaces. Leave ½ in. space above the figures and also below the figure captions.

References should be indicated in the text by superior numbers. References must be listed at the end of the paper in numerical order. Author's initials should precede their names. Journal titles should be abbreviated according to *Chemical Abstracts* style and underlined. Also underline the volume number. Book titles should be spelled in full and underlined. Examples:

1. J. F. Nicholas, An Atlas of Models of Crystal Surfaces (Gordon and Breach, New York, 1965), p. 201.
2. R. Gledhill and A. Kinloch, J. Adhesion 6, 315 (1974).

Type footnotes on the appropriate page of the text. Precede footnotes by a short horizontal line (5 units long). Add 1 line space above footnotes.

Do not type page numbers. Number the pages in light blue pencil in the top right hand corners.

Camera-copy manuscripts should not be folded. Enclose between card-boards for posting.
