

THE CATEGORY OF D -COMPLETELY REGULAR SPACES IS SIMPLE

ABSTRACT. In a recent paper H. Brandenburg characterized the objects of the epireflective hull of all developable spaces—that are those spaces which are homeomorphic to a subspace of a product of developable spaces—by intrinsic properties. It is shown here that these spaces, called D -completely regular, can be generated from a single second countable developable space $\mathbf{D}$ which has the same cardinality as the reals. As an application of this result we obtain a new characterization of D -normal spaces analogous to Urysohn's lemma and a new (external) characterization of perfect spaces (meaning every closed set is a G_δ).

1. Introduction. Completely regular spaces are generated by the class $\mathcal{P}$ of pseudometrizable spaces in the sense that every completely regular topology is initial with respect to all continuous mappings into objects of $\mathcal{P}$. In fact, as is obvious from the definition of a completely regular space, there is a single object in $\mathcal{P}$, namely the unit interval with its natural topology, that generates CompReg , the category of completely regular spaces.

In [2], [3] and [4] Brandenburg enlarged this framework by substituting for $\mathcal{P}$ the class $\mathcal{D}$ of developable spaces and characterized those spaces, here called D -completely regular spaces, which are generated by $\mathcal{D}$. In further papers [2], [5], [6], [7] he showed that a number of theorems valid in the old framework, e.g. Urysohn's and Nagata's metrization theorems, have nice counterparts in the new one. However, the question whether the analogy between these two settings would go so far as that there exists a single developable space generating all D -completely regular spaces remained open (see Problem 5.3 in [4]). We give here an affirmative answer by showing that it is even the unit interval that can be equipped with a developable and second countable topology that generates all D -completely regular spaces. As an application of this result we derive new characterizations for D -normal spaces, which were introduced in [2] and [5].

2. Notations and preliminaries. Topological spaces will simply be called spaces throughout this paper. Together with the continuous mappings they constitute the category Top . A subcategory $\mathcal{K}$ of Top is called *epireflective*, if it is closed with respect to the formation of products and subobjects. Here, all subcategories are assumed to be nonempty, full and isomorphism-closed. Every subcategory $\mathcal{K}$ is

contained in a smallest epireflective subcategory, its *epireflective hull*, which we denote by $\text{EH}(\mathcal{K})$. In accordance with many authors (see e.g. [9], [14], [15]) objects of $\text{EH}(\mathcal{K})$ are called $\mathcal{K}$ -completely regular. They are precisely those spaces that are homeomorphic to a subspace of a product of $\mathcal{K}$ -objects.

A subcategory $\mathcal{K}$ of Top is called *bireflective* if it is closed with respect to the formation of initial sources, i.e. whenever X carries the initial topology with respect to a family $(f_i: X \rightarrow K_i)_{i \in I}$ of maps into $\mathcal{K}$ -objects, then X belongs to $\mathcal{K}$. Every subcategory $\mathcal{K}$ of Top is contained in a smallest bireflective subcategory, its *bireflective hull*, which we denote by $\text{BH}(\mathcal{K})$. A space X belongs to $\text{BH}(\mathcal{K})$ iff X is initial with respect to the family of all continuous maps into $\mathcal{K}$ -objects, i.e. whenever a subset A of X is closed in X and $x \in X \setminus A$, then there exist finitely many $\mathcal{K}$ -objects $K_1, \dots, K_n$, open subsets $B_i \subset K_i$ for each i and continuous functions $f_i: X \rightarrow K_i$ such that

$$x \in f_1^{-1}[B_1] \cap \dots \cap f_n^{-1}[B_n] \subset X \setminus A.$$

A subcategory $\mathcal{K}$ of Top is called *simple*, if there exists a space E such that $\text{EH}(\{E\}) = \mathcal{K}$.

The reader will find more details on these categorical aspects in [11]. A space X is called *developable* [1] if there is a countable family $(\mathcal{Q}_i)_{i \in \mathbb{N}}$ of open covers of X such that $\{\text{St}(x, \mathcal{Q}_i) | i \in \mathbb{N}\}$ is a neighborhood base for every $x \in X$. We denote the subcategory of all developable spaces by $\mathfrak{D}$. A base $\mathcal{L}$ for the closed sets of a space X is called G_δ -base, if for every $B \in \mathcal{L}$ there exists a countable family $(B_i)_{i \in \mathbb{N}} \subset \mathcal{L}$ with $X \setminus B = \bigcup_{i \in \mathbb{N}} B_i$. In [3] Brandenburg characterized D -completely regular spaces by means of G_δ -bases: A space X is D -completely regular iff X has a G_δ -base. The subcategory of all D -completely regular spaces (resp. T_1 -spaces) is denoted by $\mathfrak{D}\text{-CompReg}$ (resp. $\mathfrak{D}\text{-CompReg-1}$).

3. The class of D -completely regular spaces is simple.

3.1. We denote by $\mathbb{N}$ the positive integers, by $\mathbb{N}_0$ the nonnegative integers, and by K the set $\{-1\} \cup \mathbb{N}_0 \cup (\mathbb{N}_0 \times \mathbb{N}) \cup (\mathbb{N}_0 \times \mathbb{N} \times \mathbb{N}) \cup \dots$. Since K is countable there exists a bijection $\phi: K \rightarrow \mathbb{N}$. Define $D := \mathbb{N}^{\mathbb{N}} \cup \{a, b\}$, where $\mathbb{N}^{\mathbb{N}} = \{f: \mathbb{N} \rightarrow \mathbb{N}\}$, $a \neq b$ and $a, b \notin \mathbb{N}^{\mathbb{N}}$. For every $n \in \mathbb{N}$ the n th projection $p_n: \mathbb{N}^{\mathbb{N}} \rightarrow \mathbb{N}$ is defined by $p_n(f) = f(n)$. We consider p_n^{-1} in a natural way as a correspondence from $\mathbb{N}$ to D . This allows us to define the following countable family of subsets of D :

$$\begin{aligned} A(-1) &:= \{a\}, & A(0) &:= \{b\}, \\ A(n_1) &:= \{b\} \cup p_{\phi(-1)}^{-1}[\{1, \dots, n_1\}] \quad \text{for every } n_1 \in \mathbb{N}. \end{aligned}$$

Assume now that $A(n_1, \dots, n_k)$ has been defined for $(n_1, \dots, n_k) \in K \setminus \{-1\}$. We then proceed inductively by setting

$$A(n_1, \dots, n_k, n_{k+1}) := (\{a\} \cup p_{\phi(n_1, \dots, n_k)}^{-1}[\{1, \dots, n_{k+1}\}]) \setminus A(n_1, \dots, n_k)$$

if k is odd and $n_{k+1} \in \mathbb{N}$, and

$$A(n_1, \dots, n_k, n_{k+1}) := (\{b\} \cup p_{\phi(n_1, \dots, n_k)}^{-1}[\{1, \dots, n_{k+1}\}]) \setminus A(n_1, \dots, n_k)$$

if k is even and $n_{k+1} \in \mathbb{N}$.

Let $\mathfrak{D}'$ denote the family of all $A(n_1, \dots, n_k)$ obtained in this way and $\mathfrak{D}$ all finite unions of elements of $\mathfrak{D}'$. Clearly, $\mathfrak{D}$ is a base for the closed sets of a topology on D . The space thus obtained is denoted $\mathbf{D}$.

3.2. THEOREM. $\mathbf{D}$ is a second countable developable space.

PROOF. It is well known from [5] that every D -completely regular second countable space is developable. Since $\mathfrak{D}$ is countable it suffices to show that every element of $\mathfrak{D}$ is a G_δ -set. But this follows easily from the fact that every $A(n_1, \dots, n_k)$ is a G_δ -set and finite unions of G_δ -sets are again G_δ -sets.

We will henceforth make no notational difference between the space $\mathbf{D}$ and the underlying set of $\mathbf{D}$.

3.3. REMARKS. (1) To provide more insight into the structure of $\mathbf{D}$ we give here an explicit construction for a development of $\mathbf{D}$:

For $n \in \mathbb{N}_0$ define $\mathcal{Q}(n) := \{\mathbf{D} \setminus A(n), \mathbf{D} \setminus A(-1)\}$ and for $(n_1, \dots, n_k) \in K$, $k > 1$, we set

$$\mathcal{Q}(n_1, \dots, n_k) := \{\mathbf{D} \setminus A(n_1, \dots, n_k), \mathbf{D} \setminus A(n_1, \dots, n_{k-1})\}.$$

Let $\Psi: \mathbb{N} \rightarrow K \setminus \{-1\}$ be a bijection. We then define $\mathcal{L}(1) := \mathcal{Q}(\Psi(1))$, and if, for $n \in \mathbb{N}$, $\mathcal{L}(n)$ is given, we set

$$\mathcal{L}(n+1) := \mathcal{L}(n) \wedge \mathcal{Q}(\Psi(n+1))$$

where $\wedge$ denotes elementwise intersection. It is easily verified that the countable family $\beta = \{\mathcal{L}(n) | n \in \mathbb{N}\}$ is a development for $\mathbf{D}$.

(2) $\mathbf{D}$ is an R_0 -space¹ since it is developable. However, $\mathbf{D}$ is not T_0 : Define $f: \mathbb{N} \rightarrow \mathbb{N}$ and $g: \mathbb{N} \rightarrow \mathbb{N}$ by

$$f(n) := \begin{cases} 2 & \text{if } n = \phi(-1), \\ 1 & \text{otherwise,} \end{cases} \quad \text{and} \quad g(n) := \begin{cases} 2 & \text{if } n = \phi(-1), \\ 2 & \text{if } n = \phi(2), \\ 1 & \text{otherwise.} \end{cases}$$

Then the only difference between f and g is their value in the $\phi(2)$ th component. Let us assume that there exists an open set B such that $f \notin B$ and $g \in B$. We may assume that

$$B = \mathbf{D} \setminus \cup \{A(k) | k \in K', K' \subset K \text{ finite}\}.$$

This implies $f \in A(k)$ and $g \notin A(k)$ for some $k \in K$. But the only $A(k)$'s cutting into the $\phi(2)$ th component are of the form $A(2, n)$ for $n \in \mathbb{N}$. Hence, there is $n \in \mathbb{N}$ with $f \in A(2, n)$ and $g \notin A(2, n)$. Since $\mathbf{D} \setminus A(2) = \cup_{n \in \mathbb{N}} A(2, n)$ this implies $f \notin A(2)$ —a contradiction because $f \in p_{\phi(-1)}^{-1}(2) \subset A(2)$. The same argumentation is still valid if the roles of f and g are interchanged.

3.4. LEMMA. Let X be a space, and A, B two disjoint closed sets with the property that there is a countable family $\mathcal{L}$ of closed sets satisfying the following conditions:

- (1) $\{A, B\} \subset \mathcal{L}$,
- (2) for every $B \in \mathcal{L}$ there is a family $(B(n))_{n \in \mathbb{N}} \subset \mathcal{L}$ with

$$X \setminus B = \bigcup \{B(n) | n \in \mathbf{N}\},$$

(3) $\mathcal{L}$ is closed with respect to finite unions.

Then there exists a continuous mapping $f: X \rightarrow \mathbf{D}$ such that $f^{-1}(a) = A$ and $f^{-1}(b) = B$.

PROOF. For every $(n_1, \dots, n_k) \in K = \{-1\} \cup \mathbf{N}_0 \cup (\mathbf{N}_0 \times \mathbf{N}) \cup (\mathbf{N}_0 \times \mathbf{N} \times \mathbf{N}) \cup \dots$ we define a set $C(n_1, \dots, n_k) \in \mathcal{L}$ by induction. Define $C(-1) := A$ and $C(0) := B$. According to condition (2) there exists a family $(B(n))_{n \in \mathbf{N}} \subset \mathcal{L}$ with $X \setminus A = \bigcup \{B(n) | n \in \mathbf{N}\}$. Define for $n \in \mathbf{N}$ $C(n) := B \cup \bigcup \{B(l) | l \leq n\}$. We assume that $C(n_1, \dots, n_k) \in \mathcal{L}$ is given for $(n_1, \dots, n_k) \in K \setminus \{-1\}$. Then there exists a family $(D(n))_{n \in \mathbf{N}} \subset \mathcal{L}$ such that

$$X \setminus C(n_1, \dots, n_k) = \bigcup \{D(n) | n \in \mathbf{N}\}.$$

Define, in case k is odd,

$$C(n_1, \dots, n_k, n_{k+1}) := A \cup \bigcup \{D(l) | l \leq n_{k+1}\},$$

and, if k is even,

$$C(n_1, \dots, n_k, n_{k+1}) := B \cup \bigcup \{D(l) | l \leq n_{k+1}\}.$$

For $x \in X$ let $K(x) := \{(n_1, \dots, n_k) \in K | x \in C(n_1, \dots, n_k)\}$. Recall that for every $k \in K$ a set $A(k) \subset \mathbf{D}$ was defined in 3.1. We assert now, that for every $x \in X$ the set

$$S(x) := \bigcap \{A(k) | k \in K(x)\}$$

is nonempty.

Let $x \in X$ be arbitrarily given. If $x \in A$, then we clearly obtain $S(x) = \{a\}$, and similarly $S(x) = \{b\}$ if $x \in B$. We assume $x \in X \setminus (A \cup B)$. Define

$$K_{\min}(x) := \{(n_1, \dots, n_k) \in K(x) | n_k = 1 \text{ or } x \notin C(n_1, \dots, n_{k-1})\}.$$

Note that $C(n_1, \dots, n_k) \subset C(n_1, \dots, \bar{n}_k)$ whenever $n_k \leq \bar{n}_k$. If $(n_1, \dots, n_{k-1}, n_k) \in K_{\min}(x)$ and $(n_1, \dots, n_{k-1}, \bar{n}_k) \in K_{\min}(x)$, this implies $n_k = \bar{n}_k$. Therefore, the mapping $g: \mathbf{N} \rightarrow \mathbf{N}$, defined below, is well defined:

$$g(i) := \begin{cases} n_1, & \text{if } i = \phi(-1), \text{ where } n_1 \text{ denotes the unique element of } K_{\min}(x) \\ & \text{having just one component,} \\ n_k, & \text{if } i = \phi(n_1, \dots, n_{k-1}) \text{ and } (n_1, \dots, n_k) \in K_{\min}(x) \text{ and } k > 1, \\ 1, & \text{otherwise.} \end{cases}$$

We prove by induction

$$g \in A(n_1, \dots, n_k) \Leftrightarrow (n_1, \dots, n_k) \in K(x).$$

Assume $k = 1$. Then $(n_1) \in K(x)$ implies $x \in C(n_1)$; hence $g(\phi(-1)) \leq n_1$ and we obtain $g \in A(n_1)$. Conversely, $g \in A(n_1)$ implies $g(\phi(-1)) \leq n_1$, and we conclude $(n_1) \in K(x)$.

Assume $k > 1$ and the assertion to be true for all $l < k$. If $(n_1, \dots, n_k) \in K(x)$, then $x \in C(n_1, \dots, n_k) \subset X \setminus C(n_1, \dots, n_{k-1})$. Hence, $x \notin C(n_1, \dots, n_{k-1})$ which implies $(n_1, \dots, n_{k-1}) \notin K(x)$. Using the assertion for $k - 1$ we obtain $g \notin A(n_1, \dots, n_{k-1})$. Since $g(\phi(n_1, \dots, n_{k-1})) \leq n_k$ this implies

$g \in A(n_1, \dots, n_k)$. Conversely, we assume $g \in A(n_1, \dots, n_k)$ which yields $g(\phi(n_1, \dots, n_{k-1})) \leq n_k$ and $g \notin A(n_1, \dots, n_{k-1})$. Therefore, $(n_1, \dots, n_{k-1}) \notin K(x)$ which implies $x \notin C(n_1, \dots, n_{k-1})$. Since $X \setminus C(n_1, \dots, n_{k-1}) = \bigcup_{l \in \mathbb{N}} C(n_1, \dots, n_{k-1}, l)$ there exists $l \in \mathbb{N}$ with $x \in C(n_1, \dots, n_{k-1}, l)$. Hence

$$g(\phi(n_1, \dots, n_{k-1})) = \min\{l \in \mathbb{N} \mid x \in C(n_1, \dots, n_{k-1}, l)\}$$

which yields $x \in C(n_1, \dots, n_k)$, i.e. $(n_1, \dots, n_k) \in K(x)$. It is now obvious that $S(x) \neq \emptyset$ since $g \in S(x)$.

We are now prepared to define a mapping $f: X \rightarrow \mathbf{D}$ by assigning to every $x \in X$ an arbitrary element $f(x)$ from $S(x)$. To show that f is continuous it is evidently sufficient to show that for every $(n_1, \dots, n_k) \in K$, $f^{-1}[A(n_1, \dots, n_k)]$ is closed in X . Therefore, let $(n_1, \dots, n_k) \in K$ be given. We show that

$$f^{-1}[A(n_1, \dots, n_k)] = C(n_1, \dots, n_k),$$

which implies immediately that f is continuous since all C 's are closed. Let $x \in C(n_1, \dots, n_k)$ be given. Then

$$f(x) \in S(x) = \bigcap \{A(\bar{n}_1, \dots, \bar{n}_l) \mid x \in C(\bar{n}_1, \dots, \bar{n}_l)\} \subset A(n_1, \dots, n_k);$$

hence $x \in f^{-1}[A(n_1, \dots, n_k)]$. Conversely assume $x \in f^{-1}[A(n_1, \dots, n_k)]$, i.e. $f(x) \in A(n_1, \dots, n_k)$, and, moreover, $x \notin C(n_1, \dots, n_k)$. Then there exists $i \in \mathbb{N}$ such that $x \in C(n_1, \dots, n_k, i)$ in case $n_1 \geq 0$, or $x \in C(i)$ in case $n_1 = -1$. This implies, as shown above, $f(x) \in A(n_1, \dots, n_k, i)$ in case $n_1 \geq 0$ and $f(x) \in A(i)$ in case $n_1 = -1$, but in any case a contradiction to $f(x) \in A(n_1, \dots, n_k)$ since $A(n_1, \dots, n_k) \cap A(n_1, \dots, n_k, i) = \emptyset$ ($A(-1) \cap A(i) = \emptyset$, respectively). The last argumentation yields, in particular, $f^{-1}(a) = f^{-1}[A(-1)] = C(-1) = A$, and similarly $f^{-1}(b) = B$.

3.5. THEOREM. *The class of D-completely regular spaces is simply generated by $\mathbf{D}$, i.e. $\text{EH}(\{\mathbf{D}\}) = \mathfrak{D}\text{-CompReg}$.*

PROOF. Since $\mathbf{D}$ is not T_0 , the epireflective hull and the bireflective hull of $\mathbf{D}$ coincide [12], [13]. We show that, for an arbitrary D -completely regular space X and for $x \in X \setminus D$, where D is closed in X , there exists a continuous mapping $f: X \rightarrow \mathbf{D}$ and an open set V in $\mathbf{D}$ such that $x \in f^{-1}[V] \subset X \setminus D$.

Choose a G_δ -base $\mathcal{L}'$ for the closed sets of X . Then $\mathcal{L} := \bigwedge \bigvee \mathcal{L}'$ is a G_δ -base which is closed with respect to finite unions, where $\bigwedge \bigvee \mathcal{L}'$ denotes the family of all finite intersections of finite unions of elements of $\mathcal{L}'$ [2, 3.1.17]. There exists $A \in \mathcal{L}$ such that $x \in X \setminus A \subset X \setminus D$, and, since there is a family $(B(n))_{n \in \mathbb{N}} \subset \mathcal{L}$ with $\bigcup \{B(n) \mid n \in \mathbb{N}\} = X \setminus A$, $B \in \mathcal{L}$, such that $x \in B$ and $A \cap B = \emptyset$. Clearly, the conditions of Lemma 3.4 are fulfilled for A , B and $\mathcal{L}$. We conclude therefore, that a continuous map $f: X \rightarrow \mathbf{D}$ exists, fulfilling $f^{-1}(a) = A$ and $f^{-1}(b) = B$. Since $V := \mathbf{D} \setminus \{a\}$ is open, we obtain $x \in f^{-1}[V] = X \setminus A \subset X \setminus D$.

To show the converse assume that X is initial with respect to the family of all continuous maps to $\mathbf{D}$. We constructed in 3.1 a family $\mathfrak{D}$ of subsets of $\mathbf{D}$ and we remarked in 3.2 that $\mathfrak{D}$ is a G_δ -base for the closed sets of $\mathbf{D}$. Define $\mathfrak{B}' := \{f^{-1}[A] \mid A \in \mathfrak{D}, f: X \rightarrow \mathbf{D} \text{ continuous}\}$ and $\mathfrak{B} := \bigwedge \bigvee \mathfrak{B}'$. We show that

$\mathfrak{B}$ is a G_δ -base for X : Clearly, $\mathfrak{B}$ is a base. Let $B \in \mathfrak{B}$ be given. Then $B = \bigcap_{i=1}^n C_i$ and $C_i = \bigcup_{j \in M_i} D_{ij}$ for all $i \in \{1, \dots, n\}$, where $M_i = \{1, \dots, m_i\} \subset \mathbb{N}$ and $D_{ij} = f_{ij}^{-1}[A_{ij}]$ for some continuous functions $f_{ij}: X \rightarrow \mathbf{D}$ and $A_{ij} \in \mathfrak{D}$. An easy computation yields

$$B = \bigcup \{D_{l_1} \cap \dots \cap D_{l_n} | (j_1, \dots, j_n) \in M_1 \times \dots \times M_n\}.$$

This implies

$$X \setminus B = \bigcap \{(X \setminus D_{l_1}) \cup \dots \cup (X \setminus D_{l_n}) | (j_1, \dots, j_n) \in M_1 \times \dots \times M_n\}.$$

Since there exists for every $i \in \{1, \dots, n\}$ and every $j \in M_i$ a countable family $(E(i, j, k))_{k \in \mathbb{N}} \subset \mathfrak{D}$ such that $\mathbf{D} \setminus A_{ij} = \bigcup_{k \in \mathbb{N}} E(i, j, k)$ we can write

$$X \setminus B = \bigcap \left\{ \left(\bigcup_{k \in \mathbb{N}} f_{l_1}^{-1}[E(1, j_1, k)] \right) \cup \dots \cup \left(\bigcup_{k \in \mathbb{N}} f_{l_n}^{-1}[E(n, j_n, k)] \right) \right\} \\ (j_1, \dots, j_n) \in M_1 \times \dots \times M_n \}.$$

Now define $L := M_1 \times \dots \times M_n$ and for $l = (j_1, \dots, j_n) \in L$

$$F(l, k) := f_{l_1}^{-1}[E(1, j_1, k)] \cup \dots \cup f_{l_n}^{-1}[E(n, j_n, k)].$$

Note that $F(l, k) \in \bigvee \mathfrak{B}'$. The above expression can now be reformulated as

$$X \setminus B = \bigcap \left\{ \bigcup_{k \in \mathbb{N}} F(l, k) | l \in L \right\} = \bigcup_{g \in \mathbb{N}^L} \bigcap_{l \in L} F(l, g(l)).$$

Since L is finite we obtain $\bigcap_{l \in L} F(l, g(l)) \in \mathfrak{B}$ for every $g \in \mathbb{N}^L$. Hence, $X \setminus B$ is expressed above as a countable union of elements of $\mathfrak{B}$. This proves that $\mathfrak{B}$ is a G_δ -base and that X is D -completely regular.

4. The class of D -completely regular T_1 -spaces is simple. For an R_0 -space X and $x, y \in X$ we define $x \sim y$ iff $\text{cl}\{x\} = \text{cl}\{y\}$. Then $\sim$ is an equivalence relation and the set ωX of equivalence classes equipped with the final topology with respect to the natural mapping $\omega: X \rightarrow \omega X$ is usually called the T_1 -reflection of X . Since $\mathbf{D}$ is developable, $\omega \mathbf{D}$, which we denote henceforth by $\mathbf{D}_1$, is a developable second countable T_1 -space [16].

4.1. THEOREM. *The class of D -completely regular T_1 -spaces is simply generated by $\mathbf{D}_1$.*

PROOF. Since $\mathbf{D}$ is initial with respect to ω and $\mathbf{D}_1$, we have $\text{BH}(\{\mathbf{D}_1\}) = \mathfrak{D}$ -CompReg. From [12, 3.4.2(1)] and [13, Theorem 3] it can easily be derived that for every class $\mathcal{K}$ of T_1 -spaces $\text{EH}(\mathcal{K}) = \text{BH}(\mathcal{K}) \cap \{T_1\text{-spaces}\}$ always holds. This implies the assertion.

4.2. PROPOSITION. $\mathbf{D}_1$ has cardinality c .

PROOF. $\mathbf{D}_1$ has obviously cardinality less than or equal to c . We prove the assertion by mapping $\{1, 2\}^{\mathbb{N}}$ into $\mathbf{D}$ by a map x such that $\omega \circ x$ is an injection.

Let $f \in \{1, 2\}^{\mathbb{N}}$ be given. Then $L := \{s_i | i \in \mathbb{N}_0\}$, where $s_0 = -1$, $s_1 = f(1)$, $\dots$, $s_i = (f(1), \dots, f(i))$, is a subset of K , which was defined in §3. Define

$x(f) := (n_1, n_2, \dots) \in \mathbb{N}^{\mathbb{N}}$, where

$$n_{\phi(k)} = \begin{cases} f(i+1) + 1, & \text{if } k = s_i \text{ for some } i \in \mathbb{N}_0, \\ 1, & \text{otherwise.} \end{cases}$$

Then $x(f) \in A(f(1)+1) \setminus A(f(1))$ holds and one shows by induction for all $n \in \mathbb{N}$, $n > 1$,

$$x(f) \in A(f(1), f(2), \dots, f(n-1), f(n)+1) \setminus A(f(1), \dots, f(n)).$$

Let $f, g \in \{1, 2\}^{\mathbb{N}}$ be given with $f \neq g$. Define

$$n := \min\{i \in \mathbb{N} \mid f(i) \neq g(i)\}.$$

We assume for simplicity that $f(n) = 1$ and $g(n) = 2$. From the argumentation above we obtain $x(f) \in A(f(1), \dots, f(n-1), 2)$ and

$$x(g) \in A(f(1), \dots, f(n-1), 3) \setminus A(f(1), \dots, f(n-1), 2).$$

Since $A(f(1), \dots, f(n-1), 2)$ is closed, this implies $\text{cl}\{x(f)\} \neq \text{cl}\{x(g)\}$ and hence $\omega \circ x$ is an injection.

In consequence of Proposition 4.2 the unit interval $[0, 1]$ can be equipped with a topology such that the resulting space I is homeomorphic to $\mathbf{D}_1$, and that a corresponds to 0 and b corresponds to 1. Hence I is a developable and second countable T_1 -space.

4.3. COROLLARY. *A topological space X is D-completely regular iff for all $x \in X$ and closed sets $A \subset X$ with $x \in X \setminus A$ there exists a continuous function $f: X \rightarrow I$ such that $f(x) = 0$ and $f(y) = 1$ for all $y \in A$.*

Lemma 3.4 and the construction of $\mathbf{D}_1$ above have an immediate consequence for perfect spaces. Recall that a space is called *perfect* if every closed set is a G_δ . Clearly, every developable space is perfect.

4.4. THEOREM. *The following conditions are equivalent for a space X .*

- (1) X is perfect,
- (2) for every pair of disjoint closed subsets A and B of X there exists a continuous function $f: X \rightarrow \mathbf{D}_1$ and distinct points a and b in $\mathbf{D}_1$ such that $f^{-1}(a) = A$ and $f^{-1}(b) = B$,
- (3) for every closed subset A of X there exists a continuous function $f: X \rightarrow \mathbf{D}_1$ and $a \in \mathbf{D}_1$ such that $f^{-1}(a) = A$.

In [7] a class $\mathfrak{E}$ of spaces was called *adequate for functional separation*, if for every space X and every pair of disjoint $\mathfrak{E}$ -closed subsets A and B of X there exists an $\mathfrak{E}$ -object E , two distinct points a and b in E , and a continuous function $f: X \rightarrow E$ such that $\text{cl } f[A] \subset \{a\}$ and $\text{cl } f[B] \subset \{b\}$. It remained open in the above-mentioned paper, whether the class of developable spaces is adequate for functional separation.

4.5. PROPOSITION. *The class $\mathfrak{D}$ of developable spaces is adequate for functional separation.*

PROOF. Let $\mathfrak{D}$ -closed disjoint subsets A and B of a space X be given. Then there exist developable spaces Y_1 and Y_2 , closed subsets C_1 of Y_1 and C_2 of Y_2 , and

continuous functions $f_1: X \rightarrow Y_1$ and $f_2: X \rightarrow Y_2$ with $f_1^{-1}[C_1] = A$ and $f_2^{-1}[C_2] = B$. The initial topology $\mathcal{X}$ on X with respect to f_1 and f_2 is developable, and it is easily verified that $\text{cl}_{\mathcal{X}}A \cap \text{cl}_{\mathcal{X}}B = \emptyset$. The assertion follows now immediately from Theorem 4.4.

5. D -normal spaces. Normal space can be viewed as those spaces X with the property that for every pair of disjoint closed sets A and B in X there exists a pseudometrizable space Y and a continuous mapping $f: X \rightarrow Y$ such that $\text{cl } f[A] \cap \text{cl } f[B] = \emptyset$. In analogy Brandenburg [2, 3.1.24], defined a space X to be D -normal, if for every pair of disjoint closed sets A and B there exists a developable space Y and a continuous mapping $f: X \rightarrow Y$ such that $\text{cl } f[A] \cap \text{cl } f[B] = \emptyset$.

The following result provides characterizations of D -normal spaces analogous to the separation of disjoint closed sets by disjoint open sets and Urysohn's lemma for normal spaces.

5.1. THEOREM. *For a space X the following conditions are equivalent.*

- (1) X is D -normal,
- (2) for every pair of disjoint closed sets A and B there exist disjoint closed G_δ -sets C and D such that $A \subset C$ and $B \subset D$,
- (3) whenever A is closed and contained in an open set U , there exists an open F_σ -set F with $A \subset F \subset U$,
- (4) whenever A is closed and contained in an open set U , there exists a closed G_δ -set G with $A \subset G \subset U$,
- (5) for every pair of disjoint closed sets A and B there exists a continuous mapping $h: X \rightarrow I$ such that $h(x) = 0$ whenever $x \in A$ and $h(x) = 1$ whenever $x \in B$.

PROOF. (1) $\Rightarrow$ (2). Let disjoint closed sets A and B be given. Then there exists a developable space Y and a continuous map $f: X \rightarrow Y$ such that $\text{cl } f[A] \cap \text{cl } f[B] = \emptyset$. Since developable spaces are perfect, $\text{cl } f[A]$ and $\text{cl } f[B]$ are closed G_δ -sets in Y . This implies that $C := f^{-1}[\text{cl } f[A]]$ and $D := f^{-1}[\text{cl } f[B]]$ are G_δ -sets in X with the desired properties.

(2) $\Rightarrow$ (3) $\Rightarrow$ (4) is clear. (4) $\Rightarrow$ (5). Let disjoint closed sets A and B be given. We define for every

$$(n_1, \dots, n_k) \in K' = N_0 \cup (N \times N) \cup (N \times N \times N) \cup \dots$$

a closed G_δ -set $G(n_1, \dots, n_k)$. From (4) we obtain a closed G_δ -set $A(0)$ with $A \subset A(0) \subset X \setminus B$. Since $A(0)$ is G_δ there is a family $(F(n))_{n \in N}$ of closed sets such that $A(0) = \bigcap \{X \setminus F(n) | n \in N\}$, and for each $n \in N$ there exists a closed G_δ -set $A(n)$ with $F(n) \subset A(n) \subset X \setminus A(0)$. Now let the closed G_δ -set $A(n_1, \dots, n_k)$ be defined. Then there exists a family $(H(n))_{n \in N}$ of closed sets such that

$$A(n_1, \dots, n_k) = \bigcap \{X \setminus H(n) | n \in N\},$$

and for every $n \in N$ there exists a closed G_δ -set $A(n_1, \dots, n_k, n)$ such that

$$H(n) \subset A(n_1, \dots, n_k, n) \subset X \setminus A(n_1, \dots, n_k).$$

We define

$$\mathcal{L}(A) := \{A(n_1, \dots, n_k) | (n_1, \dots, n_k) \in K'\},$$

and by proceeding analogously for B we obtain

$$\mathcal{L}(B) = \{B(n_1, \dots, n_k) | (n_1, \dots, n_k) \in K'\},$$

starting with a closed G_δ -set $B(0)$ which satisfies $B \subset B(0) \subset X \setminus A(0) \subset X \setminus A$.

Let $\mathcal{L}$ denote the set of all finite intersections of finite unions of elements of $\mathcal{L}(A) \cup \mathcal{L}(B)$. The property of $\mathcal{L}(A) \cup \mathcal{L}(B)$ that for every $D \in \mathcal{L}(A) \cup \mathcal{L}(B)$ there exists a family $(D(i))_{i \in \mathbb{N}} \subset \mathcal{L}(A) \cup \mathcal{L}(B)$ such that

$$X \setminus D = \bigcup \{D(i) | i \in \mathbb{N}\}$$

is still valid for $\mathcal{L}$. The proof is identical to that of 3.1.17 in [2]. Thus $\mathcal{L}$ fulfills all conditions of Lemma 3.4 which yields a continuous function $f: X \rightarrow \mathbf{D}$ with $f^{-1}(a) = A(0)$ and $f^{-1}(b) = B(0)$. Combining the natural mapping $\omega: \mathbf{D} \rightarrow \mathbf{D}_1$ with the homeomorphism between $\mathbf{D}_1$ and I we obtain a continuous function $g: \mathbf{D} \rightarrow I$ with $g(a) = 0$ and $g(b) = 1$. Hence $h := g \circ f: X \rightarrow I$ has the desired properties $h[A] \subset \{0\}$ and $h[B] \subset \{1\}$. (5) $\Rightarrow$ (1) is trivial. Thus, the proof is complete.

The following statement is obvious from Theorem 5.1.

5.2. COROLLARY. *Every perfect space is D-normal.*

The results obtained here and in [2], [3], [5] and [6] encourage further research on the relationships between developable, D -normal and D -completely regular spaces viewed as being "symmetric" to pseudometrizable, normal and completely regular spaces. A promising extension of this new framework is motivated by condition (3) of Theorem 5.1: Call a space X D -regular if every point $x \in X$ has a neighborhood base consisting of open F_σ -sets. In addition to the obvious implications it is already known from [5] that every D -regular Lindelöf space is D -normal. Further results on D -regular spaces are contained in a forthcoming paper of the author [10].

6. Acknowledgements and remarks. During the preparation of this paper the author was informed that A. Mysior from Gdansk University, Poland, proved independently the simplicity of $\mathfrak{D}$ -CompReg and $\mathfrak{D}$ -CompReg-1. His universal space, however, has very high cardinality and is of weight 2^c . We would like to express our thanks to H. Brandenburg who carefully read the first draft of this paper. Further results on D -normal spaces will appear in a paper of his, which is in preparation [8].

ADDED IN PROOF. The results of A. Mysior mentioned above have been published in the meantime (*Two remarks on D-regular spaces*, Glasnik Mat. **15** (35) (1980), 153–156).
