“At its 6556th meeting, held in private on 17 June 2011, the Security Council considered the question of the recommendation for the appointment of the Secretary-General of the United Nations.

“The Security Council adopted by acclamation the following resolution:

‘*The Security Council,*

‘*Having considered* the question of the recommendation for the appointment of the Secretary-General of the United Nations,

‘*Recommends* to the General Assembly that Mr. Ban Ki-moon be appointed Secretary-General of the United Nations for a term of office from 1 January 2012 to 31 December 2016.’”

6557th meeting    *Threats to international peace and security caused by terrorist acts*

The agenda was adopted without objection.

The Council began its consideration of the item on its agenda.

The President drew attention to the text of a draft resolution contained in document [S/2011/368](#), submitted by France, Germany, Portugal, the United Kingdom of Great Britain and Northern Ireland and the United States of America; and on the text of another draft resolution contained in document [S/2011/369](#), submitted by France, Germany, the United Kingdom of Great Britain and Northern Ireland and the United States of America.

The Council proceeded to vote on the draft resolutions ([S/2011/368](#) and [S/2011/369](#)) before it.

*Decision: The draft resolutions ([S/2011/368](#) and [S/2011/369](#)) received 15 votes in favour, none against and no abstentions, and were adopted unanimously as resolutions 1988 and 1989 (2011), respectively.*

The Council heard statements by the United States, Germany, India, the Russian Federation, France, Portugal and the United Kingdom.
