Presidential Welcoming Address on the Occasion of the 17th European Congress of Pathology and the 19th Spanish Congress of Pathology

On behalf of the European Society of Pathology and the hosting Spanish Society of Pathology, it is an honour and a privilege to extend our warm welcome to the 17th European Congress of Pathology and the 19th Spanish Congress of Pathology.

Pathology in Europe has a very long tradition, dating back to the days of the Renaissance. Compared to the long history of pathology in Europe, the history of the European Society of Pathology is quite short. The ESP is now 36 years old and has now, the forthcoming congress in Barcelona included, organised 17 meetings. In Table 1 you will find the year of each congress, the congress site and the name of the chairman of the organising committee.

From 1963 to 1999, 12 presidents, four secretaries and two treasurers served the society (see Table 2). All the outstanding pathologists and the many others who are not named here, but who were also involved in the organisation of the congresses and the various activities of the ESP, have helped pathology in Europe to gain more weight and more profile in the past decades

The congress in Barcelona will not only probably be the largest ever organised by the ESP in this century, but also, we hope, one of the most attractive. Together with the Spanish Society of Pathology the ESP will welcome more than 1100 delegates from 40 countries and representatives from (almost) all European societies of pathology, not only from the western countries but also from the eastern ones, a fact about which we are particularly happy. Pathologists from other continents, such as North and South America, Asia and Africa will also attend this event. Their presence is an honour for the meeting and enhances the role of European pathology and its leading society, the European Society of Pathology.

The scientific programme has been prepared by the Local Organising Committee in close collaboration with the Executive Committee of the ESP and its Advisory Council (chairman: A. Llombart-Bosch). The programme includes keynote lectures, symposia, short courses, slide seminars, free papers and posters. In addition, there

News from the meeting of the Executive Committee in Kiel, Germany, 13 February 1999

1. Journals and EuroPath News

The president, Günter Klöppel, updated the situation. *Virchows Archiv* is now the official journal of ESP and according to the contract with Springer Verlag, space will be available for the newsletter EuroPath News four times annually. Subscription is mandatory for members of the ESP and the fee is at present DM 90, +postage/handling expenses (DM 15–25). The contract is valid for 2 years.

2. Internet and ESP

The secretary, Jahn M. Nesland, reported on the development. Springer Verlag will contribute to make an appealing web-site. On the web site we will have information about the Society, such as statutes, bylaws, Executive committee members, Advisory council, Honorary members, etc. Links to EScoP, EuroCellPath and working groups will be established.

3. The ESP Congress, Barcelona, September 1999

Professor Antonio Cardesa gave an update. The planning and preparation are running smoothly. We can look forward to some very stimulating days in Barcelona.

4. The ESP Congress, Berlin, September 2001

The ESP congress will take place in The International Centre, Berlin. It is located in the centre of Berlin but there are many inexpensive accommodation options in the surroundings. The congress period will be held from 8–14 September. A first announcement will be available during the congress in Barcelona.

5. The First Intercontinental Congress of Pathology, Madeira, 30 April– 6 May 2000

Professor Manuel Sobrinho-Simões informed about a site visit. The programme is finalised and we can expect many interesting sessions. The social programme is also very well planned, so we all look forward to seeing you in Madeira in the year 2000. Bring your family along and combine it with a vacation.

6. Cooperation with IAP

The president, Günter Klöppel, has contacts with IAP through Professor Anna Kadar for discussions about cooperation.

7. EuroCellPath

Prof. Jean Alexis Grimaud gave a preview of the upcoming EuroCellPath Conference (June 1999) in France. During the Barcelona Congress, the future of EuroCellPath will be discussed. After a successful 10 years, Prof. Jean Alexis Grimaud, the founder and the person holding the main responsibility for EuroCellPath, has expressed the wish to be replaced. A system with president, past-president and president-elect was proposed.

8. EscoP

Prof. G. Bussolati is replacing Prof. G. Viale as Director of EscoP. G. Viale has done an excellent job, but for personal reasons, would like to be replaced. G. Bussolati proposed organising EscoP in a similar way as EuroCellPath, with a president, president-elect and past-president. The annual courses in Torino are very successful and very well accepted among the participants.

9. Minimal requirements – pathology laboratories

A working group (R. Simpson, UK, S. Uccini, Italy, and M. Marchal, Belgium) have distributed a proposal to be discussed. The group received many positive comments for their work. The final version is expected to be approved during the Executive Committee meeting in Barcelona, 18 September 1999.

A Debate

There have been a number of discussions in Europe about how dermatopathology should be practised. A number of clinical, but not pathologically qualified dermatologists do their own dermatopathology reporting and many have acquired significant expertise. However, there is concern that this expertise is not universal and that some aspects of the pathology of the skin relate to non-dermatological conditions.

In the UK, the Royal College of Pathologists has recognised this dilemma and has provided a training programme and examination for dermatologists who wish to acquire the necessary pathological skills. A number of members of the Society of Dermatology in the European community have taken this examination. The UEMS Board in Anatomic Pathology and Cytology will discuss the issue shortly with representatives of the relevant board members in medicine. It will be interesting to learn the views of the members of the European Society of Pathology on this difficult issue, which has aroused strong feelings. Many consider that dermatologists are in a unique position, having, as Prof. Underwood has put it, "seen the gross specimen". Clinical opinion is, undoubtedly, important in dermatopathology (as in all other branches of pathology), but here it may hold a special place. What do you think?

Visits of the President

On 7-8 May I was invited by the Institute of Pathology of the Faculty of Medicine, University of Ljubljana (Prof. Dr. Dusan Ferluga, Prof. Dr. Vera Ferlan-Marolt), to attend a meeting of the Slovenian Pathology Society in Ljubljana. The meeting concerned the pathology of diseases of the pancreas, biliary tract and duodenum, to which I was privileged to contribute a lecture and some comments. The meeting was well attended and the atmosphere was very lively. It was nice to see how active the Slovenian Pathology Society is. During my stay I also had the chance to visit the site of the 2003 congress of the European Society of Pathology in Ljubljana. Ljubljana has a very nice and well-equipped congress centre, which will be ideal for housing all the activities of the planned ESP congress.

After Ljubljana I paid a visit to the Institute of Pathology of the University of Graz, Austria, at the invitation of Professor Helmut Denk. Here I gave a lecture to the students and presented the new WHO classification of gastrointestinal endocrine tumors to the members of the department. Apart from these educational and scientific activities I had time to discuss the activities and aims of the European Society of Pathology with the members of the department. I returned to Kiel with the feeling that there is a great willingness to support the ESP in both Slovenia and Austria.



The IUCP Breast Pathology-Oncology, Ioannina, Greece, 11–15 May 1999

This is a postgraduate course about breast pathology. Twenty-two invited speakers from five different countries presented the well-founded scientific programme, dealing with topics such as breast cancer screening, the normal breast, borderline breast lesions, micrometastases, various problems in breast cancer diagnostics, and genetics of breast cancer.

Prof. Niki Agnantis, the president of the annual Ioannina University courses in pathology and her collaborators, did a superb job with the course. They have a good deal of experience organising courses and conferences and the breast pathology course this year was no exception. The social programme was stimulating, including local folkdance in a downtown restaurant.

The aim of the Ioannina University courses in pathology is to bring together young pathologists and tutor experts in various fields of pathology, and thereby encourage active participation of all colleagues during discussion sessions. There is an emphasis on morphologic features, newly recognised entities and modern techniques. Each course has been designed for 30–35 participants and is sponsored by the ESP within the European Institute for Continuing Medical Education (EICME) and in collaboration with the European School of Oncology (ESO).

The courses are of very high quality and are warmly recommended.

Report on the spring 1999 loannina course in pathology: breast pathology-oncology

One of the pleasant duties of the members of the faculty of the Ioannina Courses of Pathology is to offer "closing remarks". At this time it is a particular pleasure for me to offer these closing remarks since the topic, "Breast Pathology and Oncology", is of those timely subjects that has great practical implications. Its importance has been widely recognised by the establishment of national cancer campaigns.

For some of you, the Department of Pathology of the Ioannina University Medical School is that institution which sponsors courses in pathology and, indeed, now this is one of its traditions. But in addition to sponsoring courses, this Department of Pathology is a "high-energy laboratory", with interests that delve deeply into the problems of diagnosis and research. The course, held in Ioannina from the 11–15 May 1999, was perfectly organised by Prof. Niki Agnantis and her very efficient and enthusiastic staff, sponsored by the ESP within the European Institute for Con-



tinuing Education and in collaboration with the European School of Oncology. The courses, scheduled to consist of 4 days of lectures, had a faculty of teachers invited from the UK, Norway, Hungary, Italy and Greece; it was attended by 30 young pathologists either in training or certified from Greece. It was very conveniently located in the research laboratory of the Department of Pathology, where all the necessary teaching facilities were available.

The need for reliable methods of diagnosing breast disease served as the impetus to organize the first session of the course. Although serveral methods for the detection of early breast lesions are available, none of them provides unequivocal information.

The question of whether histologic, immunohistologic and ultrastructural lesions

can be detected in mammary tissues and specimens undergoing carcinogenesis but which are not yet malignant, and the properties of the already established malignant lesions, were evaluated in sessions 2, 3 and 4, in which the problems related to soft tissue and neuroendocrine breast tumors were also taken into consideration. All these points are relevant to diagnosis, prevention, and further treatment of breast cancer and form the bridge to the molecular biologic aspects of malignant cells.

Consideration of whether the genetics of breast cancer as well as the host immune and angiogenic responses are important factors in the carcinogenic process and how they affect neoplastic growth formed the basis of session 5, in which molecular techniques and systemic treatment protocols were discussed in depth as well. Ac-



cording to the published literature on these topics, we can reasonably conclude that host factors effectively modify the course of tumor pathogenesis. However, the complex interrelationships and feedback mechanisms limit the exploitation of the host phenomena for effective therapy and prevention. The goal of this closing session was to evaluate whether mammary tumour cells or the self-response to them can be modified to benefit the host.

May I now extend a few words concerning how today's young pathologists in training will look to the future after having attended the course, i.e. what the quality of their future in pathology is likely to be. It is trite to say that a close relationship between clinicians, pathologists and bench scientists is strictly necessary and required. We all say it and then frequently ignore it. The point has been made clear at this course that the patient tells us what is relevant and impor-

tant; then the clinician translates what the patient is telling us and passes it along to the pathologist and finally to the bench scientist, who in turn must retranslate this information to the pathologist and to the clinician in order to develop an efficient protocol for therapy. In summary, we have learned from this course that if the road from patient to clinician to pathologist to scientist is too long, or if the scientist and the pathologist ignore the clinician, then progress will certainly be slower than it ought to be. Reciprocally, if the clinician ignores the pathologist and the scientist, he is likely to establish improper and timewasting clinical trials which, in turn, will impede progress and any benefit to the pa-

European Board Examination in Pathology Barcelona, 1999

Examination Committee

History of the European Board of Pathology

In 1962 the national medical specialist organizations of the European Community (European Union) grouped together to form the Union of European Medical Specialists (UEMS). At the same time individual sections of the various medical specialties were formed under the umbrella of the UEMS, including a section of laboratory medicine. In 1988 a specialist section of Anatomo-Pathology was split off from this laboratory specialty. The main objective of this section was the harmonization of pathology practice in Europe. At the request of the UEMS, the different sections set up European Boards and in 1992 the European Board of Pathology was constructed but as there was an enormous overlap of activities between the specialist section of the UEMS and the European Board, it was decided that the UEMS-section Pathology should also act as the European Board of Pathology. The objectives of the European Board of Pathology are:

- the harmonization of training in pathology in Europe
- the setting of minimal standards for training institutions and for those who are in charge of training
- the establishment of european board examinations
- to organize exchange facilities for trainees between recognized training institutions
- to study and advise of manpower in European Pathology
- to advise on quality control on an European basis

European Board Examination

In 1999 the European Board of Pathology will provide the third EBP-examination in pathology. This is a written examination, consisting of multiple choice questions. The language for this examination is English only. The examination may be taken by all anatomic pathologists who have qualified as a pathologist in an European Country..

Successful candidates will be issued with a certificate by the EBP.

Examination procedures

The examination will be a multiple choice question examination, covering the whole field of pathology. The examination will consist of three parts, each lasting two hours.

- The first part deals with the theoretical aspects of general and systemic pathology and related basic sciences. The examination consists of 120 multiple choice questions.
 - To succeed in the theoretical part of the examination, the candidate will need to have studied at least a recent textbook in Pathology such as Robbins, Rubin and Farber or other textbooks.
- The second part consists of 60 projected kodachromes covering different aspects of gross pathology, cytopathology and special techniques in pathology. The latter techniques include molecular pathology and immunohistochemistry. Each kodachrome is accompanied by 1 multiple choice question.
- The third part of the examination consists of 40 glass slides for histological diagnosis. Each glass slide is accompanied by one multiple choice question.

The total number of multiple choice questions is 220.

The questions, slides and kodachromes are provided by a number of expert pathologists from the participating countries. The selection for the examination is made by the examination committee.

Examination location

The examination will take place in Barcelona, Spain, or Sundary September 19, 1999. The examination precedes the 17th European Congress of Pathology. The examination will start at 09.00 AM. Information about the location will be send to the elected candidates in due time.

Requirements

For this examination pathologists, qualified as a pathologist in an European country will be eligible to take the examination. Residents in training will have to finish their training before July 1999 to register for the 1999 assessment.

All pathologists must submit a signed copy of the official document conforming their qualification as a pathologist and a recent photograph. Residents in training must submit certified evidence that the residence training programm in pathology will be finished before July 1999.

The number of participants will be limited to 50. Registration will take place on a first-come-first-served basis, after payment. Please to not send money if you do not fulfil the requirements.

Subjects to be examined

The examination will cover the whole field of the daily practice of a pathologist. The includes histopathology, cytopathology, autopsy pathology. It also includes special techniques as electron microscopy, molecular pathology and (immuno) histochemistry. The examination is comparable with other international examinations in Pathology and requires sufficient knowledge of theoretical pathology as discussed in standard textbooks of Pathology.

Assessment fee

A fee of 550 Dfl will be charged for participating in the examination. This fee excludes the travel and lodging expenses of the candidate. Transfer should be made in dutch guilders to the EBP examination committee, as indicated on the registration forms. Credit Card payment is not possible.

Payment can be made by Eurocheques (not exceeding 300 Dfl each) or Bank transfer to the ABN-AMRO-bank in Utrecht.

The deadline for sending in your application form to take the examination and for payment of the examination is July 1, 1999.

In the event of cancellation full refund of the examination fee minus 15% for administration costs, may be made up to six months before the examination and 50% of the fee up to three months before the examination. Only written cancellations shall be accepted. No refund will be made if the cancellation request is received at the secretariat of the Examination Committee of the European Board of Pathology after August 1, 1999. Refunds will be processed in October 1999.

Any colleague and especially experienced resident or freshly qualified pathologist who wishes to gain experience in pathology in Turkey would be welcome.


