This instruction implements Air Force Instruction 32-6001, Family Housing Management and establishes housing assignment policy to ensure effective utilization of military family housing assets for members assigned to key and essential positions. This publication applies to all units assigned, attached, and associated with the 15th Airlift Wing (15 AW) to include Headquarters Pacific Air Forces (HQ PACAF), active duty, Air National Guard, and Air Force Reserve units.

SUMMARY OF REVISIONS

Chapter 1

ASSIGNMENT POLICY

1.1. All housing assignments identified in this instruction will be made in accordance with AFI 32-6001. Changes to paragraph **2.1.** will be made with approval of PACAF/DS. Changes to paragraph **2.2.** and **2.3.** will be made with approval of 15 AW/CC.

- **2.1.** The following positions are designated as key and essential. Incumbents of these positions are required to reside on the installation and will be assigned the first available quarters in the original officers' housing area if appropriate for their grade, category, and family composition.
