This 18th Wing Instruction establishes policies, procedures and standards for administering the Air Force Club Member Value Pricing Schedule. It is implemented by AFPD 34-1, Morale, Welfare, Recreation (MWR) and Services Program. This instruction applies to all personnel who utilize the Kadena Officers' Club, NCO Club and Airmen's Club Annex. \*This instruction also includes the following restaurants: The Italian Restaurant, The Mexican Restaurant, Jack's Place, The Seaside and Tee Bones Steakhouse.

## SUMMARY OF REVISIONS

This revision incorporates procedures formerly published in 18th Wing Instruction 34-103. It aligns procedures and clarifies responsibilities. A "|" indicates revised material since the last edition.

### 1. Essential Program Elements.

1.1. Every commander has an inherent responsibility to establish and maintain organizations that embody and reflect the institutional values of the Air Force. The organization must contribute to esprit de corps and provide for the unique camaraderie shared by the men and women of the United States Air Force. Air Force clubs help commanders carry out this responsibility.

1.2. By far, clubs are the major MWR revenue generator and the economic engine for quality of life programs. With this single fund, we can take advantage of the revenue stream clubs generate and move dollars to other programs deemed important or less profitable. Because of this flexibility, club revenue may be used to support other MWR activities that provide "airmen" with an improved quality of life.

1.3. Air Force clubs are a valuable asset to the military community and cannot exist without membership. Member value pricing and an appropriate eligible non-member charge is one method of returning direct value to those individuals who choose membership in Air Force clubs.

#### 2. How the Program is Administered and Program Limitations.

2.1. This schedule establishes minimum charges for eligible non-members and their guests. It does not apply to Air Force club members, family members, and their bona fide guests. It also does not apply to reciprocal privileges granted to Air Force club members, families, guests, and other US Armed Forces club members, their families, and guests in possession of a valid club membership card.

2.2. The following minimum amounts will be charged to those eligible non-members and their guests granted usage of the specific services and products. "Eligible non-members" are those personnel and family members who are eligible for, but have declined club membership.

ACTIVITY/NON-MEMBER EXTRA CHARGE Sunday Brunch and Special Brunches/3.00 Breakfast/1.00 Lunch/Buffet/2.00 Dinner/3.00

SPECIAL FUNCTIONS/NON-MEMBER EXTRA CHARGE Breakfast (Sit down and buffets)/1.00 Lunch/2.00 Dinners/3.00 Entertainment (Non-members allowed to attend entertainment programs will be charged a minimum of)/3.00 All snack bars located inside the club will charge the non-member extra charge

*NOTE:* Non-member charges are listed per person and apply to each eligible non-member and each guest of an eligible non-member. \*Non-members attending special functions including official functions will pay the extra charge.

2.3. The following club programs are designated for members and their bona fide guests only:

ACTIVITY Membership Nights (Only Air Force club card holders will be authorized free dinner on membership night) Bingo/Bar Bingo Check Cashing (Members Only) Currency Exchange Services Family Night Dining Room Discounts Giveaway Programs including Prizes Given on Membership Night, etc. 2.4. Non-members are authorized to use the following club-sponsored activities without paying an additional charge:

#### ACTIVITY

Food Delivery Service Schilling Snack Bar and Lounge

Barber Shop and Beauty Shop (only Kadena club members are authorized to use the discount coupons)

Meetings held in the club (non-members eating lunch or other meals will be charged the non-member charge)
