Subaccount representatives (SAR) send requirements to arrive at your Customer Account Representative) CAR by ______. (Use of the Air Force Publishing Bulletin [AFPB] is explained in AFI 37-161.)

ATTENTION PDMs/PDOs/CARs: SUBJECT: Requirement for Paper Produced Departmental Publications. All are reminded, requirements and requisitions will be accepted and processed by all PDOs for Functional "F" distribution publications, which are provided in hard copy format and are listed in appropriate indices. Publications listed in any index which does not indicate that it is "electronic only" will be processed, at the customer's request, for requirements and/or requisition as appropriate. A perfect example is the Airman Magazine, the Official Magazine of the Air Force. It is published monthly (in hard copy) for the Secretary of the Air Force Office of Public Affairs, to inform active duty, Guard, Reserve and Civilian members about Secretary of the Air Force and Chief of Staff programs and should be given the widest dissemination in its printed form. The Airman Magazine is distributed at a ratio of 1 copy for approximately 3.5 military and civilian personnel assigned and is exempt from the on-line (electronic) paper reduction policy. PDOs/CARs will be advised through the Air Force Publishing Bulletin when this or any other departmental publications are no longer available in hard copy. At that time all requirement files may be deleted and acceptance of requirements or requisitions declined.

AFH32-4014V4, Because of the increased requirement and due-outs for this publication, all PDOs are instructed to review their functional requirements and due-outs. Requirements and due outs should be revalidated and reported to the AFPDC on or after 21 August 1998. Requirements or due-outs established prior to 21 August 1998 will be considered invalid.
