This supplement implements and extends the guidance of Air Force Instruction (AFI) 52-101, *Chaplain Service Responsibilities and Procedures*, 19 May 1997. The AFI is published word-for-word without editorial review. Air Force Space Command (AFSPC) supplemental material is indicated in bold face. This supplement describes AFSPC's procedures for use in conjunction with the basic AFI. It applies to Headquarters Air Force Space Command (AFSPC) and subordinate units. This does not apply to Air National Guard nor Air Force Reserve Command units. This supplement requires collecting and maintaining information protected by the Privacy Act of 1974 authorized by U.S.C. 8013. System of records notice F011 AF A, Locator, Registration and Postal Director Files, applies. The reporting requirements in this directive are exempt from report control licensing (RCS) in accordance with AFI37-123, *The Information Collections and Reports (ICR) Management Program; Controlling Internal, Public, and Interagency Air Force Information Collections*. Upon receipt of this integrated supplement discard the Air Force basic publication.

- 1.8.1. Use AFSPC Form 178, **Chapel Community Personnel Data**, to maintain records of religious rites for individuals attending worship services at the chapel.
- 1.14.1. Statistics needed for AF Form 1270, **Chaplain Statistical Report**, can be gathered from the following forms:
- 1.14.1.1. AFSPC Form 174, **Individual Religious Education Enrollment and Registration Record**, is used for each student enrolled. The form maintains attendance on the student . Form is retained by the Religious Education Coordinator or Chaplain.

- 1.14.1.2. AFSPC Form 175, **Chaplain Duty Officer Report**, is filled out by the duty chaplain for each tour of duty. Report is reviewed by Senior Chaplain and then filed in the using chaplain's personal file.
- 1.14.1.3. AFSPC Form 176, **Weekly Consolidated Attendance Record for Religious Education Schools,** is used to consolidate information for the purpose of recording statistics. This form is retained by the Religious Education Coordinator, Chaplain, or in the official files.
- 1.14.1.4. AFSPC Form 177, **Individual Class Report For Religious Education Schools**, records weekly attendance, offerings, and future supply needs. This form is retained by the Religious Education Coordinator or Chaplain.
- 4.2.2. Annually during the month of June select one weekend and forward all offerings received for regular weekend worship services to the HQ AFSPC/HC Special Activity Fund no later than 31 July.
- 4.5.1. Attach a current copy of your Chaplain Fund property listing to the annual report.
- 4.11.1. Use AFSPC Form 55, Chapel Offering Worksheet to record chapel offerings.
- 4.11.4. Use AFSPC Form 54, **Chaplain Fund Request**, to process financial obligations that require Purchase Orders.
