Each facility manager (or authorized person) who needs to order supplies, get items for resale, or repair any item which Services has, must fill out the 30 SW Form 474. Complete the blocks labeled—branch/section, activity code, date, item number, complete item description, unit, unit price, and total. At the bottom of the form, fill in the vendor's name and sign the request for purchase in the block labeled "Requested by." After the 30 SW Form 474 is submitted to the NAF Purchase Office, they will prepare a purchase order from the information submitted on the form. This form is also used by the activities as a receiving report for the Blanket Purchase Agreements in use.
