- 1. Priority Classification. Urgent
- a. Aircraft in Use. Upon receipt of this Technical Bulletin (TB) the condition status symbol of the cited aircraft will be changed to a red horizontal dash "-". The red horizontal dash "-" may be cleared when the inspection of paragraph 8 below is completed. The affected aircraft shall be inspected as soon as practical but no later than the task/inspection suspense date. Failure to comply with the requirements of this TB within the time frame will cause the status symbol to be upgraded to a red "X".
  - b. Aircraft in Depot Maintenance. Same as paragraph 1a.
  - c. Aircraft Undergoing Maintenance. Same as paragraph 1a
  - d. Aircraft in Transit.
    - (1) Surface/Air Shipment. Inspect at final destination.
    - (2) Ferry Status. Same as paragraph 1d (1).
  - e. Maintenance Trainers (Category A and B). Same as paragraph 1a.

- f. Component/Parts in Stock Including War Reserves at All Levels (Depot and Others). Upon receipt of this TB, all items in all condition codes listed in paragraphs 6 and 7 below shall be annotated to read UH-60-97-ASAM-04, change in retirement life of main rotor blade cuff, not complied with. No further action is required for wholesale stock. For retail stock comply with inspection and correction procedures in paragraph 8 and 9.
- (1) Wholesale Stock. No further action is required. Report receipt of this TB in accordance with paragraph 14c(1). Report compliance with this TB in accordance with paragraph 14d(1).
- (2) Retail Stock. Report receipt of this TB in accordance with paragraph 14c(2). Upon receipt of this TB commanders and others maintaining retail stock at installation level and below shall contact the supported aviation unit to perform the inspection required by paragraph 8 and the correction procedures of paragraph 9. Report compliance with this TB in accordance with paragraph 14d(2).
- 2. Task/Inspection Suspense Date. Within 10 hours/14 days.
- 3. Reporting Compliance Suspense Date. No later than 14 January 1997 per paragraph 14.a of this TB.
- 4. Summary of the Problem.
- a. The main rotor blade cuff P/N 70150-09109-041, 70150-09109-043 manufactured by Fenn MFG (CAGE 82001) had the retirement life reduced to an interim life of 75 hours from 2400 or 500 hours for the MH-60k hours (UH-60-96-03) (TB 1-1520-237-20-174). The interim life was then increased to an interim life of 450 hours (UH-60-96-ASAM-11) (TB 1-1520-237-20-183), (TB 1-1520-250-20-8) as result of preliminary test results.
  - b. For manpower/downtime and funding impacts, see paragraph 12.
- c. The purpose of this TB is to permit the Fenn manufactured main rotor cuff to be operated to its full life of 2400 hours or 500 hours for the MH-60K, due to engineering testing results.
- 5. End Items to be inspected. All UH/EH-60A/L and MH-60K aircraft.
- 6. Assembly Components to be Inspected.

Correction Procedures.** If items described in paragraph 7 above are installed, annotate in the aircraft records that the retirement life of the Fenn manufactured main rotor blade cuffs are returned to full life of 2400 hours or 500 hours for the MH-60K. ULLS-A users add the revised retirement life of the affected cuffs in the master component file using a configuration code of 40.
