1. Priority Classification. URGENT.

- a. Aircraft in use. Upon receipt of this technical bulletin the condition status symbol of the cited aircraft will be changed to a Red Horizontal Dash // //. The Red Horizontal Dash // // may be cleared when the inspection of paragraph 8 below is completed. The affected aircraft shall be inspected, as soon as practical buts no later than the Task/Inspection suspense date. Failure to comply requirements of this Technical Bulletin within the time frame specified will cause the status symbol to be upgraded to a Red " X".
- b. Aircraft in Depot Maintenance. Aircraft will not be released until compliance with this TB has been completed.
- c. Aircraft undergoing maintenance. Aircraft will not be released until compliance with this TB has been completed.
 - d. Aircraft in transit.
 - (1) Surface/Air shipment. Prior to first flight.
 - (2) Ferry status. Inspect at final destination.
 - e. Maintenance Trainers. (Category A and B). Comply within 15 days of receipt of this TB.

- f. Component/Parts in Stock Including War Reserves at all Levels (depot and Others). Upon receipt of this TB all items listed in paragraph 6 below shall be placed in condition code "D" and retagged with a test/modification tag/label Material (Blue Color) DD Form 1561/1576-1. The authority block must reference inspection required per this TB (UH-60-97-ASAM-18) (TB 1-1520-237-20-201). Items identified as serviceable IAW paragraph 8 shall be retagged with a serviceable tag/label Material DD Form 1574/1575-1 (Yellow Color). Indicate compliance with this TB (UH-60-97-ASAM-18) (TB 1-1520-137-20-201) in the remarks block. Items identified as discrepant IAW paragraph 8 below will be retagged with unserviceable reparable tag/label DD Form, 1577-2/1577-3 (green color). Annotate remarks block to indicate that the item is unserviceable IAW this TB 1-1520-237-20-201). Discrepant items will be corrected IAW paragraph 9.
- 2. Task/Inspection Suspense Date. Within 10 hours/14days.
- **3.** Reporting Compliance Suspense Date. No later than 30 September 97 per paragraph 14.a of this TB.

4. Summary of Problem.

- a. Safety of Flight message UH-60-97-SOF-1, TB 1-1520-237-20-185 and TB 1-1520-250-20-10, was previously issued to remove certain reworked main rotor swashplate assemblies from use. To date, not all of the main rotor swashplate assemblies identified in this TB have been turned in. This Technical Bulletin is being issued to locate the remaining suspect main rotor swashplate assemblies.
 - b. For manpower/downtime and funding impacts see paragraph 12.
- c. The purpose of this TB is to require a visual check of the swashplate assembly number to identify suspect swashplate assemblies, and to remove the suspect swashplates from service.
- **5. End Items to be inspected.** All UH-60A/UH-60L/EH-60A/MH-60K, aircraft serial numbers 96-26681 and subsequent will not require identification of this action.

8. Inspection Procedures.

- a. Access the data plate on the swashplate assembly to identify the swashplate assembly serial number. The data is located on the outer diameter surface of the rotating swashplate near one of the pitch rod attachment lugs. The serial number will have the prefix A107 (EXAMPLE A107-XXXX).
- b. If the main rotor swashplate assembly serial number is listed below, perform the corrective action of paragraph 9 before the next flight.

- c. If the main rotor swashplate assembly serial number is not listed above, the inspection is complete.
- **9. Correction Procedures.** If the main rotor swashplate assembly serial number is listed in paragraph 8b above, remove it in accordance with reference 13. a (For UH-60A/EH-60A/UH-60L Helicopters) or reference 13. b (For MH-60K Helicopters before the next flight).

- a. Parts Required. Items cited in paragraph 6 may be required to replace defective items.
- b. Requisitioning Instructions. Requisition replacement parts through normal supply channels using normal supply procedures. All requisitions shall use project code "XDP" (X-RAY-DELTA-PAPA) per this TB.

NOTE

Project Code "XDP", (X-RAY-DELTA-PAPA) is required to track and establish a database of stock fund expenditures incurred by the field as a result of ASAMS/SOF actions.
