6. A brief narrative describing additions of exemptions, routine uses, or systems of records.

# Exemptions:

Added (k) (1) exemption to DUSDP 11, POW/Missing Personnel Office Files. The exemption will prevent disclosure of information specifically authorized to be classified under E.O. 12958, as implemented by DoD 5200.1 R. (1996)

Added (k)(2) and (j)(2) exemptions to F111 A JA B, Courts-Martial and Article 15 Records. The exemptions will prevent disclosure of documents received or prepared in anticipation of judicial and non-judicial proceedings under the Uniform Code of Military Justice. (1997)

### Routine uses:

Added a routine use to A0040-66bDASG, Health Care and Medical Treatment Record System, to permit disclosure to former DoD health care providers, who have been identified as being the subjects of potential reports to the National Practitioner Data Bank as a result of a payment having been made on their behalf by the U.S. Government in response to a malpractice claim or litigation, for purposes of providing the provider an opportunity, consistent with the requirements of DoD Instruction 6025.15 and AR 40-68, to provide any pertinent information and to comment on expert opinions, relating to the claim for which payment has been made. (1997)

Added a routine use to AAFES 0702.23, Dishonored Check Files, to permit disclosure to private contractors for the purpose of collection services to recover moneys owed to the U.S. Government. (1997)

Added a routine use to AAFES 0702.34, Accounts Receivable Files, to permit disclosure to the Department of the Treasury, Financial Management Service, to enable collection of delinquent debts owed to the U.S. Government via administrative offset. (1997)

Added a routine use to A0040-57a DASG, Armed Forces Repository of Specimen Samples for the Identification of Remains, to permit disclosure to proper authority, as compelled by other applicable law. (1997)

Added two routine uses to S322.10 DMDC, Defense Manpower Data Center Data Base, one to allow the release of information to facilitate the enforcement of child support owed by delinquent obligors within the entire civilian Federal government and the Uniformed Services work force (active and retired); the second will allow research studies concerned with the health and well being of the active duty and veteran population. (1996)

Added two routine uses to DHA 05, Persian Gulf Veterans Illnesses Files, one to permit disclosure to the Presidential Advisory Committee on Gulf War Veterans' Illnesses for purposes of carrying out those functions as set forth in Executive Orders 12961 and 13034 or such further Order as directed by the President, and the second to the Department of Veterans Affairs for use, in conjunction with the Persian Gulf Health Registry, to permit investigative, scientific, medical and other analysis regarding possible causes, symptoms, diagnoses, treatment, and other characteristics pertinent to Gulf War Illnesses. (1997)

Added a routine use to F044 AF SG K, Medical Professional Staffing Records, to permit the disclosure of records concerning civilian consultants or contractors who engage in direct patient care may be released to civilian organizations employing said civilian consultants or contractors providing direct patient care to eligible beneficiaries if such records are necessary to evaluate the civilian consultant or contractor in accordance with 10 U.S.C. 1102(c)(E). (1997)

Added two routine uses to N05520-5, Personnel Security Program Management Records System, one to permit disclosure to the White House to obtain approval of the President of the United States regarding certain military personnel officer actions as provided for in DoD Instruction 1320.4; the second to the Immigration and Naturalization Service for use in alien admission and naturalization inquiries for purposes of determining access to National Security information. (1997)

Added a routine use to N01640-1, Individual Correctional Records, to permit notification to the victims and witnesses of crime of date of parole or clemency hearing and other release related activities. (1997)

Added a routine use to N01070-3, Navy Personnel Records System, to permit the disclosure of personnel information to governmental entities or private organizations under government contract to perform random analytical research into specific aspects of military personnel management and administrative procedures. (1997)

Added a routine use to S180.10 CA, Congressional, Executive, and Political Inquiry Records, to permit disclosure to Federal and local government agencies having cognizance over or authority to act on the issues involved. (1997)

Added a routine use to S322.10 DMDC, Defense Manpower Data Center Data Base, to permit disclosure to the Educational Testing Service, American College Testing, and like organizations for purposes of obtaining non-attributable personal data for use in analytical personnel studies of the DoD civilian and military workforce. (1997)

### Systems of records:

### Nonexempt:

F036 AFMC D, Education/Training Management System (ETMS). The system was established to provide data to Command Training and Resources Managers for development of long-term training plans and programs, and track progress toward established goals; to develop and execute centers education and training management plans and evaluation of centers education and training programs; to provide centers acquisition professional development managers with resources to compare acquisition certification requirements with work force qualifications, manager training requirements, and courses completed related to acquisition certification. (1996)

N01740-1, Family Dependent Care Program. The system was established to ensure family members are cared for during deployments, reserve mobilizations, temporary duty, etc., and that arrangements are in place for the financial well-being of family members covered by the Family Care Plan during separations. (1996)

S200.60 DD, Chaplain Care and Counseling Records. The system was established to document spiritual and personal counseling and assistance given to DLA personnel and their families. (1996)

S322.15 DMDC, Defense Incident-Based Reporting System (DIBRS). The system was established to provide a single central facility within the Department of Defense (DoD) which can serve as a repository of criminal and specified other non-criminal incidents which will be used to satisfy statutory and regulatory reporting requirements, specifically to provide crime statistics required by the Department of Justice (DoJ) under the Uniform Federal Crime Reporting Act; to provide personal information required by the DoJ under the Brady Handgun Violence Prevention Act; and statistical information required by DoD under the Victim's Rights and Restitution Act; and to enhance DoD's capability to analyze trends and to respond to executive, legislative, and oversight requests for statistical crime data relating to criminal and other high-interest incidents. (1996)

T7332, Defense Debt Management System. The system was established for the administrative management and collection of all delinquent debts, including past due loan payments, overpayments, fines, interest, penalties, fees, damages, leases, sales of real or personal property, etc., due to the DoD and debts due to other Federal departments and agencies of the U.S. Government that may be referred to the DoD for collection. (1996)

- DHA 08, Health Affairs Survey Data Base. The system was established to improve quality, efficiency and cost effectiveness of Military health care services. (1997)
- DC3I 01, Joint Reserve Intelligence Planning Support System (JRIPSS). The system was established to provide the Joint Staff, Combatant Commands, DoD intelligence organizations, and the Reserve Components a means to more adequately assess the intelligence and language capabilities of Reserve Component personnel and to identify individuals possessing the requisite skills to fulfill operational requirements or missions. (1997)
- F168 AF SG G, Reporting of Medical Conditions of Public Health and Military Significance. The system was established to permit records to be used for ongoing public health surveillance the systematic collection, analysis, and interpretation of outcome-specific data for use in the planning, implementation, and evaluation of public health practice within the Air Force. (1997)
- HDSWA 017, Voluntary Leave Sharing Program Records. The system was established to manage the Defense Special Weapons Agency (DSWA) Voluntary Leave Sharing Program. (1997)
- HDSWA 018, Travel Management Program. The system was established to maintain an official travel record authorization and payment file system. Provides management information for control of travel expenditures, supports documentation requirements, and provides reimbursement accounting for persons on official travel. (1997)
- N05420-1, Field Naval Aviator Evaluation Boards (FNAEB). The system was established to maintain a database of all naval aviators who have had a Field Naval Aviator Evaluation Board (FNAEB) conducted and to maintain copies of FNAEB reports. (1997)
- N01650-1, Awards Information Management System and Records. The system was established to maintain a database of military personal awards and unit awards. (1997)
- RDCAA 215.1, entitled Voluntary Leave Transfer Program. The system was established to manage the DCAA Voluntary Leave Transfer program. (1997)
- S400.20 CA, Day Care Facility Registrant and Applicant Records. The system was established to collect information required to manage and administer a day care program. (1997)

# Exempt:

DFMP 26, Vietnamese Commando Compensation Files. The system was established to allow records collected and maintained by the Vietnamese Commandos Compensation Commission to validate claims of commandos or their survivors for compensation subject to section 657 (c) of Pub.L. 104-201, Payments to certain persons captured and interned by North Vietnam. (1997)

9. Number of instances in which individuals brought suit under section (g) of the Privacy Act against the agency and the results of any such litigation that resulted in a change to agency policies or practices.

During the reporting period, 8 suits were brought against the Department of Defense or its components. None of the suits resulted in any changes to existing DoD component policies or practices.

# 10. Description of the results of reviews undertaken in response to the following:

- a. Section (m) contracts. Of those DoD components maintaining section (m) contracts, some components conducted full or partial reviews of existing contracts. The subject reviews disclosed that the contracts complied with current statutory and regulatory requirements, to include having the required Federal Acquisition Regulation (FAR) clauses regarding the Privacy Act (i.e., 52.224-1 and 52.224-2).
- b. Record keeping practices. The DoD components generally monitored their record keeping policies and practices, to ensure that they were consistent with statutory, OMB, National Archives and Records Administration, and agency guidelines regarding records maintenance and disposition. Where random surveys were conducted, component record systems were found to be in compliance with pertinent authority. Where not, the component initiated corrective action. Resource limitations, however, impacted on the ability of some components to conduct more extensive reviews.
- c. Routine use disclosures. The DoD components were especially sensitive to the statutory requirement that any proposed use of the information outside the agency must be compatible with the purpose for which the information was collected by the component. Generally, of the routine uses reviewed, they were found to have met the statutory compatibility requirement. Many recently published routine uses were driven by legislation which necessitated the establishment of a new use in order to carry out the Congressional mandate.
- d. Exemption of systems of records. Of the components which have exempt record systems, reviews were conducted to determine whether the claimed exemptions were still required and needed. The components concluded that their exempt systems were justified. On the rare occasion when an exemption was claimed for an existing or new system of records, a detailed review of the exemption was conducted so as to ensure that statutory

requirements were satisfied. This was especially true if the exemption involved an exemption other than 5 U.S.C. 552a(k)(1) (classified information). When a component determined that an exemption was no longer needed, action was taken to delete it.

e. System of records notices. As appropriate and warranted, DoD components took action to change pertinent system notices so as to ensure that they were consistent with statutory requirements. During the reporting period, the following additions/deletions/alterations/amendments were made, all of which were properly published in the Federal Register.

For 1996, 6 systems of records were added, 3 systems of records notices were deleted, 102 systems of records notices were amended, and 3 systems of records notices were altered.

For 1997, 10 systems of records were added, 7 systems of records notices were deleted, 99 systems of records notices were amended, and 21 systems of records notices were altered.

# 11. A description of the agency Privacy Act training.

The DoD components continue to be creative in their training efforts, using diverse approaches and tools in training the workforce in an effort to educate and sensitize its personnel as to the requirements of, and the protections provided by, the Privacy Act. Some components offered not only general training to their employees, but specialized training to personnel performing discrete functions, such as inspector generals, judge advocates (military attorneys), record managers, and Privacy Act Where training of component Privacy Act officials is officials. concerned, some components relied solely on in-house training, outside training, or both. A number of components cited Privacy courses offered by the Department of Justice and the Office of Personnel Management as an excellent means of providing training to their privacy personnel. Outside the Government, the American Society of Access Professionals (ASAP) continued to be used by components as a means of providing privacy training to their personnel. ASAP training, which is conducted thrice yearly, always has significant numbers of DoD personnel in attendance. Many components prepared Privacy Act materials or utilized recurring component publications as part of their overall effort to educate their personnel in this critical and sensitive area. Components continued to widely use the DoD training video which was created some years ago. Though dated, its contents are as relevant today as it was then. One component has developed its own training film. Some components have provided privacy information to their personnel through internal websites (and one permits the employee to ask privacy related questions) and two components have established public webpages regarding their

privacy programs that not only serve to educate their personnel, but provides a means by which the general public is educated as well.
