Subj: JUDGE ADVOCATE GENERAL'S CORPS TARGETED AUGMENTATION PROGRAM (TAP)

1. <u>Purpose</u>. To promulgate eligibility criteria and application procedures for the Judge Advocate General's Corps TAP.

2. Cancellation. JAGINST 1212.1A.

3. <u>Discussion</u>. TAP was established in July 1983 to provide reserve judge advocates (JAs) on active duty the opportunity to develop performance records beyond the 36-month active duty obligation prior to consideration before the Transfer/ Redesignation (Augmentation) Board.

a. The Judge Advocate General of the Navy (JAG) will convene two administrative selection boards annually to recommend reserve JAs for extension on active duty.

b. Per reference (a), a TAP selectee is extended on active duty and considered for augmentation after (1) applying for augmentation and (2) completing approximately 4 years of active service as a JA.

4. <u>Eligibility</u>. Semi-annual TAP boards will convene in March and September of each year. Except as noted below, each Reserve JA may apply to 2 consecutive boards, the first opportunity being the board that convenes during or after the officer's 24th month of continuous active duty following commencement of Naval Justice School (NJS) training.

5. Procedures.

a. <u>TAP</u>. The JAG will convene semi-annual boards in Washington, D.C., to review applications and select Reserve JAs for TAP. Selectees will be extended on active duty in a Reserve status until they are eligible for consideration for augmentation.

b. <u>Application</u>. The application format is set forth in enclosure (1). Each application shall contain all officer fitness reports, undergraduate and law school transcripts, NAVPERS Form 1070/10 (Officer Photograph Submission Sheet), no more than 3 letters of recommendation, and an unqualified extension request. A TAP application, with endorsement, must be received by Navy Personnel Command (PERS-4416C) not later than 30 days prior to the board's convening date; normally 15 February for the March board and 15 August for the September board. Applicants compete with other officers from their year group.

c. <u>Resubmission</u>. Applicants not selected for TAP at their first board may have their application considered by the next consecutive board upon written request, with command endorsement, or may submit a new application.

d. <u>Transfer/Redesignation (Augmentation)</u>. Navy augmentation boards normally convene semi-annually in October and April. Except as noted below, TAP selectees may apply only to that augmentation board which convenes approximately four years after they commence NJS training.

e. <u>Exceptions</u>. The objective of the TAP and augmentation process is to select the most qualified officers for career status. Therefore, exceptions to the above policy restrictions on both the timing and number of opportunities to apply for TAP and augmentation -- which are intended solely to distribute fairly the selection opportunities within a given year group -may be approved by the JAG on a case-by-case basis. Officers seeking such exceptions shall submit their request and application to the JAG, with command endorsement, not later than the deadline for the applicable board.
