- Purpose. To issue revised military justice statistical reporting procedures for Navy and Marine Corps officers exercising general courtmartial jurisdiction.
- 2. Cancellation. JAGINST 5800.9.
- 3. Application. The provisions of this instruction are applicable to Navy and Marine Corps officers exercising general court-martial jurisdiction who ordinarily perform military justice functions, i.e., officers that receive records of trial for action under subsections (e) and (f) of reference (a).
- Background. References (b) and (c) require collection of court-martial and nonjudicial punishment data. This revision incorporates previous changes by message and new requirements.
- 5. Policy. The collection and maintenance of accurate and timely statistical information reflecting trends in military justice processes and criminal activity is necessary for measurement of the efficiency of personnel and the effectiveness of discipline-related initiatives by the Department of the Navy.

6. Definitions

- a. Officer Exercising General Court-Martial Jurisdiction (OEGCMJ). An officer empowered to convene general courts-martial as stated in paragraph 3.
- b. Convening Authority. An officer empowered to convene general, special, or summary courts-martial.

7. Procedures

- a. Reporting Periods. The cognizant OEGCMJ shall submit quarterly reports to the Office of the Judge Advocate General, Building 111, Washington Navy Yard, Washington DC 20374-5074 (Atm: Code 40), not later than 31 January (1st quarter), 30 April (2d quarter), 31 July (3d quarter), 31 October (4th quarter). Alternatively, the cognizant OEGCMJ may submit reports by DDN E-Mail to JAG 40; by message to NAMARA JAG WASHINGTON DC; or by FAX to DSN 288-7453, commercial (202) 433-7453.
- b. Reporting. Report courts-martial for the quarter in which sentence or acquittal was announced. Report nonjudicial punishments for the quarter in which punishment was announced. Separate reports are required for Navy and Marine personnel. Negative reports are required.
- c. Organizational Accountability and Subordinate Convening Authority Submissions. Each OEGCMJ is responsible for collecting and submitting statistics from all subordinate officers exercising summary or special courts-martial jurisdiction.
- 8. Format. Format for submission of the QCAR is contained in enclosure (1).
