Subj: Navy Personnel Augmentation of the Fleet Marine Force (FMF)

Ref: (a) NAVREGS 0307

1. <u>Purpose</u>. To assign responsibility for implementation of Navy Personnel Augmentation of the Fleet Marine Force (FMF) within the Department of the Navy (DON).

2. Background

a. Navy FMF support is not maintained at combat strength during peacetime. Therefore, in the event these forces or elements are required to deploy, immediate predeployment augmentation is necessary to bring the number of Navy personnel of the deploying units up to combat strength.

b. Reference (a) requires the Chief of Naval Personnel and Commander, Naval Medical Command, under the command of the Chief of Naval Operations (CNO), to respond directly to the Commandant of the Marine Corps (CMC) in meeting the particular Navy personnel needs of the United States Marine Corps.

3. Policy

a. The administration and implementation of Navy personnel support of the FMF rests with the Chief of Naval Operations, in coordination with the Commandant of the Marine Corps.

b. Support missions for augmenting personnel shall be predesignated to the maximum extent possible.

c. Operations planning involving the use of FMF units shall provide for transportation of Navy augmentees from their present commands to mobilizing units in accordance with Joint Operation Planning System procedures.

4. Action. CNO and CMC shall publish implementing directives for Navy personnel augmentation of the FMF that ensure:

a. Marine Corps requirements for Navy augmentation of FMF units are periodically reviewed, updated, validated and provided to the Chief of Naval Personnel, Commander, Naval Military Personnel Command, Chief of Naval Reserve, and Commander, Naval Medical Command.

The immediate availability of properly trained and qualified b. personnel to augment the FMF in the event that these forces, or elements, are mobilized for deployment.

c. Plans for the augmentation of FMF units are developed, promulgated, and updated at least annually.
