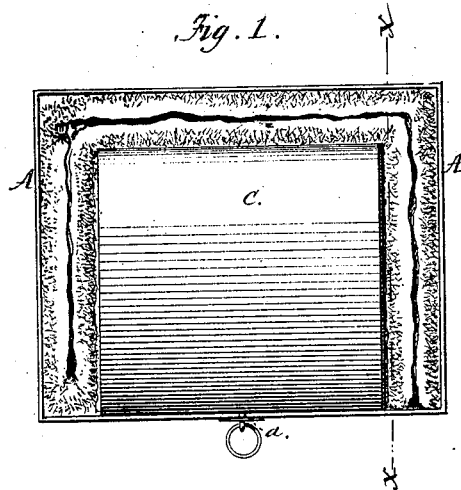
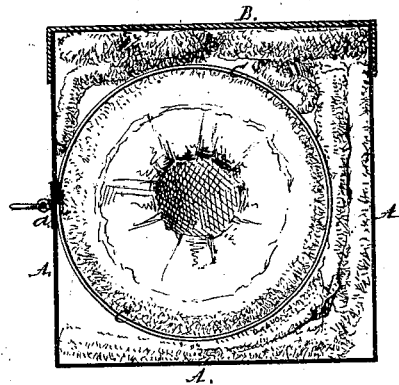

IMPROVEMENT IN FUR-SET BOXES.

The Schedule referred to in these Letters Patent and making part of the same.

To all whom it may concern:

Be it known that I, CLINTON W. FRAZER, of Brooklyn, in the county of Kings and State of New York, have invented a new and improved Fur-Set Box; and I do hereby declare that the following is a full, clear, and exact description thereof, which will enable others skilled in the art to make and use the same, reference being had to the accompanying drawing forming part of this specification.

Nature and Objects of my Invention.

My invention consists of a box inclosed by a box, of paper or other suitable material, arranged together, as hereafter shown, for the purpose of holding a full set of wearing apparel, known as ladies' furs, without waste of room.

The arrangement in my fur-set box forms a close, convenient, and compact storage and protection for the above-named wearing apparel, allowing just the amount of space required to contain a set of ladies' furs and no more.

Figure 1 is a plan of the fur-set box with cover removed.

Figure 2 is a vertical section on line *x x*.

A is a box, formed of paper or other suitable material, square or rectangular in form, having a cover, B, which fits closely over it to exclude dust or anything that would be likely to soil the contents.

In this square or rectangular box is secured, by means of a rivet, screw, or other suitable mechanical

device, *a*, at one side of the box A, the case C, which may be cylindrical or of any form suitable to the shape of the muff. The rivet *a* is intended to secure the case C to one side of the box A, loosely, so that it may stand vertically, horizontally, or at any inclination within a circle about the rivet. The case C may be closed at one end or not. The case C to be sufficiently deep to completely incase a muff. The box inclosing it should be sufficiently wide to admit a cape, when folded once, to lie snugly in the space shown in the drawing. There will then be space sufficient on the top of the muff-case to accommodate the third piece of fur or boa. The space under the case C is sufficient to accommodate the cape and support the muff-case in a horizontal position.

I am aware that fur-set boxes have been made and used with a case similar in form to the one in my box, but they have been invariably fixed or secured to the outer box vertically. The peculiar arrangement of my fur-set box utilizes space more completely than that of any other now in use.

What I claim as my invention, and in which I desire to be secured by Letters Patent, is—

The box A, combined with the case C and suspending-rivet or screw *a*, arranged as described, for the purpose set forth.
