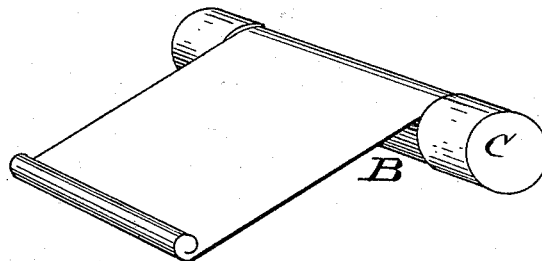

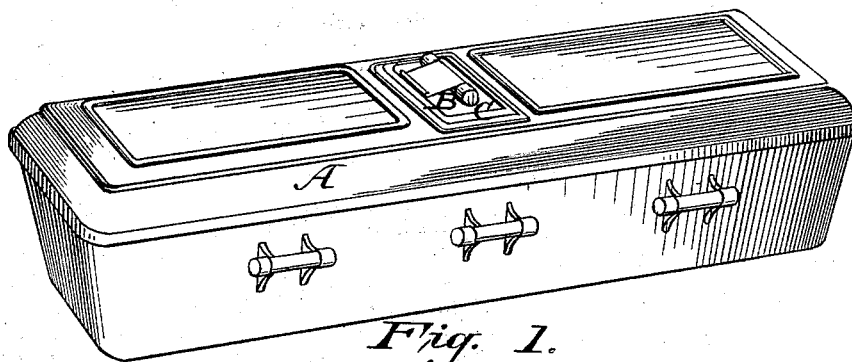

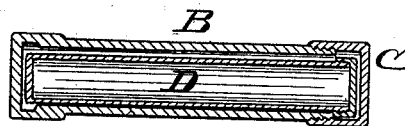

NAME-PLATE FOR BURIAL-CASKETS.

SPECIFICATION forming part of Letters Patent No. 422,084, dated February 25, 1890.

Application filed March 21, 1889. Serial No. 304,104. (No model.)

To all whom it may concern:

Be it known that I, GEORGE W. LEARMAN, a citizen of the United States, residing at Cleveland, in the county of Cuyahoga and State of Ohio, have invented certain new and useful Improvements in Name-Plates for Burial-Caskets, of which the following is a specification.

This invention relates to a name-plate for burial-caskets comprising a scroll which serves as a name-plate, and a hollow cylinder from which it appears to be partly unrolled, the cylinder being provided with a removable cap and the inner receptacle provided with a tight cap and adapted to serve as a depository for records, substantially as hereinafter described, and pointed out in the claims.

In the accompanying drawings, Figure 1 is a perspective view of a burial-casket having my improved name-plate attached. Fig. 2 is a detached and enlarged view of my new name-plate. Fig. 3 is a longitudinal section of the record-receptacle.

A represents a burial-casket, which may be of any of the well-known styles and finish.

B is a name-plate, consisting of a sheet of metal in suitable design representing a scroll attached to a cylinder from which it appears to be unrolled. One end of said cylinder is

tightly closed and the other is provided with a removable cap C.

D represents an inner receptacle, which may be of glass or any other durable material provided with a tight cap and adapted to serve as a safe depository for records or relics and capable of being removed for inspection.

Having described my invention, I claim—

1. The herein-described name-plate for burial-caskets, comprising the scroll which serves as the name-plate proper, and the hollow cylinder from which it appears to be unrolled, said cylinder being provided with a removable cap and adapted to serve as a depository for records, substantially as set forth.

2. The herein-described name-plate for burial-caskets, comprising a scroll which serves as the name-plate, and the hollow cylinder from which it appears to be unrolled, said cylinder being provided with a removable cap and the inner receptacle provided with a tight cap and adapted to serve as a depository for records, substantially as set forth.
