






SAMUEL A. STAHL AND BENJAMIN KLIPPER, OF KNOXVILLE, TENNESSEE.

## WATCH-CHAIN CHARM OR OTHER ARTICLE OF JEWELRY.

SPECIFICATION forming part of Letters Patent No. 491,382, dated February 7, 1893.

Application filed November 15, 1892. Serial No. 452,073. (No model.)

*To all whom it may concern:*

Be it known that we, SAMUEL A. STAHL and BENJAMIN KLIPPER, of Knoxville, in the county of Knox and State of Tennessee, have  
5 invented a new and useful Improvement in Watch-Chain Charms, Breastpins, or other Articles of Jewelry, of which the following is a full, clear, and exact description.

This invention consists in a watch-chain  
10 charm, or other ornament or article of jewelry, including breast-pins, shawl-pins &c., having, irrespective of their link, pin or hook attachment for fastening them in place, a globular form or construction designed to represent  
15 the earth, and having marked or delineated on it the shape of the land and oceans or waters on each hemisphere, and a microscope or microscopes inserted within holes in such globular body at certain places occupying  
20 different geographical positions notable in history or otherwise, said microscopes containing views illustrative of a particular event or events connected with said places, substantially as hereinafter described and claimed.

25 The event or events which the charm or jewelry article is here designed to commemorate, are the sailing of Columbus from the city of Palos in Spain on his voyage which resulted in the discovery of America, and  
30 the Columbian or World's Fair now about being held at Chicago in the United States of America in honor or commemoration of such discovery.

Reference is to be had to the accompanying  
35 drawings forming a part of this specification, in which similar letters of reference indicate corresponding parts in all the figures.

Figures 1 and 2 represent opposite exterior  
40 views of a globe-shaped charm or piece of jewelry, having delineated on it the land and water forming the eastern and western hemispheres of our globe the earth, with the invention applied; Fig. 3 is an irregular transverse  
45 section of said globe-shaped charm at the places indicated on it representing the city of Palos in Spain and Chicago in the United States of America, respectively; and Figs. 4 and 5 are face views of microscopic lenses  
50 with pictorial photographs on them illustrating respectively the sailing of Columbus and the Chicago or Columbian World's Fair.

In said drawings, A is the globe-shaped charm or piece of jewelry representing the earth, Fig. 1 representing the western hemisphere, and Fig. 2, the eastern hemisphere with their  
55 land and water demarcations. At the place marked Palos in Fig. 2, a hole *b* is made, in the one end of which is inserted a minute microscope *d* containing a photographic or other view *e*, Fig. 5, of the ships in which Columbus  
60 and his followers sailed on their exploring expedition which resulted in the discovery of America; and at the place marked Chicago in Fig. 1 is another hole *f* at the one end of which is inserted another microscope *d'* containing  
65 a view *e'*, Fig. 4, of the buildings of the Columbian or World's Fair now about being held in Chicago in commemoration of the discovery of America by Columbus, so that by looking first through the one microscope and then  
70 through the other, the two connected historical or prominent events are exhibited in their respective geographical positions. Such charm or piece of jewelry, which conveys  
75 amusement with instructions, may be made of metal or other material, either in one piece or, as shown by the dotted line in Fig. 3, in two pieces, and may have a loop, link or other plain or ornamental attachment for utilizing  
80 the article either as an appendage or fastening as desired and as hereinbefore referred to.

Having thus described our invention, we claim as new, and desire to secure by Letters Patent:—

As a new article of manufacture, the within  
85 described charm or piece of jewelry, of globular construction, representing the earth with its land and water divisions appearing thereon, and having holes made in or through it at fixed places of historical or national im-  
90 portance, in combination with a microscope or microscopes inserted therein at said places and containing views illustrative of the particular events which associate or give notoriety to said places, substantially as specified. 95
