

IMPROVEMENT IN BUTTON-STRAPS FOR SUSPENDERS.

Specification forming part of Letters Patent No. 180,942, dated August 8, 1876; application filed April 6, 1876.

To all whom it may concern:

Be it known that I, JAMES B. SHARP, of the city, county, and State of New York, have invented a new and Improved Suspender-Strap, which invention is fully set forth in the following specification, reference being had to the accompanying drawing, in which-

Figure 1 represents a perspective view of a suspender provided with my improved strap when applied to a cast-off buckle-connection. Fig. 2 is a detached view of my strap when applied to a permanent buckle-connection. Fig. 3 is a plan of my improved strap provided with a slot in the middle. Fig. 4 is a similar view of my strap when provided with a hole in the middle.

Similar letters indicate corresponding parts. This invention consists in a button-strap for suspenders, provided with an elongated slot at or near the middle of its length, in combination with a permanent or cast-off buckleconnection, so that said button strap can be attached to the buckle without requiring any extra labor.

In the drawing, the letter A designates my button strap, which is provided at or near the middle of its length with an elongated slot, a, as shown in Figs. 1, 2, and 3.

In order to connect my button-strap with a suspender, I use a buckle-connection provided with a tongue or button, b, and by passing the elongated slot a over this tongue or button, the operation of attaching the buttonstrap to the suspender is accomplished. The buckle-connection may either be permanent, as shown in Fig. 2, or it may be constructed on the principle of a snap hook, or in any other suitable manner allowing of detaching or "casting-off" said connection from the

buckle, as shown in Fig. 1.

My button strap may either be made of woven fabric or of leather. When the same is woven, the elongated slot a is preferably produced during the operation of weaving, but when it is made of leather the elongated slot a is punched out, and, if desired, such elongated slot may be strengthened by a suitable eyelet.

The button-strap being provided with an elongated slot, a, it can slide on the buckleconnection, and it is free to accommodate itself to the motions of the body of the person

wearing the suspender.

I am aware that a suspender-strap provided with a button-hole at each end and a circular hole at its center for engagement with the tongue of a buckle is not new, and such I do not claim; but

What I claim as new, and desire to secure

by Letters Patent, is-

A button-strap for suspenders, provided at or near the middle of its length with the elongated slot a, for engagement with a permanent or cast off buckle connection, substantially as described and shown, and for the purpose set forth.
