

## IMPROVEMENT IN COMBINED SOAP AND SHAVING BOX.

Specification forming part of Letters Patent No. 192,997, dated July 10, 1877; application filed May 21, 1877.

To all whom it may concern:

Be it known that I, ANTON HOPFEN, of New York, in the county of New York and State of New York, have invented certain new and useful Improvements in Combined Soap and Shaving Box; and I do hereby declare that the following is a full, clear, and exact description thereof, reference being had to the accompanying drawings, and to the letters of reference marked thereon, which form part of this specification.

The nature of my invention consists in the construction and arrangement of a soap and shaving box, as will be hereinafter more fully

set forth.

In order to enable others skilled in the art to which my invention appertains to make and use the same, I will now proceed to describe its construction and operation, referring to the annexed drawing, in which-

Figure 1 is a perspective view, Fig. 2 is a plan view, and Fig. 3 is a cross-section, of my

combined soap and shaving box.

My combined soap and shaving box is composed of three main parts—the body A, which is simply a rim of any suitable form and size, a lid, B, hinged to said body, and a bottom, C, provided with an upwardly-extending rim,

D, that fits within the body A.

The body A and the rim D are made slightly tapering, so that the box can be extended by putting out the bottom, but said parts cannot easily be separated. The bottom C extends beyond the rim D sufficiently to form a shoulder, a, which prevents said bottom from being

pushed inward into the body A.

The lid B and bottom C are preferably made convex, as shown on their outer faces, and both provided with numerous perforations, b, for the escape of moisture. On the under side of the bottom C is formed a foot or pedestal, E, projecting sufficiently far below the bottom so that when the box is put down there will be room for a free circulation of air into and through the box.

The box, thus constructed, may be made of metal, rubber, wood, or any other suitable material.

In the bottom of the box is a rack, G, and on the inside of the lid are strips or cross-bars H H, to prevent the soap from coming close to the bottom and lid of the box, which would close the perforations in them, and, therefore, destroy one of the objects of the inventionto permit a free circulation of air through the box around the soap.

This box is specially intended for travelers, and can be used as a shaving-box by extending the box and placing a pad, I, of rubber or other suitable material, in the bottom, to close

the perforations therein.

This pad I may be carried, ordinarily, in the lid B, between it and the strips H.

Having thus fully described my invention, what I claim as new, and desire to secure by Letters Patent, is-

1. A combined soap and shaving box, composed of the body A, perforated lid B, and perforated bottom C with sliding rim D, substantially as herein set forth.

2. The centrally-located foot or pedestal E, formed on the under side of the perforated bottom C, substantially as and for the purposes herein set forth.

3. The rack G and strips H, in combination with the box having perforated lid and bottom, for the purposes herein set forth.

4. The pad I, in combination with the perforated bottom C of the combined soap and shaving box, for the purposes herein set forth.
