

IMPROVEMENT IN UMBRELLA-HOLDERS.

Specification forming part of Letters Patent No. 202,140, dated April 9, 1878; application filed January 3, 1878.

To all whom it may concern:

Be it known that I, John H. Bowers, of Cowan, in the county of Franklin and State of Tennessee, have invented a new and Improved Umbrella-Holder, of which the following is a specification:

In the accompanying drawings, forming part hereof, Figure 1 represents my improved umbrella-holder in use, and Fig. 2 is a detail view, showing the arrangement of the straps

and buckles.

Similar letters of reference indicate corre-

sponding parts.

The object of my invention is to provide an umbrella-holder for the use of farmers and others, which will support the umbrella and

permit of the free use of both hands.

In the drawings, A is a belt that surrounds the waist, and is provided with buckles a for drawing it together, and has attached to it a cup or socket, b, for receiving the lower end of the umbrella-staff. To the left-hand side of the belt, at the front and back, buckles c are attached for receiving the ends of a strap, d, that runs over the shoulder. To the back of this strap a strap, e, is secured, which runs around the body parallel to the strap A, and is received by the buckle f, secured to the front of the strap d. A strap, g, is attached to the back of the strap d, and runs around the body under the right arm, and is buckled to the strap h, that is secured to the strap d at or near

the point of attachment of the buckle f. The lower end of the staff of the umbrella is placed in the socket b, and the strap e is wound once around the umbrella-staff before being buckled.

This improved device holds an umbrella securely, and admits of a free use of both hands, and enables a person to work under a hot sun or during a rain without giving the umbrella any special care or attention.

I am aware that it is not new to support an umbrella from the person by two shoulder-straps, a belt, and a chest-strap, and such I do not claim. In this case, when these shoulder-straps are tightened, the belt cannot be raised or lowered without interfering with the chest-strap, while the fastening of the shoulder-straps to the chest-strap causes a strain across the chest and a heat that are very objectionable. My use of a single shoulder-strap connected with the belt avoids these objections.

What I claim as new is-

An umbrella-holder having a single shoulder-strap fastened to the belt and inclosed by the chest-strap, as and for the purpose specified.
